## **Privacy Policy**

### 1. Information We Collect

We do not knowingly collect or request information from children under 18.

#### 2. How We Use Your Information

We use your submitted information for the following purposes:

- To evaluate eligibility for residential care services
- To follow up on applications and referrals
- To communicate with the applicant or referrer regarding next steps
- To maintain safety, security, and compliance
- To improve our website and services

## 3. How We Store and Protect Information

All information submitted through our forms is stored securely via encrypted servers provided by our website host. We restrict access to your data and only authorized staff may view or process submitted information. Although no method of transmission over the Internet is 100% secure, we use commercially acceptable means to protect your personal information.

#### 4. Disclosure of Information

We do not sell, trade, or rent your personal information to others. We may disclose personal data if required by law, legal subpoena, or to protect the rights, safety, or property of Healing Haven Residential Care, our staff, or others.

#### 5. Your Rights

As a website visitor and potential applicant, you have the right to:

- Know what personal data we collect and why
- Request access to your submitted information
- Request correction or deletion of inaccurate data
- Withdraw your consent (where applicable)
