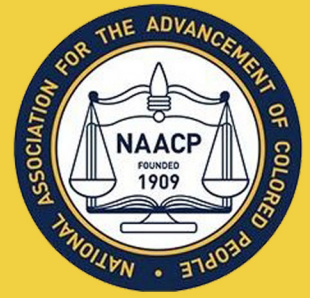

As an all-volunteer civil rights organization, we depend on the continuing support of members like you. Hence this appeal that you renew your membership — or start a new membership — today.

What Accomplishments?

Here's a very partial list.

- In Feb. 2022, we filed an ethics complaint against Lebanon County District Attorney Pier Hess Graf with the Disciplinary Board of the PA Supreme Court. Our complaint was spotlighted in local and regional media and mentioned in the *New York Times*. In July 2023, the Disciplinary Board reprimanded D.A. Graf for her unethical and unprofessional behavior.
- We established three active standing committees that have begun to have a positive impact in the local community:
 - Public Safety & Criminal Justice Committee
 - Education Committee
 - Legal Redress Committee
- We are currently creating a Housing Committee to address the severe lack of affordable housing in Lebanon County.
- We developed and are following a comprehensive and ambitious strategic plan (see the About Us page of our website).

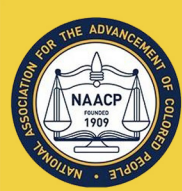

PUBLIC SAFETY & CRIMINAL JUSTICE



We have:

- Become active members of the Lebanon County Criminal Justice Advisory Board (CJAB)
- Regularly attended the meetings of the Lebanon County Prison Board
- Established four active Working Groups:
 - (1) Lebanon County Criminal Justice Advisory Board
 - (2) Prison Board & Lebanon Co. Correctional Facility
 - (3) Lebanon Police Department & Mayor's Office
 - (4) Other Lebanon Co. Municipal Police Departments
- Established positive working relationships with key players in the Lebanon County criminal justice community

EDUCATION



Our Education Committee has undertaken a wide range of initiatives:

- Cultivating positive working relationships with:
 - K-12 public school district superintendants & school boards
 - Representatives of higher education
 - The general public
- Establishing & granting an annual \$1,000 Diversity Scholarship for a meritorious graduating high school senior of color
- Organizing an annual MLK Discovery Day community event
- Developing a large & growing list of antiracist educational resources
- Creating & disseminating educational brochures featuring antiracist literature for children, teens & adults

LEGAL REDRESS COMMITTEE



Over the past 4 years, our Legal Redress Committee has received and responded to dozens of complaints of discrimination from members of our local community. This is one of the most challenging aspects of our civil rights work here in Lebanon County. We are not lawyers and we cannot offer legal counsel. What we can do, and do, is listen to complainants, offer our moral support, and work to identify the legal and other resources that are available to those in need. We have helped to direct them to the legal resources available to them and developed a “Complaints of Discrimination” form on our website.

Special Events

- We organized & hosted a Juneteenth / Freedom Day celebrations at public parks each year from 2021-2024, and are planning another for Saturday, June 21, 2025
- We held our 2nd, 3rd & 4th Annual Frederick Douglass Community Orations at Lebanon Valley College and are planning our 5th on July 5, 2025
- We helped to develop a Lebanon County African American Heritage Trail
- We hosted hugely successful Black History Month events each February since 2021 and will do so again in 2025, including another big Freedom Fund Gala on Sat. Feb. 22
- We engaged in lots of outreach at community events
