1. Call to Order. 4. Treasurer's Report.

5. Policies & Procedure.

6. Grants.

- a. The District was awarded a FEMA Grant for the washer and dryer and also for the cascade air system.
- b. Commissioner Freilich expressed his appreciation for all the work Commissioner Lomonaco has put forth in securing the Grants the District has received. The other Commissioners expressed their gratitude as well.
- c. Commissioner Prentice will work with the Senator's office to draft a press release regarding the FEMA Grant.

On a motion by Commissioner Bohl, which was seconded by Commissioner Prentice, the Board moved to approve spending \$3916.43, which is the required matching funds for the FEMA Grant. The vote was, Yays: 5 – Commissioner Brower, Commissioner Lomonaco, Commissioner Bohl, Commissioner Prentice, and Commissioner Freilich, Nays: 0, Abstain: 0. All present in favor, Motion Carried.

7. Community Relations.

a. The Putnam County Health Dept is requesting to use Station #2 for Flu shots on 10/7/20 from 2 to 6 pm with restrictions for Covid. Commissioner Bohl will speak to the Company Board for their approval as well.

On a motion by Commissioner Brower, which was seconded by Commissioner Lomonaco, the Board moved to approve use of Station #2 by The Putnam County Health Dept. The vote was, Yays: 5 – Commissioner Brower, Commissioner Lomonaco, Commissioner Bohl, Commissioner Prentice, and Commissioner Freilich, Nays: 0, Abstain: 0. All present in favor, Motion Carried.

b. The Lyons Club is looking to park a small trailer in the back of Station #1. Commissioner Brower will speak with them and ensure they have the proper insurance for the trailer.

On a motion by Commissioner Brower, which was seconded by Commissioner Lomonaco, the Board moved to allow The Lyons Club to park their trailer at Station #1 . The vote was, Yays: 5 – Commissioner Brower, Commissioner Lomonaco, Commissioner Bohl, Commissioner Prentice, and Commissioner Freilich, Nays: 0, Abstain: 0. All present in favor, Motion Carried.

8. Budget Workshop.
