SECTION 3: TERMS & CONDITIONS

By signing below and submitting this registration, the vendor agrees to the following:

- **Setup/Teardown:** Setup hours are Friday, Feb 26th from 2:00 PM to 9:00 PM, and Saturday, Feb 27th from 7:00 AM to 8:45 AM. Vendors must not break down their booths prior to the show closing at 3:00 PM on Sunday. Disregarding this or other rules may result in not being invited back.
- **Staffing:** Vendors are responsible for manning their tables during all public show hours (Saturday 9:00 AM - 5:00 PM, Sunday 9:00 AM - 3:00 PM).

- **Firearm Safety & Handling:** All firearms on display must be securely zip-tied or cable-locked to prevent the action from closing or firing. Any ammunition for sale must remain in sealed boxes or original packaging.
- **Black Powder:** No black powder or other explosives of this type are allowed in the building.
- **Legal Compliance:** Vendors are solely responsible for ensuring all sales, trades, and transfers conducted at their tables comply with all applicable local, state, and federal laws. Federally Licensed Firearms (FFL) dealers must prominently display their license at their booth.
- **Wisconsin Tax Reporting:** To comply with state law for temporary events, vendors must provide their Wisconsin Seller's Permit Number or declare their tax-exempt status on this form so the event organizers can properly submit Wisconsin DOR Form S-240.
- **Merchandise Requirements:** To maintain the quality and theme of the Sportsman's Equipment Resale Event, a minimum of 80% of items displayed must be hunting, outdoor, firearm, or sporting-related equipment. General flea markets or household rummage goods are strictly prohibited.
- **Liability & Security:** The Fox Valley Muzzle Loaders and Sunnyview Expo Center are not responsible for lost, stolen, or damaged merchandise, or for accidents occurring in vendor booths. Vendors are solely responsible for properly securing their own valuable merchandise.
