# 1. New pathway to permanent residency for over 90,000 essential temporary workers and international graduates

On April 14, 2021, the Honourable Marco E. L. Mendicino, Minister of Immigration, Refugees and Citizenship, announced an innovative pathway to permanent residence for over 90,000 essential workers and international graduates who are actively contributing to Canada's economy. ## **Testing: arrival and Day 10**

**Q.** I received a positive test result from my on arrival test. Do I need to complete the day 10 Switch Health test?

**A.** Travellers who test positive on the Day 1 test will not be required to test again but must remain in isolation in a suitable location for a period of 14 days from the date of the collection of their first sample.

In addition, if you receive a positive result, you no longer have to report your daily symptom status to the Public Health Agency of Canada; however, it is very important to be continuously monitoring your health during your isolation. If symptoms develop or get worse, call 911 or the public health authority in the province or territory where you are located and follow their instructions.

## 4. COVID-19 Vaccination and Rapid Testing occurring in the regions

The attached COVID-19 Vaccination and Rapid Testing document summarizes information on current COVID-19 vaccination roll out plans and rapid testing initiatives occurring in all regions. **All updates are in blue for easy reference.**
