Chuck DeWitt
Co-Founder

A former deputy sheriff who studied criminology at Oxford and Cambridge universities, the career of Chuck DeWitt has spanned four decades of public service. A graduate of Stanford University in California, Mr. DeWitt rose from deputy sheriff to Director of the Justice Division for Santa Clara County. Mr. DeWitt left his post in Silicon Valley to become a Fellow at the U.S. Department of Justice in 1984, where he was responsible for corrections and law enforcement programs. He was assigned to the White House in 1989 to investigate terrorist threats and review border security. Mr. DeWitt was then nominated by the President and confirmed by the U.S. Senate to become Director of the National Institute of Justice. Mr. DeWitt developed and authorized many policy and technology projects still underway at the U.S. Department of Justice, ranging from community policing to DNA evidence systems. He approved hundreds of grants to law enforcement agencies to demonstrate innovations in policing that are operational today. Programs to strengthen the nation's justice system included joint efforts with the FBI, Secret Service and and National Laboratories (through interagency agreements) to to foster new technologies, communications, and information systems.

Scott Green's 40-year career was likewise rooted in public service, but it was his work on the football field as an NFL official (eventually spanning 20 years and three Super Bowls) that led him off Capitol Hill to create Lafayette Group. Mr. Green's public safety career began as a probation officer during which time he received a Master's Degree in Criminal Justice Administration from Arizona State University. He went on to serve in the San Diego, California, court system, before coming to Washington, D.C., to serve over a decade as a staff assistant to the U.S. Senate Judiciary Committee for then-Senator Joseph Biden. His primary duties with the Senate Judiciary Committee involved issues and legislation impacting public safety services.

During his tenure, Mr. Green was instrumental in writing legislation that focused attention and resources on improvements in public safety technology and communications.

Election Security

Overview

On January 6, 2017, the U.S. Department of Homeland Security (DHS) designated elections as critical infrastructure. Although individual state and local jurisdictions conduct elections, protecting election infrastructure is a national responsibility shared between federal, state, and local governments and their private sector partners. In addition to being a whole-of-government and cross-sector responsibility, election security involves multiple aspects of homeland security. These include cybersecurity, physical security, supply chain security, and emergency communications—all areas in which LGI possesses significant expertise.

The dynamic combination of subject-matter experts, management consultants, design specialists, and researchers has enabled LGI to become an integral partner in assisting federal clients with their election security efforts. LGI's contribution to the Cybersecurity and Infrastructure Security Agency's (CISA) election security mission began with stakeholder engagement and outreach, specifically to state and local election authorities. We have broadened CISA's engagement and outreach efforts to include election industry partners and political campaigns. LGI's contribution is also expanding into additional election security priorities for CISA, including strategic planning and training and exercises.

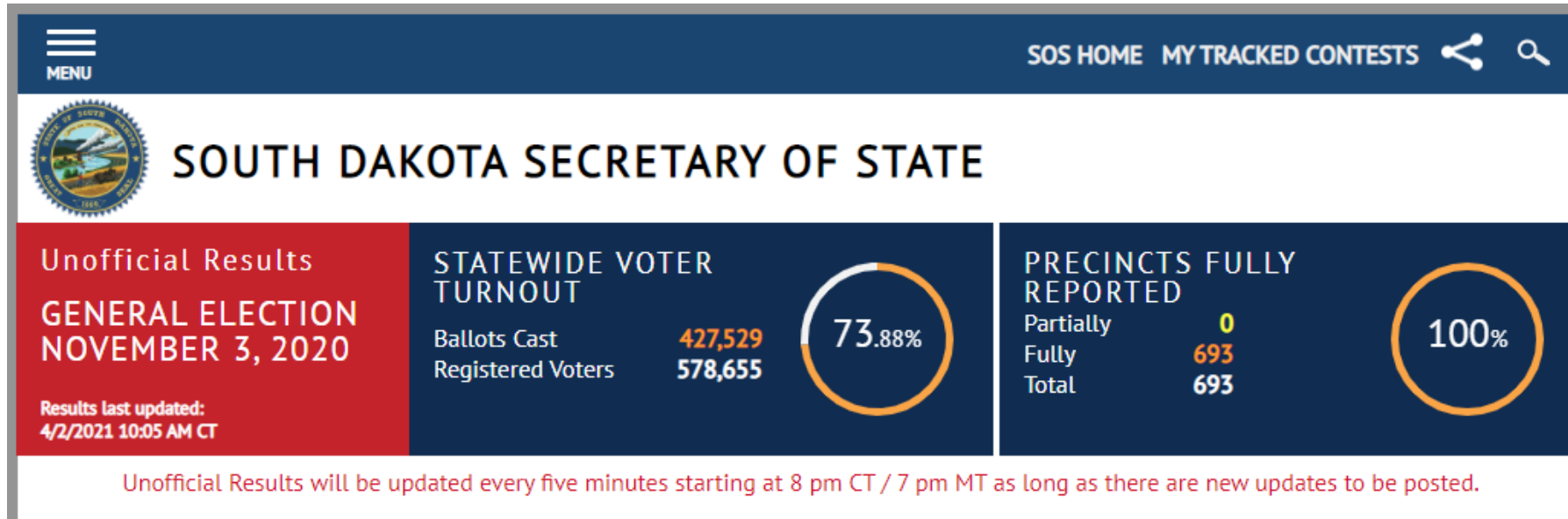

Heritage Foundation

- 1) Voter ID – SD allows for affidavit to be exception to photo ID requirement.
 - 2) Voter Database – Is not currently run against Social Security Admin Death Records, State welfare, public assistance agencies, county tax records nor do they check to see how many individuals live at an address.
 - 3) Absentee Ballots – SD does not require notarized or witnessed. SD does not investigate validity of an absentee ballot when the post office returns it as undeliverable by the post office.
 - 4) Ballot Harvesting – SD allows third party strangers to pick up and deliver a voter's absentee ballot.
 - 5) Voter Assistance – SD allows anyone to assist another person to vote, without ID or reason.
 - 6) Private Funding of Officials and Agencies – SD allows private money to fund election officials and agencies...Google, Facebook, and others played a role.
- * Heritage Foundation misunderstood, that some counties did allow drop boxes.

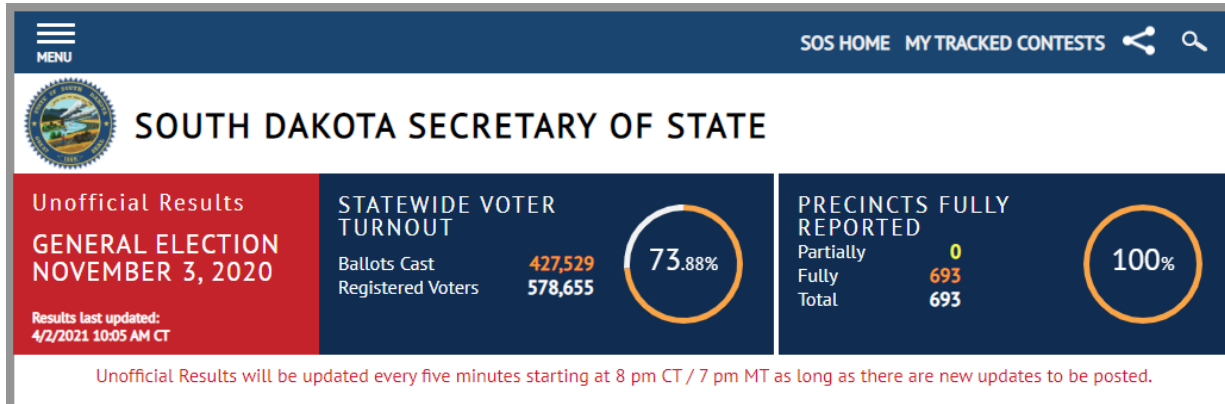
SD SOS Web Site on 4/2/2021 Shows 427,529 Ballots Cast in the state

SD SOS Data from 12/29/2021 shows 427,074 total votes – **455 votes under.**

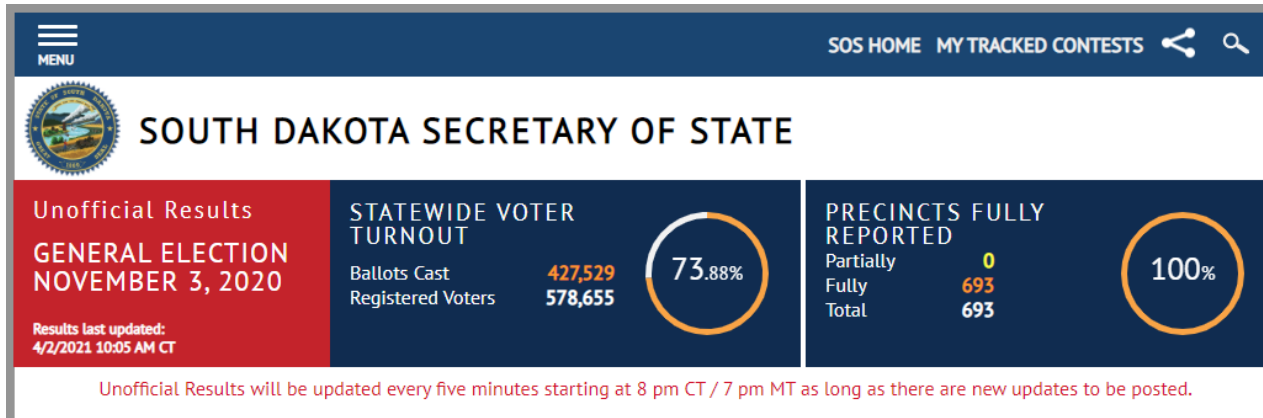
Interesting Tidbits



When we looked at the 9/22/2021 data set we found:

- 163 Voters Voted on 11/3/2020, were Registered after the election.
- 552 voters registered 11/3/2020 and 49 voted in 11/3/2020 election
- 260 voters that voted on 11/3/2020 registered between 10/20/2020-11/3/2020 = not legal. Last legal date to register to vote for the 11/3/2020 election was 10/19/2020. Registrations 10/20/2020 and beyond are late per SDCL 12-4-5.
- 11 voters voted TWICE.
- 256 Voters with original registration date 100 years ago or more. 227 them are active status. This makes them 120 years old or older.

The Magic is Amazing



When we looked at the 12/29/2021 data set we found:

146 new records from 9/22/2021 with voter history for 11/3/2020 not recorded previously.

601 Voter Records removed since 9/22/2021 database.

36 New Voters with Original Registration date 09.22.21 thru 12.23.21 VOTED 11/3/2020!

18 Records are completely blank, with active votes on 11/03/2020.

STRANGER THINGS in SD

SDCL 12-1-4 states:

*For the purposes of this title (Title 12), the term, residence, means the place in which a person has **fixed his or her habitation** and to which the person, whenever absent, **intends to return**.*

A person who has left home and gone into another state or territory or county of this state for a temporary purpose only has not changed his or her residence.

A person is considered to have gained a residence in any county or municipality of this state in which the person actually lives, if the person has no present intention of leaving.

If a person moves to another state, or to any of the other territories, with the intention of making it his or her permanent home, the person thereby loses residence in this state.

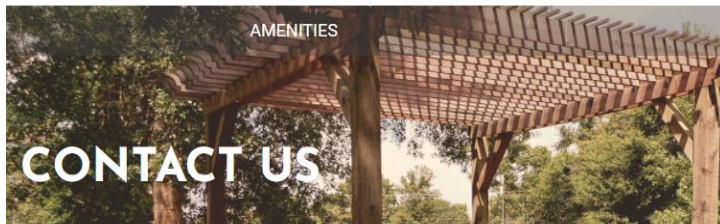

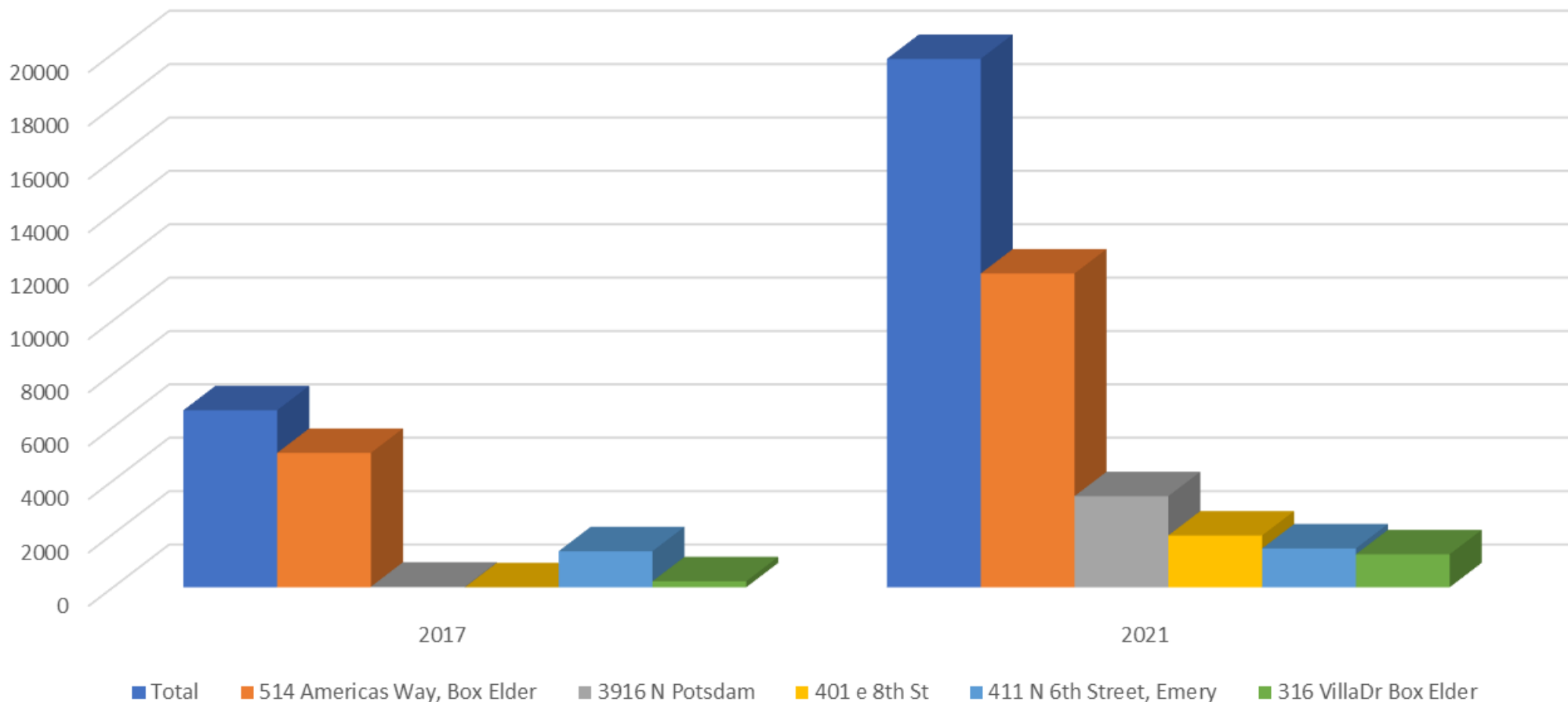

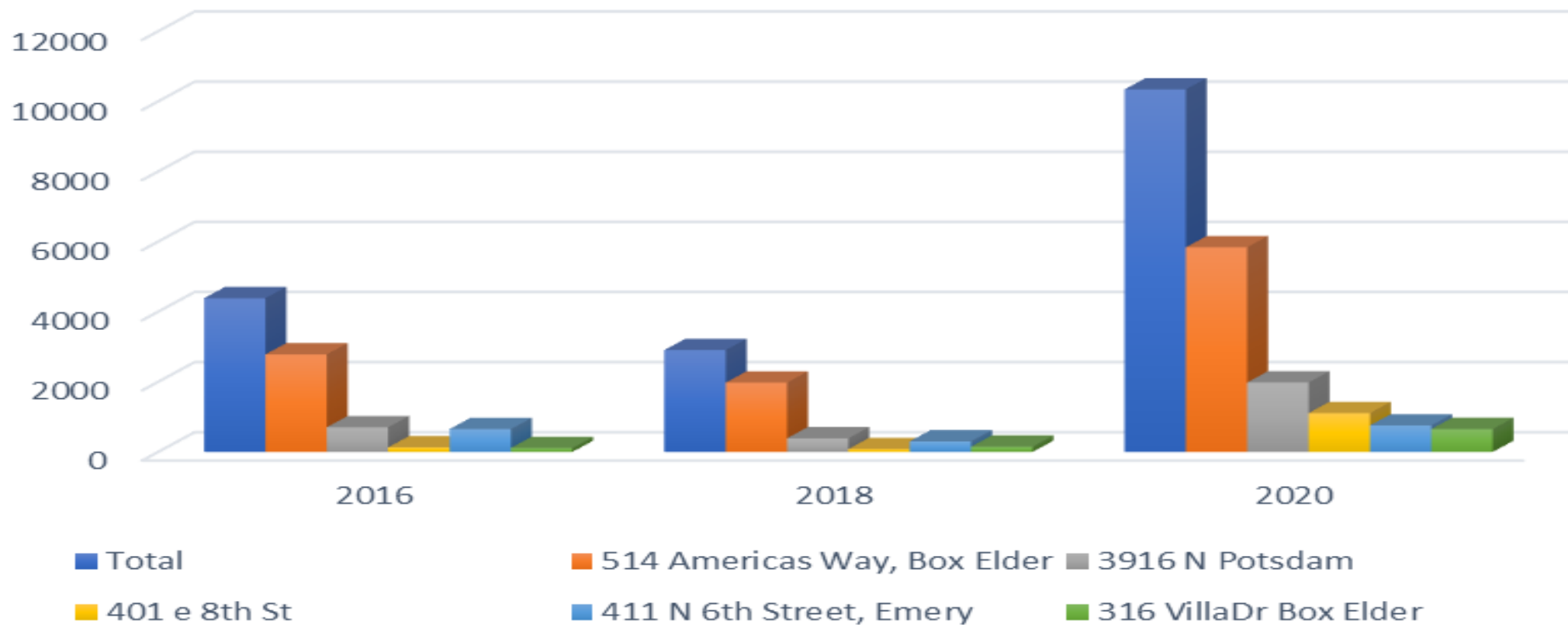
Increase in Mail-Forwarding Registered Voters (2017-2021)

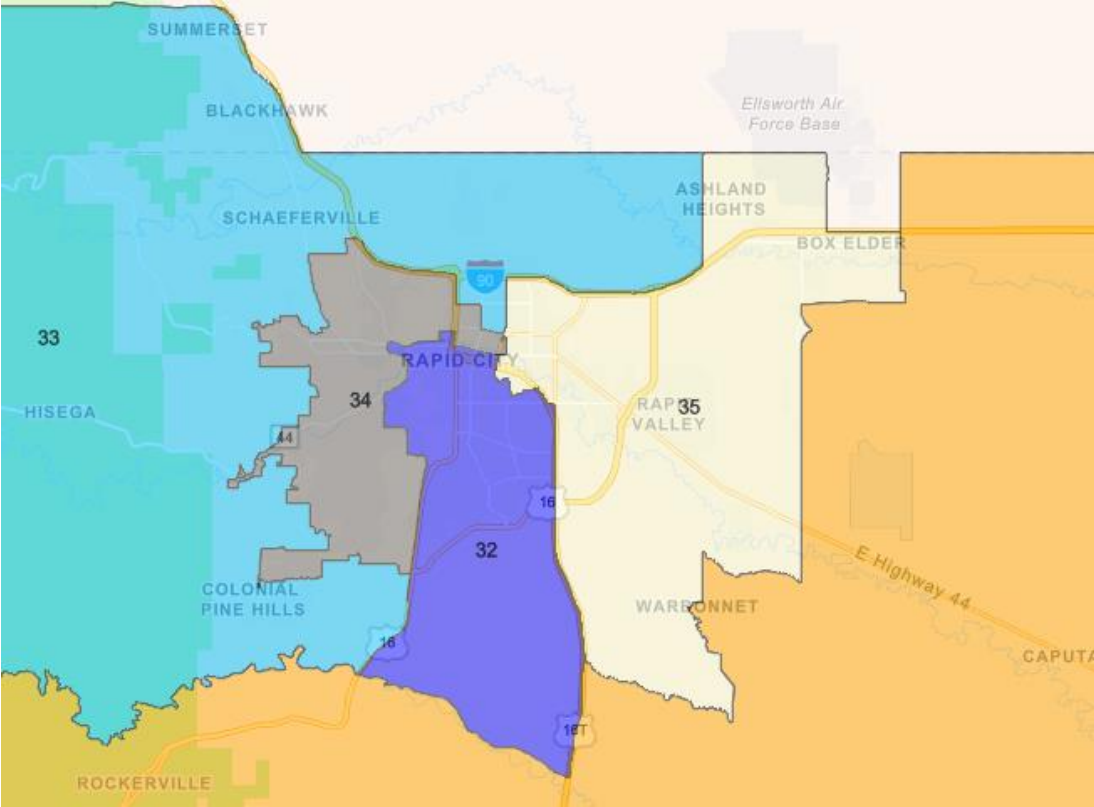

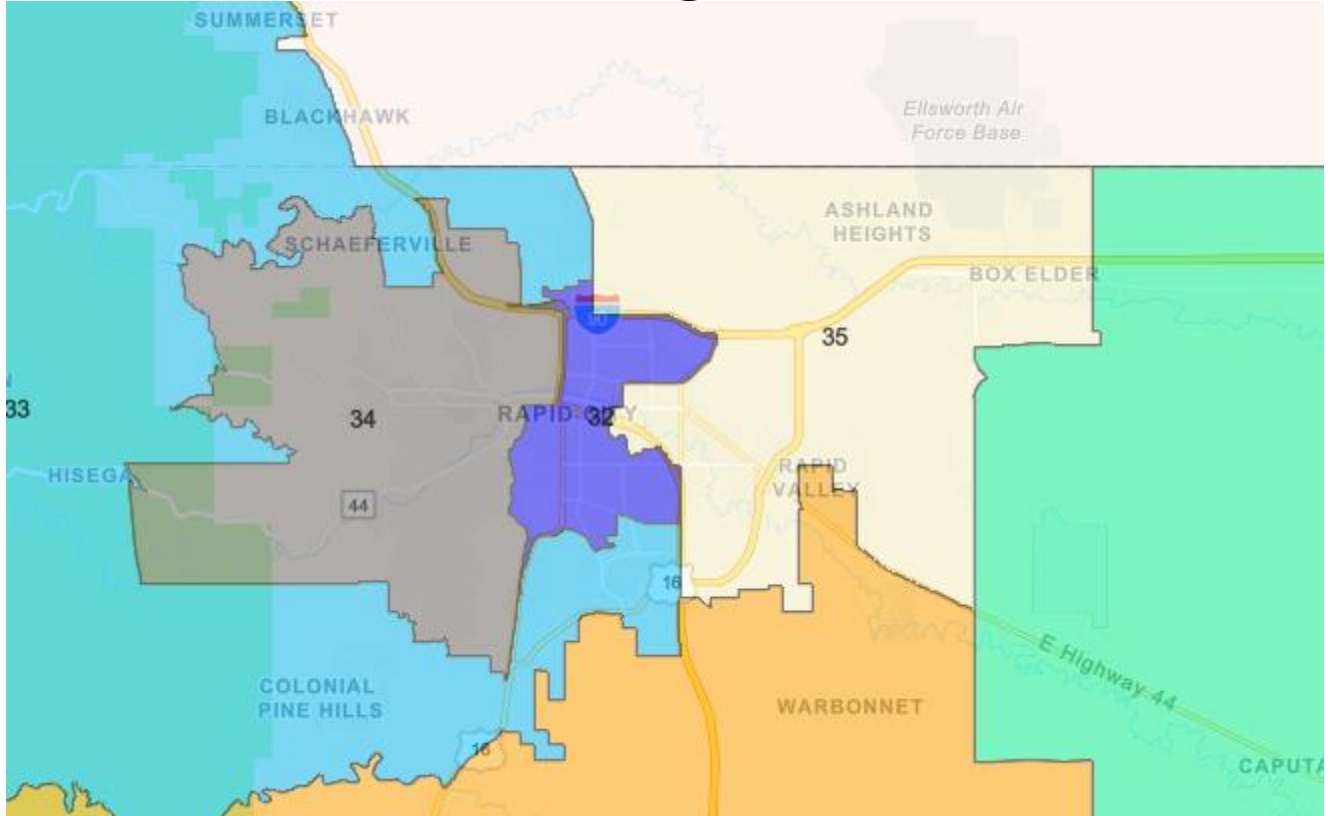

What is PCI Compliance?

- PCI stands for the Payment Card Industry. In 2006, major payment card brands Visa, MasterCard, American Express, Discover Financial Services, and JCB International established the Payment Card Industry Data Security Standard (PCI DSS). The PCI DSS helps merchants prevent consumer payment card data theft.
- Compliance with the PCI DSS or “PCI compliance,” is required for all businesses that process, store, or transmit payment card data. Merchants must complete a PCI DSS compliance form annually. Becoming PCI compliant helps prevent data breaches.

ES&S Voting Systems 6.1.0.0 State Certification. I have viewed both October 21-23, 2019 and July 26-28, 2021 certifications in Pierre, South Dakota.

ES&S State Certification Manager Mark Manganaro along with Secretary of State Steve Barnett, State Board of Elections Members, and other officials were present.

Mark Mannganaro demonstrated machines, and software that would need to be purchased to view the Vote Cast Record.

“We are looking at having a more in-depth demonstration on this process in March 2020 from another ES&S representative. **Further research on post-election audits will need to be conducted prior to any legislation drafted for future legislative sessions.**” - Steve Barnett Oct 30, 2019

ExpressVote Universal Voting System, v. 4.0.0.0

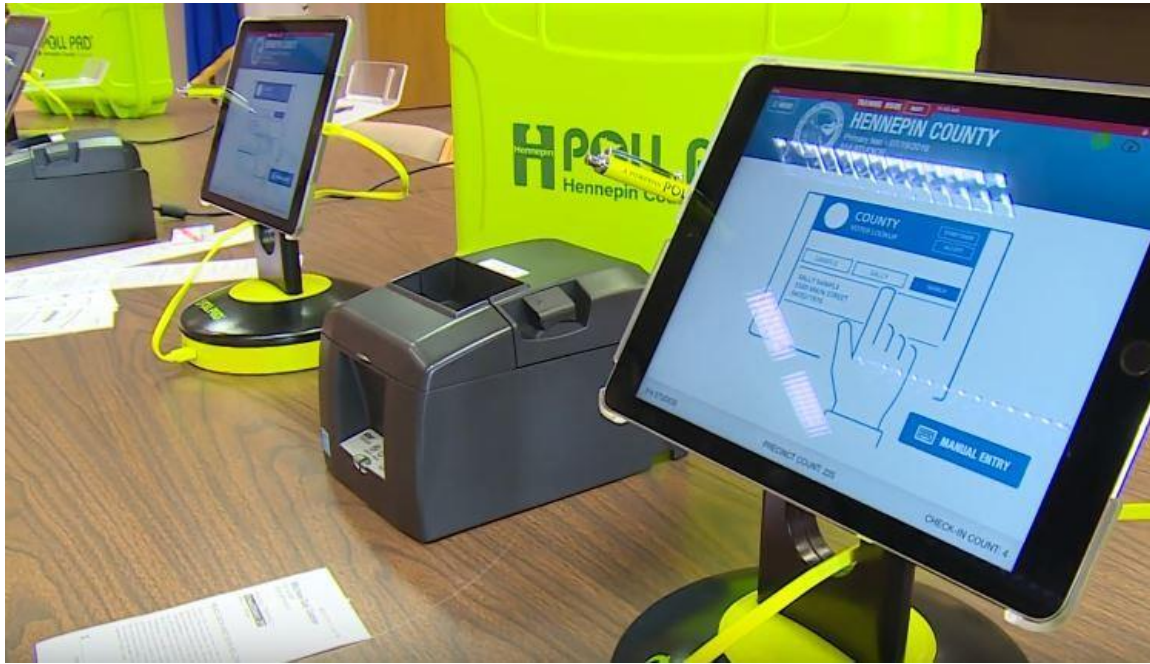
The ExpressVote is a universal voting device designed for all voters, with a printed voter-verifiable paper record. This system combines paper-based voting with touch screen technology. The ExpressVote includes a mandatory vote summary screen that requires voters to confirm or revise selections prior to printing the summary of ballot selections using the internal thermal printer.

What is an Electronic Poll Pad?



- 1) Direct Connection to SOS.
- 2) Live data over the internet.
- 3) Very Expensive.
- 4) Same Day Registration?

Poll Pads

- ❑ Electronic poll books are connected to the internet. (also ES&S)
- ❑ Voter rolls can be monitored live during an election leaving room for bad actors to check in voters and cast votes for them, and allows vote harvesting from certain demographics.
- ❑ E-Poll Books are NOT a certified piece of voting equipment, they don't undergo federal testing and there is no uniform standards governing their design.
- ❑ E-Poll Books allow for vote centers or super-precincts, which diminish local oversight, provide unlimited amounts of ballots for an undetermined amount of voters, do not provide for checking of photo ID.
- ❑ The cost for Lincoln County was \$77,000 for I-pads only, no tech support or security included. This proposal has been set aside by the auditor due to public pressure and questions from the commissioners.
- ❑ Pennington County has had check-in problems and poll book crashes in prior elections.

We strongly recommend that all Electronic Poll Books be banned from the state.

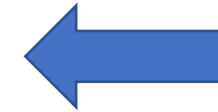
- (1) The jurisdiction may use vote centers that allow voters in the jurisdiction to vote at any of the vote centers in lieu of establishing precincts and wards for the election;
- (2) Any person who is registered to vote and living in the jurisdiction may be appointed as a polling place superintendent or deputy to any of the vote centers;
- (3) Secure, encrypted electronic pollbooks shall be used in lieu of paper registration books;
- (4) The entire jurisdiction is designated as one voting precinct for the election; and
- (5) Any jurisdiction that uses vote centers shall provide a printed paper voter registration list and a printed and bound paper pollbook to each vote center prior to the opening of the polls.

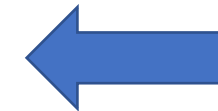

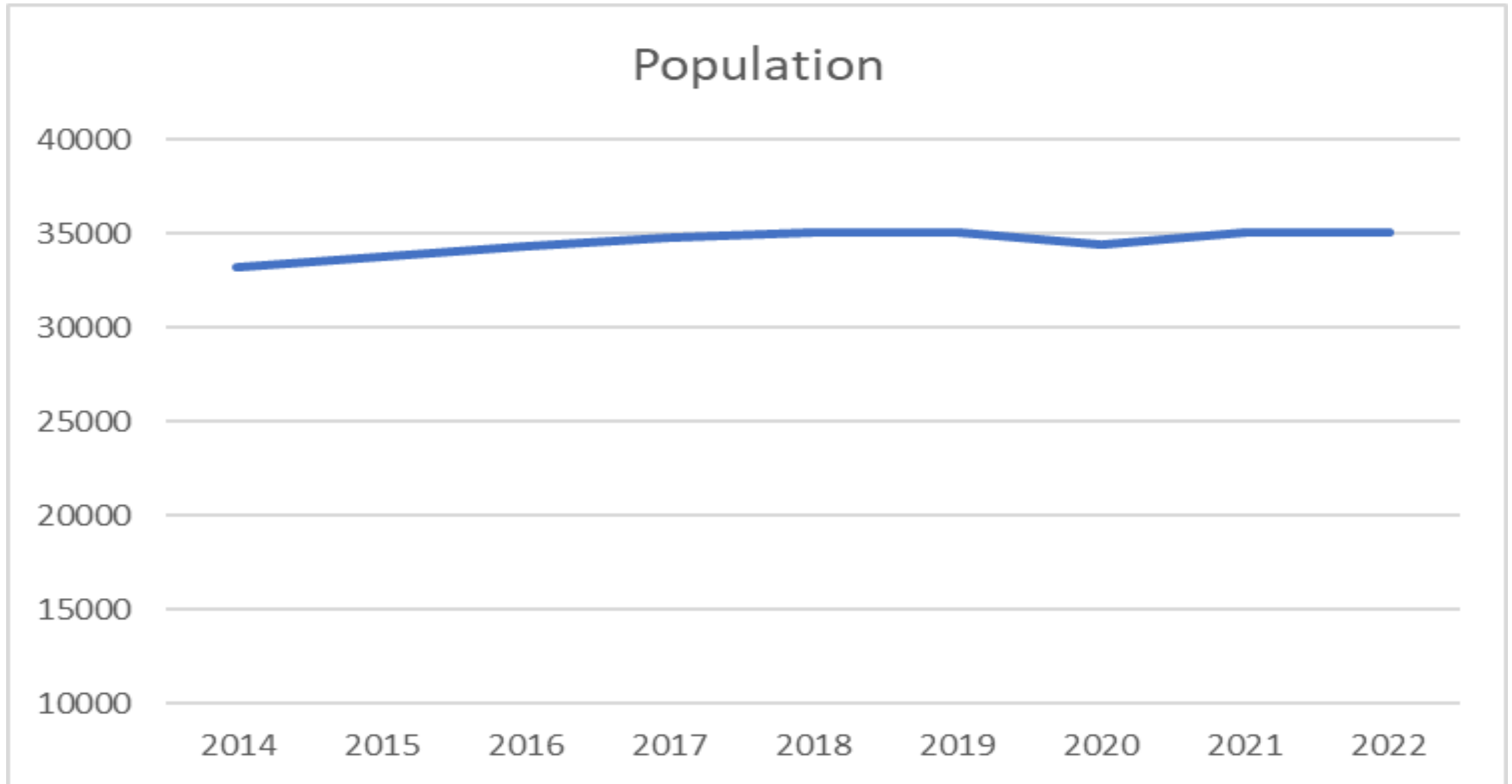

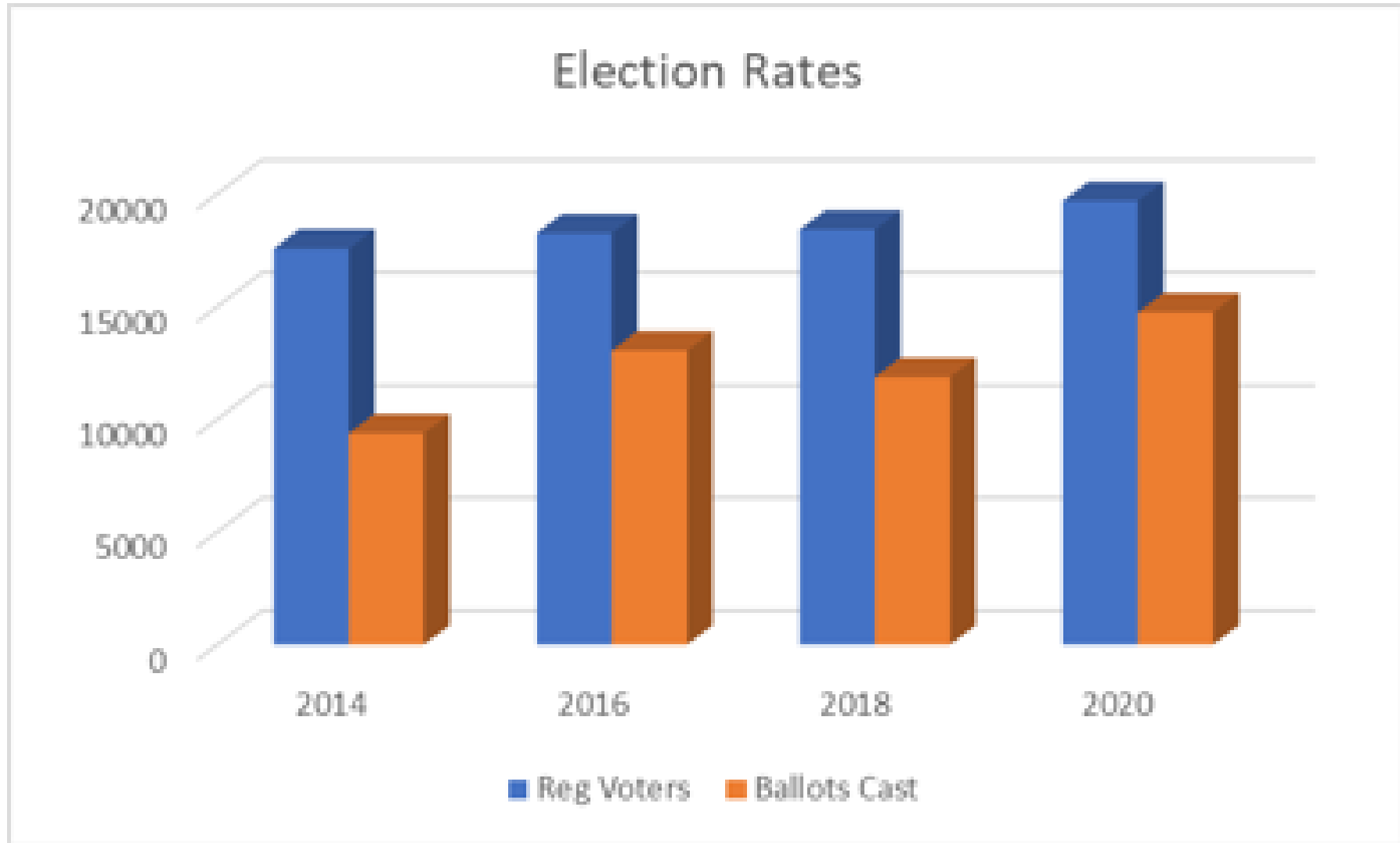

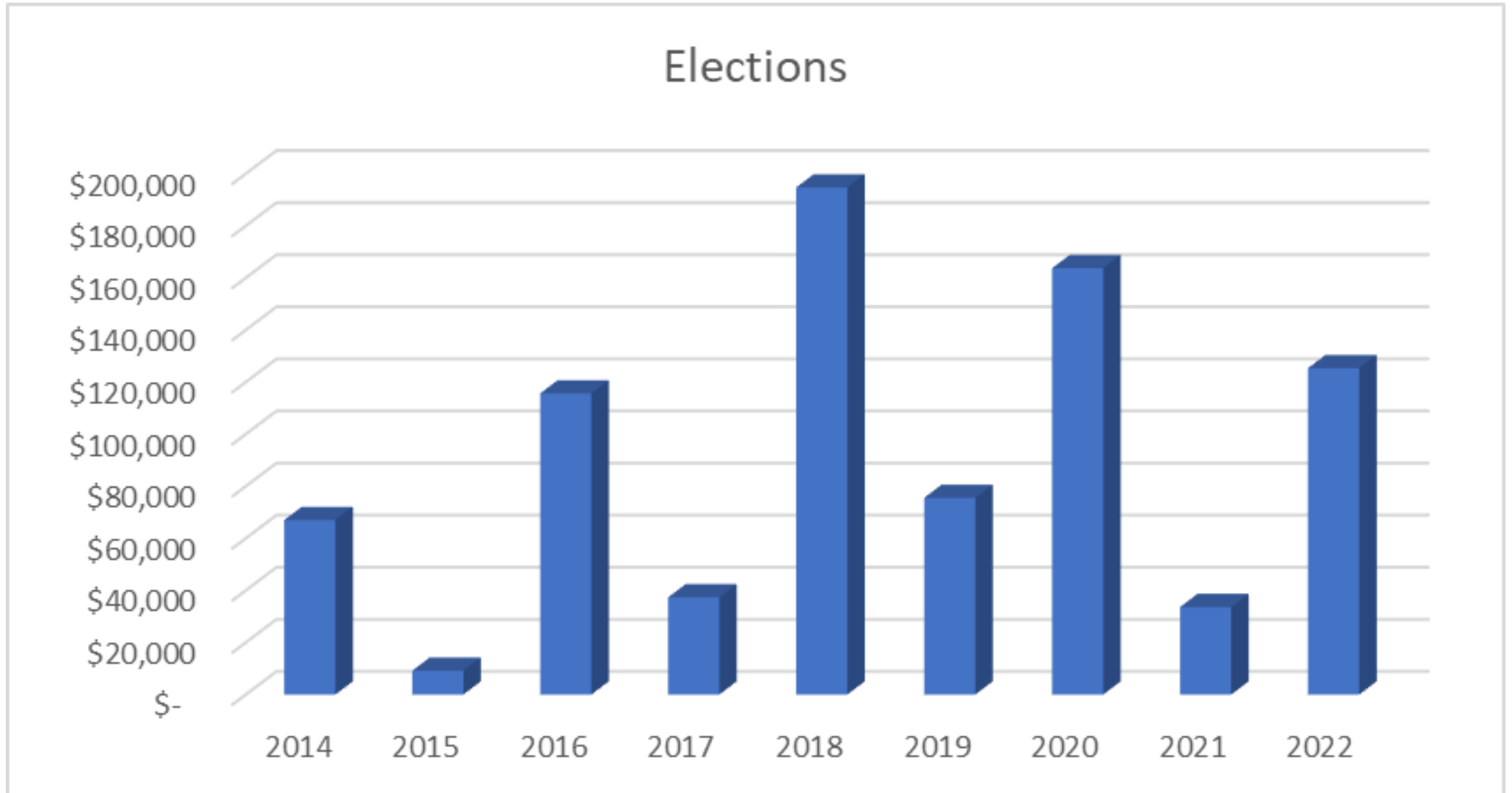
Brookings County Population



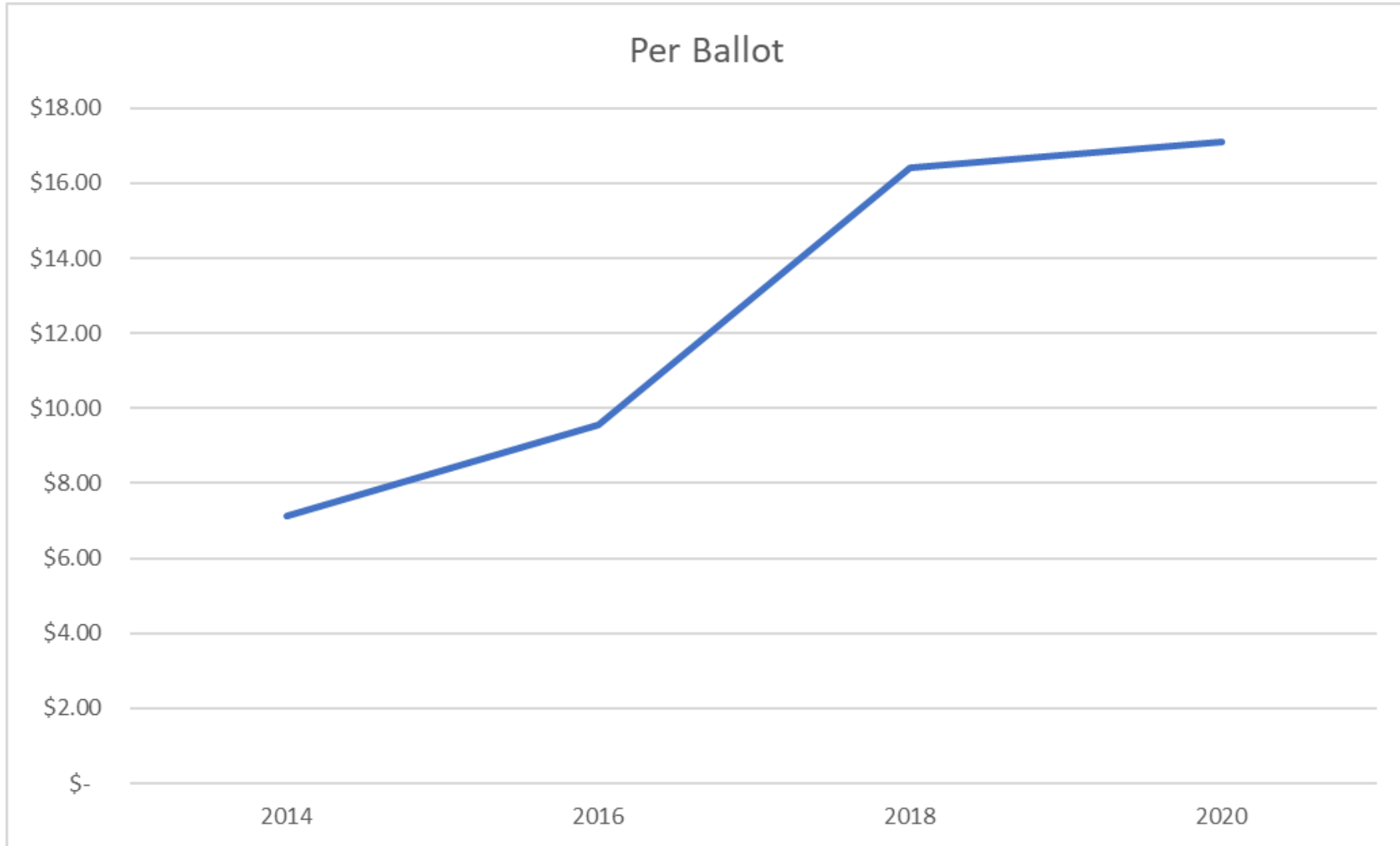
Brookings County Election Rates



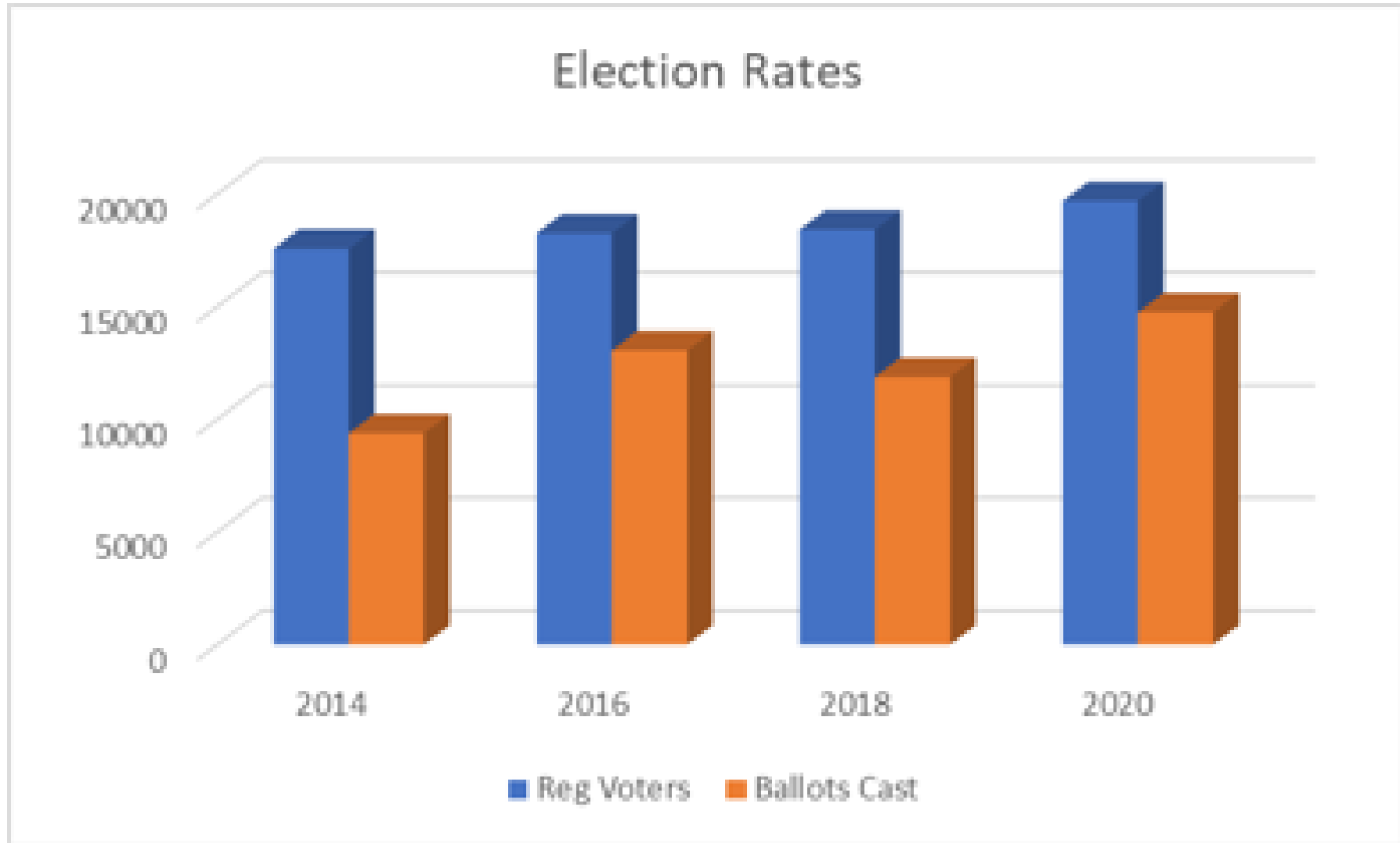
Brookings County Election Expenses

Drop Boxes

- Drop boxes have been added outside of courthouses in South Dakota counties. (some of these were purchased with Zuckerbucks)
- All of these boxes have the identical locking mechanism. Does your county have an after-market lock that is secure?
- Do they have 24-hour video monitoring with high-definition security cameras? Who is watching the video surveillance 24/7?
- Drop boxes can be vandalized, unlocked, and subject to ballot drops. They are a known mechanism for vote harvesting and fraud.
- Do you know the surveillance video is only kept for **2 months**? Election material must be kept for 22 months.

We believe a voter can either mail in their legitimate absentee ballot or drop off in person.

We strongly recommend that all drop boxes be removed from the state.

Does SD law allow drop boxes?

SDCL 12-19-7 addresses returning absentee ballots.

12-19-7. Marking and folding ballot--Officer before whom marked--Mailing or delivering ballot.

A voter voting an absentee ballot shall mark it and fold it without revealing the marks to any other person. The voter shall place the voted ballots in the return envelope provided and seal the envelope. The voter shall sign the statement on the return envelope. **The voter shall either mail the ballot, deliver it in person or have it delivered to the person in charge of the election.**

The grant was for 14,438.00 this leaves an under expenditure of \$312.74. However, there is one more pay period that has not been paid out yet. That will consume the remainder.

Originally, I was going to use the grant to get a permanent ballot drop box and for temporary workers. I have had discussions with the church where the deputy was located and they are not receptive to the ideal of having the drop box in their parking lot. I am still exploring the ideal I just have to find a location. The cost for a drop box at this time is around 4,000 if I find a suitable location for the ballot drop box I will budget accordingly.

Preliminary Results from walk canvassing

Lincoln County: Doors answered = 40%

Average doors answered with voters not living there = 94%

Minnehaha County : Doors answered = 44%

Average doors answered with voters not living there = 98%

Pennington County: Doors answered = 36%

Average doors answered with voters not living there = 100%
