REVIEW OF PREVIOUS MEETING MINUTES: Motion made by Director Johnson to accept the May 13, 2024 minutes as presented; and seconded by Director Lamb.

STAFF REPORTS CHIEF HOLMES:

• New Items:

• Fire Defense Board Items:

- O Training for our new Alternates has begun, and we are ready for the fire season rotation. Joe Hyatt from GPFD, has replaced Chief Painter from Jacksonville's alternate position.
- Attended the OSFM Conflagration Drill and we passed with no issues. It was a good refresher
 for those that have gone through this and the new FDBC, were able to see what happens, and
 what is the process when the event happens.

• OSFM – Red Team:

ASST. CHIEF ISMAILI (on vacation - report provided... numbers to be confirmed)

- For the month of May, we had a total of 115 calls: 8 good intent/no incident calls; 24 service/public assist calls, 4 false alarm calls, 32 medical calls, 14 illegal open burn/smoke investigation calls, 7 grass fires, 1 small vehicle fire, 14 motor vehicle accidents with no civilian fatalities and no firefighter injuries. Assisted on 11 calls with our mutual aid partners.
- Completed 2 fire and life safety inspections.
- OSFM Defensible Space program has been implemented, with 25 properties assessed.
- OSFM grant funded Chipper program is up and running. Three new hires to run the chipper and 17 residents have utilized the service.
- Water project is on hold... Agreement has been sent to the City of Cave Junction. Waiting to hear back. Theresa Stover has signed a contract with IVFD and is now working with us.

DEP. CHIEF GAVLIK:

- IVVF Foundation awarded \$8,000 grant from the Four Way Foundation. Funds will be used for the new training building – interior lighting, ventilation, and electrical. Insulation materials are planned if funds available after other work.
- Annual wildland pack testing done needed for out of district deployment opportunities.
- Two of our firefighters are currently training at the Oregon Caves for rope cave rescue. We also sent personnel to attend Rural Metro's water rescue class.
- Working with OR EMS to provide Pre-Hospital Trauma Life Support training in July.
- Explorers have a bottle fundraiser coming up on July 6th. Hoping to attend the Explorer Competition in January 2025.
- Training classes this month will cover Bleeding Control & Bandaging, Pump & Roll/Bump & Run,
 Firefighter Combat Challenge, and Leadership is Everyone's Business.

DIV. CHIEF SHERMAN:

- Logistics, vehicle and station maintenance report was provided in the board packet.
- They will be installing water level gauges in the external water tanks at the outlying stations.

ADMINISTRATOR PAUL: no report, financials provided.

NEW BUSINESS:

• 2024-2025 Budget Approval, as submitted from the Budget Hearing.

Motion made by Director Johnson moved to approve that the Illinois Valley Rural Fire Protection District budget committee approve the 2024-2025 budget in the amount of \$4,942,175. Additionally, moved that the budget committee approve taxes for the 2024-2025 fiscal year at the rate of \$1.8701 per \$1,000 of assessed

property value for operating purposes and the rate of \$0.50 per \$1,000 of assessed property value for funding the hiring and retaining of four (4) Firefighter/EMT's. The 2024-2025 budget year will be the 3rd year of the approved 5-year levy to approve 2024-2025 Fiscal Year Budget, seconded by Director Lamb. Roll Call vote: Director Binker -yes; Director Lamb – yes; Director Johnson – yes = unanimous

• Resolution 24-02 to adopt the 2024-2025 fiscal year budget, making appropriations, levying and categorizing taxes in the amount of \$4,942,175.

Motion made by Director Johnson to approve Resolution 24-02, seconded by Director Lamb. Roll Call vote: Director Binker -yes; Director Lamb – yes; Director Johnson – yes = unanimous

• Motion by Director Johnson to authorize to invest taxing district funds by the Josephine County Treasurer. Motion seconded by Director Binker.

Roll Call vote: Director Binker -yes; Director Lamb – yes; Director Johnson – yes = unanimous

- Recommend two annexations request as follows:
 - Adi Hamami of 35245 Redwood Hwy, O'Brien 7.8 acres for a total of 12.8 acres
- O Dwyer Trust & John Merrill of 6545 Lakeshore Dr, Selma 7.12 acres for a total of 12.12 acres Motion made by Director Lamb to approve both annexation requests, seconded by Director Johnson. Roll Call vote: Director Binker -yes; Director Lamb yes; Director Johnson yes = unanimous
 - Ethan Lane City of Cave Junction: No major updates or insights. City Council meeting is this evening and the budget meeting is on Wednesday, June 12.

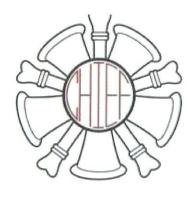

Board of Directors Meeting Operations/Prevention Notes 07/08/2024

The shift schedule is attached.

For May, we ran a total of 127 calls.

We had 23 Good intent calls. These are; no incidents found, canceled en-route, smoke investigation, & legal open burns.

We had 17 Service Calls. Public Assists, Lift assists, Gas leaks, Smoke & Fire Alarms, etc.

We had 2 hazardous condition calls. Powerline problems, fuel leaks, etc..

We had 35 medical calls.

We had 27 illegal open burns/ calls. Most of these calls are transient-related. We issued multiple warnings and citations.

We had 9 Grass Fire. The fire on Deer Creek was a rekindled burn pile. The fires on Protsman Way and the two on Holland Loop were unintentional caused by equipment. The fires on Shadywood and Reeves Creek were escaped open burns. The one on Lakeshore and the two on Redwood Hwy were undetermined.

We had 2 small vehicle fires. Both fires were undetermined.

We had 8 Motor Vehicle Accidents with 2 civilian fatalities and **NO** firefighter injuries.

We assisted our partners with 4 mutual aid calls.

We installed 13 smoke alarms in Valley residences.

We completed 8 fire and life safety inspections.

Our OSFM grant-funded chipper program has served 9 more residents.

The IVFD Water Project updates will be presented to you by our new Grant Administrator Teresa Stover.

With the help of the Illinois Valley Volunteer Firefighter Foundation, I was able to purchase the needed steel to help build the support needed for the interior staircase flooring. Now I need to coordinate my welders to install it so we can set into place the interior stars. Also, I have started cutting into the first-floor walls to connect the containers, allowing for building search drills inside the building.

We have a couple of new volunteer firefighter applicants in process that I hope will add to our ranks and provide us with a few more members to help with staffing and responses.

The Oregon EMS Association's Pre-Hospital Trauma Life Support (PHTLS) class is moving forward with registrations open. The class will be held on July 13-14, 2024 from 0800 -1700 hours each day.

The Explorers' next can & bottle return fundraiser with the IVCanDo is this Saturday, July 6^{th} from 1000 - 1400 hours if anyone has been saving up their returnable bottles and cans.

Training for this month will cover areas of Triage / Multiple Patient Scene, Water Rescue Throw Bags, Vehicle Extrication, Drafting / Porta-Tanks, and Task Performances.
