# ANNUAL REPORT 2025

## Message from the Fire Chief



Neighbors and partners,

2025 was a year of significant progress for the Illinois Valley Fire District. Our firefighters and support staff responded to 1286 calls for service, providing fire suppression, emergency medical care, rescue operations, and community support with professionalism and compassion. Every response reflects our commitment to protecting lives and property across the Valley.

This year we secured more than half a million dollars in grant funding, strengthening nearly every facet of district operations. This included \$97,000 from FEMA's Assistance to Firefighters Grant to replace outdated turnout gear; \$35,000 through the OSFM Wildland Upstaffing Grant for enhanced summer staffing; and a \$370,000 Resilience Connex Grant to stage critical community supply containers that will bolster our preparedness for large-scale emergencies. We were also

awarded the OSFM Capacity for Personnel Grant, supporting staffing stability and long-term service reliability.

Additionally, we improved district capability with a new-to-us vehicle for the Assistant Chief, received a donated ambulance from Mercy Flights now dedicated for Rehab Support, and expanded our Chipper Program to help residents improve defensible space and reduce wildfire risk.

IVFD proudly supported state and national response efforts. In January, we deployed a Type 1 Engine to the California Palisades Fire, and throughout the year sent a Water Tender, Type 6 Brush Truck, and Chief Officer to multiple Oregon State Conflagrations. These deployments demonstrate our district's readiness and professionalism, while also bringing valuable experience back to our local responders.

Training and leadership development remained a core priority, with members completing over 4,510 hours of training across all disciplines. In June, I began coursework in the National Fire Academy's Executive Fire Officer (EFO) Program, a multi-year leadership commitment that will continue through 2026, with graduation planned for early 2027. This education strengthens our long-term strategic direction and leadership capacity.

Through strong partnerships, responsible financial management, and the dedication of our staff and volunteers, 2025 was a year of meaningful advancement for the Illinois Valley Fire District. We remain focused on building a safer, more resilient community—one prepared to meet today's needs and tomorrow's challenges.








## About Our District



**I**n 1954... the Illinois Valley Rural Fire Protection District was formed. It was originally formed by farmers who volunteered their time to keep their community safe. From its inception, volunteers have been the backbone of the District and continue to keep us moving forward with their hard work and dedication to the safety of our communities.

**W**e currently protect the communities of: Selma, Kerby, Cave Junction, Takilma and O'Brien. The District is about 144 square miles covering the Redwood Highway corridor; extending from the top of Hayes Hill to the California border. The Fire District responds regularly for mutual aid assistance with Rural Metro Fire, Gasquet Fire (CA), Oregon Caves, BLM, Forest Service and unincorporated areas of Josephine County. With mutual aid, our total response area is over 200 square miles.

In recent years, the overall scope of emergency services provided by IVFD has broadened beyond fire suppression to include medical emergencies, public assists and rescues. Medical calls accounted for approximately 48% of our calls in 2025, while fires accounted for 8% .

## Fire Chief



### Fire Chief

Fire Chief John Holmes has led the district since 2020, bringing with him over three decades of experience in fire service and emergency management. He holds a Master's Degree in Emergency Services Management and has been instrumental in advancing the district's operational capabilities, community engagement, and financial sustainability.

Under Chief Holmes' leadership the district has secured numerous grants to enhance resources, apparatus, and personnel.

In 2017 the district successfully passed a Local Option Tax Levy to hire and maintain 4 FF/EMT's. This Local Option Tax Levy was renewed in 2022 for five more years and we hope to be able to maintain this funding source. He was also awarded a Fire Service Capacity grant which allowed the district to add 2 FF/EMT's to our staffing. Between the levy and the grant we have been able to sustain 6 full time FF/EMT's for the Illinois Valley giving us 24/7 staffing.

Chief Holmes has also spent multiple hours collaborating with Oregon State Fire Marshall, neighboring Fire Chiefs, and State representatives to share information to help not only our community but others in Fire Prevention, grant administration, emergency management, strategic management and resource management. His dedication in crisis leadership and emergency response will continue to strengthen the District's ability to serve and protect.

## Assistant Fire Chief



### Assistant Chief—Operations & Prevention / Fire Marshal

Assistant Chief Kamron Ismaili has been a dedicated member of the district since 2003, starting as a volunteer and rising through the ranks to his current role as Assistant Chief of Operations and Prevention and Fire Marshal. With over two decades of service, he has played a vital role in enhancing the district's operational efficiency, fire prevention efforts, and overall safety initiatives.

Assistant Chief Ismaili's unwavering commitment to the district is evident in his leadership, work ethic, and dedication to both emergency response and community risk reduction. His expertise in fire prevention and operational strategy continues to strengthen the district's mission of protecting lives and property.

## Facility Inspections

Illinois Valley Fire Prevention is responsible for all the facilities within the District. The position is currently staffed by our Assistant Fire Chief / Fire Marshal and three Shift Lieutenants.. Fire inspections are scheduled and accomplished as needed and as time allows.

## Burn Permits

In 2025 the residents of the Illinois Valley were again able to receive information on safe burning practices, burning regulations, and burn permits from the comfort of their homes through our online burn permits. This creates a fuel savings for the public and passes on valuable fire safety information. The information and permits were also available at the administration office for those who are not connected. The 2024-2025 Burn Season ran from October 2024 thru May 31, 2025; there were 1,863 residential burn permits issued.

## Smoke Alarms

In 2025 the residents of the Illinois Valley were again able to receive information and request smoke alarm installations through our "Community Connect" software. Once registered you can get your burn permit, order inspections or smoke alarm installations. You can also fill out information you fill the fire District might need if they have to respond to your address.



Valuable information includes items like:

- How many residents in the household and if any are disabled.
- Are there any buildings unattached that contain people.
- How many pets and if any are likely to attack one of the responders.
- Are there any bridges or roads that our vehicle are unable to cross
- Any information you feel is pertinent to our emergency responders. This information is available to the responders before they arrive, which could be life saving.

## Budget & Finance



### Division Chief Administration

Division Chief Jamie Paul has been a vital part of the Illinois Valley Fire District since September 2014. She originally joined as a front desk and billing clerk and through dedication and hard work, she advanced to her current role as Division Chief of Administration in March of 2017.

As the Division Chief of Administration Division Chief Paul oversees creating and maintaining the Districts' annual budget and audit. She takes care of accounts receivable & payable, grant expenditures, payroll, paid time off accruals & benefit records ensuring the smooth management of employee administration. Her diligence, attention to detail, and commitment to the district's success make her an invaluable asset to both the department and the community.

**Illinois Valley Fire District** has a fiscal year of July 1 through June 30 of the following year. Our main source of funding is received from Josephine County tax assessed values at the rate of \$1.87 per \$1,000 of assessed value. We were also awarded a 5-year local option levy for the fiscal years 7-1-2022 thru 6-30-2027 for the hiring/maintenance of 4 full time FF/EMT's at the rate of \$.50 per \$1,000 of assessed value. We do receive minimal funding from reimbursement invoicing, donations, and interest income.

### Deployment Income

Illinois Valley Fire District may receive deployment income when we are providing aide to fires outside our district. The District only receives the funds for the apparatus that is sent. Any money received for Fire-Fighters wages is 100% paid to the Fire-Fighters that were deployed.

### Grant Revenue

Illinois Valley Fire District applies for grants throughout the year. The possible grant funds are added into our budget usually for the next Fiscal Year. If we get the grant then we are cleared to spend those funds. Often times we do not receive the grant and this can make a large impact on our budgeted expected income. Grant items are, of course, not purchased unless the funds are awarded and received.

### Awarded Grants 2024-2025

In 2024-2025 IVFD was awarded an Oregon State Fire Marshall upstaffing grant of \$35,000 to help with seasonal staffing during high fire season. This grant has been invaluable in getting the extra help that we need.

We were also granted a Resilience Hubs and Networks

grant which was not monetary but supplied the Illinois Valley with disaster preparedness equipment. This equipment has been strategically placed at opposite ends of the Illinois Valley.

### Previous FY Grants

In previous Fiscal Years we were awarded multi-year grants that are still in play. We are currently still working on: The hydrant water and sewer infrastructure grant which helps build infrastructure along Caves Highway (House Bill 2588) and will get a new water hydrant near IVFD Station 1. This hydrant will be utilized for fire protection in the Illinois Valley as well as giving our Fire-Fighters the ability to do live training. We are diligently working to complete this grant by the end of Fiscal Year 25-26.

- We still have some funds from the OSFM wildfire risk reduction grant (chipper grant) which has supplied at least 70 individual residences with hundreds of hours of fire prevention services by chipping of wood debris piles. We are hoping to do some community events this year and are working on staffing to get the chipper out to individual residences as well.
- Our OSFM Fire Service Capacity Grant, which is supplying the Illinois Valley with 2-full time FF/EMT's until 6-30-2026, still has some funding left and we will keep our FF/EMT's until we spend all of the grant money. This grant with our Levy funds has given us the ability to keep two (2) FF/EMT's on 24/7.

## EMERGENCY MANAGEMENT

**T**he Illinois Valley is prone to natural disasters such as flooding, earthquakes and wildfires. Preparedness is critical for saving lives. The Fire District works closely with Emergency Management staff to insure we are prepared for a disaster.

### Available Programs:

A few of the programs that we provide information for are: Disaster Registry, Citizen Alert, and Evacuation information (Ready, Set, Go).

The Disaster Registry is a program in Jackson and Josephine Counties that gives special assistance in an emergency. If you need outside help to safely leave your home or special notification about the need for evacuation, due to an impairment, this program is available by visiting [www.rvcog.org](http://www.rvcog.org). You can also contact the Rogue Valley Council of Governments at 541-664-6674.

Citizens Alert sends information by mobile phone, work phone, email, or text messaging in case you are not at home when an emergency strikes. To sign up please visit [www.co.josephine.or.us/alert](http://www.co.josephine.or.us/alert).

Ready, Set, Go information helps residents prepare for evacuation. It informs citizens what "green, yellow, and red" warnings mean as well as how to prepare for each.

### EOC:

IVFD houses a Josephine County alternate Emergency Operation Center (EOC). The alternate EOC would be activated if the Illinois Valley became cut off from the rest of the county, or in the case of a large scale event in the Illinois Valley.

### ARES:

The Josephine County Emergency Communications (JCEC) is part of the state wide ARES which provides amateur radio emergency communications for the alternate EOC and on scene of a disaster. Their equipment is housed at IVFD Station #1. They provide a critical link to the outside world if telephone communications were to be interrupted.

- ◆ Assign tasks to each family member for what to do during Level 1 (Ready), Level 2 (Set) and Level 3 (GO!) evacuations.
- ◆ Have an evacuation plan for your pets and livestock. If it isn't safe for you, it's not safe for them.
- ◆ Designate a meeting place - this could be a friend or family member's house, or an evacuation shelter.
- ◆ Choose an out-of-the-area contact person to relay information about your welfare to family and friends and to keep your phone lines open.

#### House Preparation

- ◆ Make sure house numbers are visible from the street.
- ◆ Make sure driveways are wide enough for emergency vehicles to enter (10-12 feet wide).
- ◆ Prepare your defensible space.

#### Emergency Kits - Keep them ready at all times in your home and vehicle.

- ◆ Include supplies for you and everyone who lives in your home or visits regularly.
- ◆ Include supplies for your pets.
- ◆ Include copies of important documents, phone contact lists, family photos, household inventory lists, and any portable valuables.
- ◆ Keep your vehicles filled with gas.

### BE SET

- ◆ Keep pets and livestock ready to go in case you need to evacuate in a hurry.
- ◆ Be sure to have your photo ID or something showing your current address in case you need to access an evacuated area.
- ◆ Monitor local television and radio stations for updates.
- ◆ Move propane BBQ appliances away from structures (during wildfires).

### GO!

- ◆ Leave house lights on and windows closed.
- ◆ Let your emergency contact and/or family members know where you are going.

# ILLINOIS VALLEY FIRE DISTRICT



The following individuals share a deep commitment to public service and the citizens of the Illinois Valley, and their selfless contributions are essential to the success of the district's mission. While the number of volunteers may fluctuate, their dedication to the Illinois Valley remains constant, and their hard work continues to strengthen the district's ability to respond to emergencies and serve the community effectively.

## Firefighter/EMTs

The Illinois Valley Fire District is covered by three shifts (A, B, C), manning Station 1 twenty-four hours a day, 365 days a year. Each shift works forty-eight hours on duty and ninety-six hours off duty.

Station 1 (Caves Hwy) is the Primary Response for all of Illinois Valley.

These FF/EMT's are paid by the November 2021 Local Option Tax and Capacity Grant funds.

The five-year levy (7/1/2022—6/30/2027), ensures funding for the salaries of four full-time Firefighter/EMTs while the Capacity Grant monies fund the salaries of the other two. The Capacity Grant runs 7/1/2023—6/30/2026.

This critical support has allowed Illinois Valley Fire District to retain these essential positions, strengthening the district's ability to respond effectively to emergencies and serve the community.

The district is also lucky enough to have some wonderful volunteer fire fighters. These men and women spend hundreds of hours each year responding to incidents as well as weekly and annual training. Volunteer fire fighters are one of the district's most valuable asset and IVFD would like to thank them for all they do!

## Volunteers

In 2025, volunteers contributed thousands of hours to the Illinois Valley Fire District, demonstrating their unwavering dedication to the community. Our volunteer roster is made up of citizens from all walks of life, including retirees, business owners, homemakers, students, auto mechanics, public servants, baristas, contractors, restaurant and retail workers, to name just a few.

The **IVFD REHAB TEAM** responds as needed and is on the cutting edge of cardiovascular disease and cancer prevention for our firefighters. This team responds to all structure and wildland fires as well as any extended incident.

**RESERVE TENDER OPERATORS** respond as needed to setup and operate water supply to the fire scene.

**TRAFFIC CONTROL** responds as needed to the scene when traffic control is needed.

**CHAPLAINS** respond as needed to the scene and are part of the Rogue Valley Chaplain's Association.

**EMS** pull shifts along side the Duty Crew to provide additional EMS support.

**AIR TRAILER** responds as needed to any fire where the Fire Fighter air tanks may need to be refilled. Without this critical team our firefighters would be limited on the amount of time they could fight a fire.

Sometimes our firefighters assist AMR with transporting patients to the hospital; Our **SUPPORT** is also utilized for picking up the firefighter and bringing them back to the station.







### S tatistics

In 2025 we averaged 86.5% of calls processed in under 64 seconds, followed by 10.86% processed between 64-180 seconds and 2.64% over 180 seconds. We had 59 mutual aid responses with 74.58% being mutual aid received, 15.25% mutual aid given and 10.17% other aid given. Travel time for responses varied due to the size of our District with only 14.75% under 240 seconds.



## Statistics



The past year for the Fire District was once again a busy year. There were 1286 calls, which is a 5.99% decrease from the previous year. There were 1,368 logged last year and 1,286 calls this year which included: 105 Fire calls, 615 EMS calls, and 258 Public Assists/Other calls. These numbers include cancelled enroute and mutual aid responses.

The Illinois Valley Fire District encompasses approximately 144 square miles. The Fire District responds regularly for mutual aid assistance with Rural Metro Fire, Gasquet Fire (CA), Oregon Caves, BLM, Forest Service and unincorporated areas of Josephine County. We also aid local law enforcement when requested for standby situations. With mutual aid, our total response area is over 200 square miles.

## Emergency Medical Services



**T**he Illinois Valley Fire District and our partners, American Medical Response (AMR) provide basic and advanced life support to the entire Fire District. AMR has the exclusive ambulance service contract for Josephine County and they station an ambulance at IVFD Station 1 for District coverage. Back up ambulances are available from their stations in Grants Pass.

We also call upon the services of Mercy Flights and Reach Air Medical Services on a regular basis to give the citizens of the Illinois Valley the quickest emergency medical care possible.

Emergency medical calls are approximately 48% of IVFD's call volume. IVFD members include licensed basic life support, Emergency Medical Responders and Emergency Medical Technicians. Some are licensed Advanced Emergency Medical Technicians and Intermediate Emergency Medical Technicians. Each medical responder receives continuing education every month and skill proficiency assessments.

### **Mutual Aid:**

IVFD is a signatory to the Rogue Valley Fire Chief's Association Mutual Aid Agreement. IVFD is also on the Rogue Valley Task Force providing rapid multi-department response to large-scale incidents in Josephine and Jackson Counties. Due to our close proximity to California, we also have an agreement with Gasquet Fire for mutual aid.

### **Dispatch Services:**

The 911 communications center is operated by the City of Grants Pass and provides 24 hour 911 call-taking services for a number of agencies in Josephine County, including The Illinois Valley Fire District.

### **Experience Levels:**

The bulk of our emergency service delivery is from our paid career staff with years of service ranging from three years to over 30 years.
