- Station 5: The permitting process has begun.
- Attended the IVFROG, SOFCO, and IAAI meetings, multiple education and continuing education classes, as well as our hydrant grant meetings.

DIV. CHIEF GAVLIK:

- This month I am finishing up with the ordering of the electrical supplies needed for the interior of the training building. This was funded by the Four Way Foundation grant.
- We have four recruits scheduled for the next fire academy and the online training has been opened up for them to begin their bookwork before the hands-on training which starts next month.
- Our DPSST training maintenance packet is completed and we are good to go for another year. Also, I
 am finishing up with the registration of the Explorers this month to keep that program going for
 another year. We currently have eleven post members and five club members but we may be losing one
 or two due to moving out of the area.
- I am in the process of putting together next year's training schedule as well as updating our training lesson plans for the coming year.
- Participated in a mutual aid training this week: night operations structural training activity.
- Training for this month will cover areas of Patient Assessment, Salvage & Overhaul, and SCBA Donning. We will not have any training scheduled for Christmas Eve and New Year's Eve.

Logistics, vehicle and station maintenance report was provided in the board packet.



The shift schedules are attached.

For November, we ran a total of 114 calls.

We had 22 Good intent calls. These are no incidents found, canceled en-route, smoke investigation, or legal open burns.

We had 20 Service Calls. These are public assists, lift assists, gas leaks, water leaks, stand-by, etc.

We had 38 Medical Calls.

We had 9 Illegal Open Burns/Calls. Most of these burns were residents burning legal material during fire season. We had a few residents burning illegal material, which were cited, and the remainder were transient warming fires.

We had 1 Appliance Fire. The cause of the fire was unintentional. This was a malfunctioning pellet stove that got clogged.

We had 1 Large Vehicle Fire. The cause of the fire was unintentional. This was a malfunctioning refrigerator.

We had 2 Structure Fires. The fire on Caves Hwy was unintentional. The cause of the fire was a wood stove. The fire on Aquarius Way is under investigation.

We had 15 Motor Vehicle Accidents with NO civilian fatalities and NO firefighter injuries.

We assisted our partners with 6 mutual aid calls.

We installed 12 smoke alarms in Valley residences.

We completed 2 fire and life safety inspections.

SUBJECT: Hydrant Project Status Report

DATE: December 10, 2024

The IVFD water and sewer lines expansion will install approximately 1,700 lineal feet each of water and sewer lines from existing City of Cave Junction main lines on Old Stage Road to the Illinois Valley Fire District Station 1 at 681 Caves Highway (see attached drawings). Four fire hydrants will be installed along the water line; three on Caves Highway and one on the fire station back lot.

IVFD is managing the design, engineering, and construction of the project. Upon completion, IVFD will hand off operation and maintenance of the lines to the City of Cave Junction. The project is funded by an Oregon Lottery direct legislative award, as administered by Business Oregon. The Business Oregon deadline to complete the project is March 2027.

Procurement

- o In response to the Request for Proposal (RFP) for design engineering services published on September 17, we received and opened two qualified proposals at the proposal opening meeting on October 8. The proposals were evaluated and both firms were interviewed. A preliminary selection has been made.
- The contract between IVFD and the selected engineering firm has been negotiated and drafted. The first draft was reviewed by IVFD, legal counsel, and the engineering firm. The second draft is now under review by IVFD and Business Oregon. After their review and any further changes, it will return to the engineering firm and legal counsel for a second review.
- Next steps are to complete contract updates, issue the Notice of Intent to Award
 Contract in mid-December, execute the contract, and then hold the engineering kick-off meeting.

Design engineering

Survey and design to achieve 100% approved Construction Documents is estimated to take
 65 days.

Construction

o The construction phase is estimated to take 45 days. Although this is subject to change, this phase is projected to complete in summer 2025.
