#### ASST. CHIEF ISMAILI:

- For the month of July, we had a total of 130 calls: 27 good intent/no incident calls; 10 service/public assist calls, 2 false alarms, 5 hazardous condition calls, 34 medical calls, 6 illegal open burn/smoke investigation calls, 13 grass fires, 3 small vehicle fires, 1 large vehicle fire, 2 structure fires, 11 motor vehicle accidents with no civilian fatalities and no firefighter injuries. Assisted on 16 calls with our mutual aid partners.
- Installed 13 smoke alarms in valley residences.
- Completed 13 fire and life safety inspections.
- Water project: Teresa Stover is our grant administrator and will be providing updates.
- Station 5: We still have a contract with the county, which includes a paved driveway, which has been waived. We also have an opportunity to contract with the Grange for \$1,200/year, including power and water services. A contract is currently under review with the Grange attorney's office.
- Lt. Lane has accepted a position with Eugene Springfield Fire. He will be missed after 7-1/2 years with IVFD. As a result, FF/EMT Marler is now in a levy paid position and FF/EMT Vetter is now in a capacity paid position. We have moved FF Dunlap to a Wildland up-staffing position.

#### DIV. CHIEF GAVLIK:

- The power is connected to the training building lighting; working on cutting in for the 3<sup>rd</sup> floor stairs.
- Working on updating firmware for radios and repeaters.
- Added two new volunteer firefighters, and processing more applications.

IVFD is responsible for the construction portion and will then hand over the operation to the City of Cave Junction. An upcoming RFP will soon be released for design engineering services.
- Ethan Lane City of Cave Junction: Nothing to report for today's board meeting. (via FB Live)

- The board welcomed two individuals interested in being appointed as a new board member to fill our board vacancy. The applicants attending were invited to speak during public comment.
- Director Johnson gave a brief update that the board held a workshop prior to the board meeting to begin work on the upcoming levy initiative for the 2025 election.
- Director Johnson shared that Best Practices Public Meeting Law training (from SDAO) is now available online on Vector Solutions. SDAO emailed today that it is available; and it needs to be completed by all board members. The "official" state mandated Public Meeting Law training is still under development by the Oregon Government Ethics Commission. We will add it to the agenda as an item to be completed once the training is released by OGEC.

- Director Lamb thanked our firefighters for attending our meetings, and expressed appreciation for them staying safe; and for their spouses that support them.



The Oregon State Fire Marshal is excited to share a few success stories from the 2024 Wildfire Season Staffing Grant. This grant provided funding to 191 local fire agencies in Oregon, allowing them to hire additional firefighters. These extra hands have been crucial in responding to wildfires quickly and keeping them small, away from our communities.

One great example of how this grant has helped is with the Illinois Valley Fire District (IVFD). Here are two incidents that show the difference more firefighters can make:

- On July 17, IVFD and the ODF Southwest Oregon District responded to a vehicle fire on Martin Road. The car was fully on fire and started burning the nearby brush. Thanks to the additional firefighters funded by the staffing grant, the ODF quickly controlled the brush fire while IVFD put out the car fire. All fires were quickly extinguished and cleaned up.
- In another incident, IVFD, ODF Southwest Oregon District, and the Josephine County Sheriff's Office responded to a car fire at the intersection of Dead End and Oregon Street. The fire spread to blackberry bushes and nearby brush. With the extra firefighters from the staffing grant, the fire was put out quickly and the area was cleaned up. This fast response prevented a larger wildfire.

These examples show how the 2024 Wildfire Season Staffing Grant is helping local fire agencies respond to fires more effectively. By adding more firefighters, we can better protect our communities and natural areas from wildfires.

Board of Directors Meeting Operations/Prevention Notes 08/12/2024

The shift schedule is attached.

For May, we ran a total of 130 calls.

We had 27 Good intent calls. These are; no incidents found, canceled en-route, smoke investigation, & legal open burns.

We had 10 Service Calls. Public Assists, Lift assists, Gas leaks, etc.

We had 2 False alarms, etc

We had 5 hazardous condition calls. Powerline problems, fuel leaks, gas leaks etc.

We had 34 medical calls.

We had 6 illegal open burns/ calls. Most of these calls are transient-related. We issued multiple warnings and citations.

We had 13 Grass Fire. The Crooks Creek fire was an act of nature. The fire started from a lightning strike.

The fire on Martin Road was unintentional. The vehicle exhaust system caught the grass on fire.

The fire on Redwood Hwy in Kerby was undetermined. This was most likely vehicle emissions.

The fire on O'Brien Road was unintentional. This was a rekindled burn pile.

The fires on 200 blk Caves Hwy and 300 blk Kerby Ave were unintentional. These were caused by unattended transient campfires.

The fire on the 1200 blk of Caves Hwy was unintentional. This was caused by the exhaust or blades of a lawnmower. **B**oth fires on Dick George Road and the fire on Kirkham Road were unintentional. The cause of the fires was vehicle emissions.

The fire on Rockydale Road was undetermined. This was possibly an intentional fire. ODF and OSP are investigating.

The second Redwood Highway fire and the fire at Forks Park were intentional. ODF and OSP are investigating.

We had 3 small vehicle fires. The fire on Rockydale Road was unintentional. The fire started due to mechanical failure. The fire on the Golf Club Drive was undetermined. The fire started in the engine compartment. The fire on Norman Road was undetermined. The fire appeared to have started in the engine compartment.

We had 1 large vehicle fire. The fire on W. 6<sup>th</sup> St. and Kirby was undetermined. This was a transient trailer that was unoccupied.

We had 2 structure fires. The fire on Laurel Road was determined. The fire originated in the attic space above the first floor. The fire had possibly started by electrical arcing. The fire on Caves Hwy was unintentional. This was a plastic-covered greenhouse. The fire started from the spontaneous combustion of wet compost covered with cardboard.

We had 11 Motor Vehicle Accidents with **NO** civilian fatalities and **NO** firefighter injuries.

We assisted our partners with 16 mutual aid calls.

We installed 13 smoke alarms in Valley residences.

We completed 13 fire and life safety inspections.

The IVFD Water Project updates will be presented to you by our new Grant Administrator Teresa Stover.

Station 5 location. The contract with the county is still in place and the pavement obligation has been waived. But we have an opportunity to contract with the Grange to place station five on their property. This is a \$ 1200-a-year obligation that will put us on the property that has power and water. The contract is still at their attorney's office.

We have lost Lt Lane to Eugene Springfield Fire Department. He has given the Fire District 7 ½ years of dedicated service. He will be missed.

We have brought FF/EMT Marler over from Capacity to the Levy side.

We have Brought FF/EMT Intermediate Vetter over from Upstaffing over to Capacity.

And we have brought on board FF Dunlap to our Wildland up-staffing.

**SUBJECT: Hydrant Project Status Report** 

DATE: August 7, 2024

The IVFD water and sewer lines expansion will install approximately 1,700 lineal feet each of water and sewer lines from existing City of Cave Junction main lines on Old Stage Road to the Illinois Valley Fire District Station 1 at 681 Caves Highway (see attached drawings). Four fire hydrants will be installed along the water line; three on Caves Highway and one on the fire station back lot.

IVFD is managing the design, engineering, and construction of the project. Upon completion, IVFD will hand off operation and maintenance of the lines to the City of Cave Junction. The project is funded by an Oregon Lottery direct legislative award, as administered by Business Oregon. The Business Oregon deadline to complete the project is March 2027.

#### Agreements

- The grant agreement between IVFD and Business Oregon was executed in March 2024.
- o The contract with Stover Writing Services for grant and project administration was executed on June 10, 2024.
- o The cooperative agreement between IVFD and the City of Cave Junction was signed by the City on July 31, 2024. This agreement indicates the terms and conditions under which the City will accept ownership of the water and sewer extension project.

### Permits and regulatory approvals

- o ODOT requires the Utility Permit Cultural Resource Review Notification to three tribal nations: Confederated Tribes of Grand Ronde, Confederated Tribes of Siletz Indians, and Cow Creek Band of Umpqua Tribe of Indians. The tribal notification is in process and should be completed in about five weeks.
- After the engineering plans are complete, the following will be done:
  - Submit the ODOT Application to Occupy or Perform Operations Upon a State Highway.
  - Submit engineering plans, land use compatibility statement, and treatment capacity statement to the Department of Environmental Quality (DEQ) for review and approval of the sewage collection system.
  - The Oregon Health Authority Drinking Water Services will likely need to review engineering plans for the water lines; these requirements are being researched.
  - The City of Cave Junction requires a development permit for public works improvements.

## Procurement

The Request for Proposal (RFP) for design engineering services has been drafted and will soon be submitted for review by Business Oregon. Upon completion, legal notices and other announcements will be published and engineering companies will be invited to submit their bids. There will be a three-week bid period.
