VRCC/ECCNA

April 2022 VRCC report

Report

Hello Family,

The numbers are in from the 39th AVCNA. Unfortunately, the 39th AVCNA lost \$9,189.30. The 39th host committee spent \$33,304.61 and it only received \$24,115.31. This doesn't surprise me with the 39th AVCNA having to deal with COVID and historically conventions not held in the Richmond to VA beach areas lose money. The 40th is being held in Virginia Beach.

There was an issue with the VRCC's Wells Fargo bank account. I am going to read the treasures report directly.

"I have a few items to discuss that happened over the convention weekend.

1. I arrived at the Hotel Madison on Thursday, Jan 20, 2022 around 1 pm. I tried to check in, but my room was not ready. The VRCC secretary rode with me and was checking in, so I informed the guest service agent that she could put the Thursday night room and tax for the secretary on the VRCC debit card. The agent ran the card and it declined. I asked her to try again because there was no way the card should be declining. The card was declined again. I informed the GSA that I would be back later to cover the Thursday charge. I immediately went to the lobby and signed on to Wells Fargo, where accounts are located. To my surprise all three of the accounts had a \$0.00 balance and stated "Acct closed due to CIP error". My heart dropped; I didn't know what happened. Was it fraud? I immediately told the VRCC secretary what had happened and then called the local Wells Fargo bank in Harrisonburg. I spoke to a banker and let him know what happened. He looked up our accounts in the system and stated it was a CIP error. He stated the error was the addresses did not match in the system. The accounts were closed and a cashier's check would be mailed out to the address in the system, which is the VRCC's Chair's address. I informed the banker that would not work, that I was at the hotel and we were having a

convention that weekend. I got off the phone drove to the bank in Harrisonburg and asked for the bank manager. I proceeded to tell the bank manager what had happened, he looked up the accounts and called corporate. This is what happened, when I went to VA Beach in Oct of 2021 to add the 40th treasurer to the 40th bank account, the banker looked up the VRCC through the SCC, (State Corporation Commission), which has our address listed as the VRCC Chair's address, since the address on record follows the chair of the corporation. The bank accounts address has always been our accountants address in VA Beach, so they can receive the bank statements in order to compile our taxes and financial statements. The banker in VA Beach informed me that the addresses had to match what was listed with the SCC. I informed the banker that it has never matched the SCC and the address had been the accountants for over 10 years. So, the banker in VA Beach changed the address on the bank accounts to the VRCC chair's in order to match the SCC, but stated we could keep the mailing address as the accountants. She was WRONG!! The addresses did not match; therefore we received a CIP error and the accounts were closed down. I was not notified by mail or a phone call that this was going to happen. I asked the bank manager what we could do, that I needed start-up money to open the convention the next day. After several hours, the corporate office was able to reverse the closure and open the account back up. The banker told me to check the accounts in the AM. I informed the VRCC chair on Thursday night. 2. Friday morning: I logged on to the VRCC bank accounts and all the accounts were back open, but still had a \$0.00 balance. I called the bank to see what could be done, the banker stated that he could not stop the cashier checks that they automatically went out in the mail. He stated that it would cost us several hundred dollars to stop payment and could not guarantee that we would get the money back from corporate even if it was a bank error. I was very pleasant and did not shoot the messenger, I informed him that I needed cash and that was not acceptable.

I spoke to the VRCC chair and secretary and we came up with the following: The VRCC V-Chair was informed when she arrived Friday night.

- I took \$600 out of my personal bank account to cover the start -up funds for the convention. The VRCC Chair was able to get the hotel to put all the rooms and expenses from the hotel on a master account and we would cut a check at the end of the convention.
- The VRCC treasurer paid for the hospitality food on her personal credit card. (est. \$700)
- The VRCC treasurer took the bank deposits from Friday to the bank on Sat morning so the funds could immediately be available. (\$3810.00)
- The money we collected through PayPal on Friday hit the acct Sat morning (\$4,872.82)
- 3. Sunday: Due to PayPal deposits and cash deposited we were able to write checks and pay our bills. The VRCC treasurer, Secretary, Chair, and Vice-Chair agreed that we would address what happened at the regular VRCC business meeting in March 2022.
- 4. The certified checks were finally received by our accountant. They informed me by email and I asked them to mail the checks to my home address. The accountant mailed me the checks and they were deposited on 2/10/2022."

The treasurer submitted in her report copies of the checks received after the convention from Wells Fargo and the bank statement with the money being redeposited into the VRCC bank account.

IMO the treasure stepped up and went above and beyond her duties and ensured the convention would go on.

Elections were held for a majority of executive positions of the VRCC, chair, vice chair, secretary, and vice treasure. The past chair, vice chair, and secretary were re elected since normally when you serve these positions it's for 2 conventions and they were only able to serve one convention due to COVID postponing the 39th a year. Kelly M, the former VRCC director of new dominion was elected the vice treasurer. This will be the final year the treasurer will serve, so Kelly will assume the treasurer's duties next year and the vice treasure position will be open again in March of 2023.

My term as VRCC director will end In February 2023 and I will be able to fill the role as vice treasure (if elected) at that time. This means at this time I will not be looking to serve another 2 years as the Piedmont

VRCC director when my term is up. It would be a good idea for our area to elect an alternate VRCC director sooner than later.

**Treasurer** This budget-development information was emailed.

Good afternoon. I apologize for not putting this info out sooner in the month. I dropped the ball on our budget.

Attached is an Excel spreadsheet showing the last 18 months of financial info for the Area. There's a copy of the first two columns down below as well. The second column labeled "Last 18 Months" is the average per month for that time period. The exception being Special Events since they only have four events per year typically.

As you look through this info, please take into consideration what our monthly donations have been before asking for a specific budget amount. Also keep in mind that the budget can be updated. For example, if there's no H&I meetings, and therefore that subcommittee wants very little in the budget now, that figure can be modified at a later date if more meetings start to happen. Just an example. Another example is if literature keeps their figure lower than they have historically, but one month they need to go over that dollar amount, then a motion can be presented to exceed the budget amount.

Please let me know if you have any questions and follow up as soon as possible with a proposed budget amount for the committee you're responsible for.
