There was some great validation of our effectiveness when a staff member told us that a woman who hadn't spoken her entire time there finally spoke after our meeting to say she was going to attend an NA meeting when she discharges the next day!

5 East had no meetings last month; Melissa says she hopes to find some folks to take a meeting in to the facility this month.

ACRJ had zoom meetings scheduled for both the men and the women, but the ACRJ coordinator got covid and since she has to be in the meetings, we had to cancel. We are working to get the meetings started this month.

Wellness center's Panel Leader is unable to continue, so I took over until we can fill the position. I emailed our volunteer list, but only got 2 responses from volunteers currently willing to take meetings in. The committee discussed what to do and we decided to just do the best we can with what we have and try to get more folks involved.

While our Area didn't feel comfortable signing the Region 10 Business Associates agreement, discussion with the Mohr center Director came up with a compromise. Each volunteer will need to fill out a volunteer form, read the confidentiality agreement and sign a form stating they read the agreement and agree to abide by it. So, we're clear to start meetings there. However, our newly elected Mohr center Panel Leader was absent and sent no report. I had spoken with the Mohr center director and he hadn't heard from Kermit. So we've had no other progress in getting that meeting going.

The subcommittee members discussed the lull in volunteers both for committee members and panel members. It was agreed that asking members individually was more effective than putting out

announcements. We also liked the idea of an H&I service day to try and generate enthusiasm. We're unsure if that will need to be coordinated with special events or how exactly to do that, but it will be brought to Area for discussion.

## VRCC

The VRCC retreat was held 5/14/22-5/15/22 in Virginia Beach. I was unable to attend any of the workshops on Saturday due to an ECCNA host committee meeting in Richmond. I arrived early evening on Saturday. I was told by some of the other directors and VRCC executive committee that the Saturday workshops were a great team building experience. I was able to participate in a bingo fundraiser for the 40<sup>th</sup> AVCNA Saturday evening. The event raised \$605.

The VRCC treasurer was unable to attend the retreat due to an illness. The directors tabled the matter of whether to find a new bank account until she was present. The treasurer is also seeking a new accountant.

In an effort to cut some of the cost of the 40<sup>th</sup> AVCNA, the directors voted on giving the VRCC chair and vice chair some flexibility to renegotiate the contract with a plan or two for the directors to decide. The main focus will be switching from room-rental-rate only to a food-and-beverage-rate with free rooms. More will be revealed.

I made a motion to allow early bird registration for the next AVCNA to be open from one hour after the main speaker, in order to capture the Saturday crowd. Early bird registration would continue to be open on Sunday morning, as in the past. The motion also set the early bird registration to a flat \$20, removing the \$20/1 and \$30/2. The early bird registration is done this way for the ECCNA conventions.

I have been asked to find a new permanent location for the VRCC meetings in Charlottesville. I will continue the search process and if anybody knows of a location that might work, please let me know.

Bids are due for the 41st AVCNA at the July VRCC meeting; I haven't heard of any areas stepping up to host.
