Men's ACRJ had no meetings, as there were problems coordinating time/place and volunteers.

Both Women's ACRJ meetings took place last month; there were some very open inmates, and our message was well-received. Lauren H. reported difficulty finding volunteers; we are relying on the same small group of volunteers and not able to carry a diverse message. There are 2 meetings scheduled for this month; the 2nd meeting is at a later time and it's hoped that this might attract more volunteers. Regardless, we can really use more females to take the message of recovery to some inmates hungry for the message of recovery.

5 East had 3 of the scheduled 5 meetings take place; 2 were canceled due to sick volunteers. The attendance was 2, 3 and 1. The December schedule is full except for the 29th; only 1 volunteer has committed for January.

All three scheduled Boxwood meetings took place, with a big jamboree on Thanksgiving with 4 volunteers and 9 residents. Attendance continues to average from 7 to 9. There is good engagement in the meetings. December's schedule is full except for 12/15. See Erick H. if interested.

Erick H. retracted his resignation and committed to another year of service. Thanks Erick!

The Mohr Center meetings continue to go well. All 4 meetings took place as scheduled and were well-received. The December schedule is full.

Lauren H. reported interest in her home group for an H&I meeting at Fluvanna's Women's Prison, though it seems like a combination of in-person and zoom meetings would get more support.

We have vacancies for Chair and Secretary- though Will P. and I will continue to serve for the time being.

The VRCC met in Charlottesville on Sunday, November 20, 2022, at the Center @ Belvedere and via Zoom. The VRCC minutes haven't been sent out yet, so if I miss anything in this report, I will report it at the next ASC.

December 15th is the last day to register for AVCNA at the discounted rate. Part of the expenses of the convention is to guarantee a certain amount of hotel rooms to the hotel. 
