The Central Atlantic Region of NA held it's GSR Assembly on April 18th and the 202nd Regional Service Conference on April 19th via Zoom teleconference. There were enough Areas present to make quorum and conduct business.

Piedmont family,

As of March 30 we have received donations through PayPal of \$460.86 and those funds have been transferred to our credit union account. Additionally, the KISS group sent \$75.00 and anonymous donations of \$148.62. Almost all the PayPal money was credited to the donors' home groups. All these funds are included on the Treasurer's Report Spreadsheet, below.

The report from PayPal, which doesn't seem to be available yet, lists donors by name and amount, which I believe should remain anonymous. We don't give credit by name for money put in the basket. Does the ASC concur?
