During both the WSC and this webinar, my understanding was that each Zone would elect a member to be part of a workgroup to study this over the next two years of the current conference cycle. However, the August communication from the World Board proposes moving toward a three-year cycle until 2029 as a way of studying the effects of a three-year cycle. More will be revealed in the CP webinar this afternoon."
