Payment for my child's program is due on Monday of each current week if paying weekly and on the 1st if paying monthly. Tuition is payable according to the tuition schedule whether or not my child attends. All parents must add your bank account or credit/debit card information in Procare for tuition payments. If tuition is not paid by Friday, then I understand that my child cannot return to care the following Monday until paid.

Our program is open Monday through Friday from 7:30 am to 4:30 pm. If I am late picking up my child, a penalty of \$5 for the first five minutes and \$1 for each additional minute will be charged to the account per child.

In the event I choose to end my relationship with Next Generation Preschool and withdraw my child or change my child's schedule a 20- day notice will be given in writing.

Proper attendance tracking is imperative to the safety of the children enrolled. All parents are required to sign their children in and out each day. When a family fails to sign their child in or out, a \$5 penalty may be applied to your account for each occurrence.
