

#### **PAYMENTS AND CONDITIONS, Group Agrees to the Following:**

- 1. To provide its own leader and chaperones to set the rules and to supervise the behavior and welfare of the tour participants.
- 2. To have all payments and all required documents to American Classic Tours, Inc. as per the Payment & Deadlines Schedule on the following page.
- 3. Late payments will incur a \$100 fee. Payments and/or Rooming Lists received within 45 days of departure will incur an additional \$150 fee to cover late processing expenses.
- 4. Cancellation of this tour prior to 120 days of departure will be refunded in full, except for any nonrefundable supplier contracted fees and charges and the non-refundable booking deposit as specified in the Payments & Deadlines Schedule below.
- 5. Cancellation of this tour occurring within 120-46 days of departure will be subject to cancellation fees of 20% of the Tour Cost, the non-refundable booking deposit as specified in the Payments & Deadlines Schedule below and any non-refundable amounts paid to suppliers to confirm Group's reservations.
- 6. Cancellations occurring within 45 days of departure will receive no refunds.
- 7. To the Group Terms and Conditions attached hereto as Exhibit "A".
- 8. To the Tour Inclusions and Exclusions attached hereto as Exhibit "B".
- 9. Group understands that American Classic Tours, Inc. will require participants or their parent or guardian to agree in writing to its Participant Terms and Conditions attached hereto as Exhibit "C".

### **BINDING ARBITRATION:**
