Agnes J. Johnson Charter School (AJJCS) is committed to meaningfully engage and consult with the stakeholders of the community. As discussed in our LCAP Workshops, the biggest needs were summer learning opportunities and an intervention specialist to work with students who are academically underperforming. To discuss the ESSER III Plan, a townhall meeting was held on September 10, 2021. The plan was also discussed with School Site Council on October 15, 2021. Additionally, AJJCS posted the ESSER III plan on the website with a link to a feedback email. The administrative team reviewed and responded to the feedback emails. AJJCS conducted a survey about providing summer learning opportunities and an intervention specialist which received responses from parents of 45 students indicating the need for summer learning opportunities and an intervention specialist. Administration discussed the plan with the teachers and staff during professional development on October 18, 2021. The Board of Directors has been versed in the needs of the students and much discussion has taken place in regard to providing summer learning opportunities and an intervention specialist for our students focusing on reading, writing, and math. Administration consulted with the El Dorado Charter SELPA on October 22, 2021 as it relates to the Learning Loss Recovering Plan developed specifically for students with disabilities.

The ESSER III Plan was approved by the Board on October 25, 2021. The ESSER III Plan was submitted to the Humboldt County Office of Education on October 26, 2021.

As discussed in our LCAP Workshops, through the results of the parent meetings and surveys, it became evident what the needs were for AJJCS. This feedback was catalogued, and it takes into account the needs of our students to remediate reading, writing, and math skills. AJJCS is implementing the LCAP with specific attention to the actions and services that will remediate student learning loss and academically underperforming students. The ESSER III plan was developed on the basis of the additional needs for all students to include using the summer months and the need for an Intervention Specialist during the school months to remediate student skills and increase student achievement. The community is passionate about our students meeting and exceeding grade level academic standards. AJJCS reflected on the input received from the stakeholders and developed the ESSER III plan with this need in mind.

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 3 – Promising Evidence:** the effectiveness of the practices or programs is supported by one or more well-designed and well-implemented correlational studies (with statistical controls for selection bias).
  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Planning for, coordinating, and implementing activities during long-term closures, including providing meals to eligible students, providing technology for online learning to all students, providing guidance for carrying out requirements under

IDEA, and ensuring other educational services can continue to be provided consistent with all Federal, State, and local requirements;

- Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment;
- Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
- Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;
- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

**Note:** A definition of “underserved students” is provided in the Community Engagement section of the instructions.

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
