CO-ED SAND VOLLEYBALL RULES AND ELIGIBILITY

LOCATION & TIME: Games will be played at the Grainfield City Park, starting at 9:00 am on Sunday, May 25, 2025. The bracket will be posted by Friday, May 23, 2025.

ELIGIBILITY: All players on your team must be at least a Freshman in High School for the incoming 2025-26 school year. Players may play on only one team.

ROSTER: You may have up to eight (8) people on your roster.

NET HEIGHT: All games will play on a net height of 7'9".

THE GAME: Using rally scoring, best two (2) of three (3) games will determine the match. First 2 games to 15, must win by 2 points. If a third game is needed, it will be to 10 points, must win by 2 points. Teams are allowed one (1) time-out per game. Time-outs last one (1) minute in length.

SUBSTITUTION: Each team will be allowed unlimited substitutions. Teams can either substitute by NFHS rules, or a new player may enter each time the team rotates. The new player must enter at the same spot in the rotation, and a new player must rotate in each time.

CO-ED RULES: Standard Co-Ed rules will apply to this tournament. At no point should there be more males than females on the court. There can be the same amount of males and females, or more females than males, but never more males than females. A female **MUST** touch the volleyball before it goes over the net (a 2-male-touch only is not allowed).

FENCE: If the ball hits the fence at any point, the play is over and a rally point will be awarded to the appropriate team.

CEILING BALL: There is no ceiling!

OFFICIALS: One (1) referee will be used for all games. All other questions regarding a rule by an official shall be settled on the spot by the official and supervisor if available. Judgement calls are not open to discussion.

LINE JUDGES: Each team **MUST** provide a line judge during non-play games.

FORFEIT TIME: A team will have five (5) minutes before their forfeit their game. The referee's watch is the official watch.

FOOD PROHIBITED: Food is not permitted inside the playing area.

UNSPORTSMANLIKE CONDUCT: Unsportsmanlike conduct will not be tolerated. We want everyone to have fun, but please be respectful of others trying to enjoy the event.

CALLS: Officials can't see everything on the court. Please be honest and call your own fouls.
