Our Finance Programs

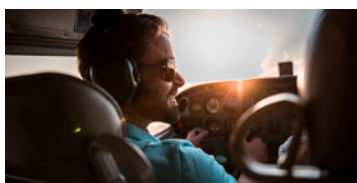

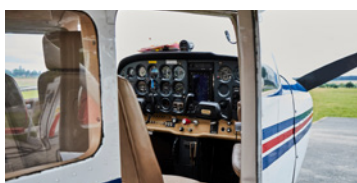


Our Customers.

- ▶ *Drop out when costs start building up.*

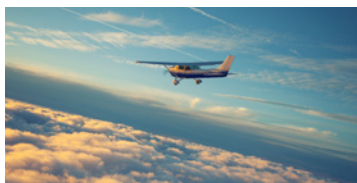
Our programs allow these students to take lessons on a regular schedule while avoiding the shock to their checkbook or their credit card balance. Flight Training Finance customers include those pursuing private or commercial certificates as well as those adding advanced ratings.



Our Current Programs . . .

One to Five Flight Lessons Per Week

Our current flight training finance programs are designed for Students that take *one* to *five* flight lessons per week.



Our Future Programs . . .

Full Time or Accelerated Training

At the present time, Flight Training Finance does not offer programs for Students enrolled in full time or accelerated flight training programs. If your school needs financing for full-time Students, please ask us to put you on our priority notification list for our future program offerings.

Our Finance Programs (cont.)

Down Payment.

Our standard down payment is \$250, which is paid to, and retained by, the flight school. Some Students may prefer to pay a larger down payment. This is always acceptable and desirable.

For the Student, the down payment signifies a closing of the transaction, and serves to decrease dropouts and terminations. For the school, the down payment represents payment for the initial training under the program. Therefore, initial training, up to the down payment amount, is not reimbursed to the school by Flight Training Finance.

Interest Rates.

Our current interest rates range from 12% to 18%, depending on the income, debt ratio and credit history qualifications of the applicant. Generally, Flight Training Finance interest rates will correspond to the rates charged on credit cards used by individuals with income, debt ratio and credit history similar to the applicant. Our programs, however, leave those credit card lines undisturbed and fully available for everyday use.

The examples on our payment chart reflect payment amounts at the maximum 18% rate. Applicants qualifying for a lower rate will have payments lower than those shown.

Program Size.

How much can be financed? Flight Training Finance has no fixed maximum program size eligible for financing.

Most of our customers are fairly new Students pursuing a private certificate, or taking the next step -- an instrument rating. Some, however, are pursuing commercial certificates or advanced ratings. Students that need a significant amount of commercial training usually find it easier to finance just one or two certificates or ratings at a time. Making monthly payments on their initial account with us will partially reduce their balance before more financing is needed -- avoiding the need to qualify for financing of the TOTAL training cost. Also, by establishing an on-time payment record for their initial training, the Student creates a solid credit rating with Flight Training Finance -- a pre-requisite to further approvals.

An average Flight Training Finance contract is \$13,500. After a Student has achieved his or her initial goal, he or she can apply to finance additional training, with either a separate finance transaction or by combining the cost of new training with an existing account. Like the Student's first application, additional financing approvals will be based on the Student's income, debt ratio and credit record with Flight Training Finance and other creditors.

The yellow sheet . . .

The yellow sheet included in this section shows examples of our standard payment terms. Flight Training Finance is happy to consider any “custom” terms you or your Student may request, but most transactions are based on our standard terms.

For illustration purposes, the examples show program cost in \$100 increments. However, any program cost may be financed. To determine monthly payment amounts for precise program amounts not in \$100 increments, you can approximate the monthly payment amounts from the attached examples. Or, call our office anytime for an exact quote.

NOTE: The payment examples shown on the yellow sheet are computed at a maximum interest rate of 18%. Applicants that qualify for our Preferred Interest Rates (see below) will have lower payments.

How to read the yellow sheet.

The number of monthly payments is directly linked to the number of lessons per week. For example, if a Student chooses to take three lessons per week he could spread his training cost over as many as 48 monthly payments.

The number of monthly payments (48) then determines the monthly payment amount (\$404) depending on the total cost of the flight training program (\$14,000) that best meets the individual needs of the Student.

Number of Most Common Monthly Payments.

Our programs have been designed so Students following the most common schedule of two to three lessons per week will usually have monthly payments of \$336.48 to \$389.22 per month. This is based on a program for \$13,500. Some Students may prefer to repay over a shorter term (fewer payments) than our standard terms. This is always acceptable and desirable.

When to complete this form.

Some schools like to learn if a Student is approved for financing before discussing training. These schools start out by asking the Student to complete a finance application. However, you may wish to sit down with a prospective Student and fill out the Prepaid Flight Training Agreement in your very first meeting. In many cases, this practice creates a higher degree of interest and a greater Student commitment. Long term, it leads to lower dropout rates. A customer that wants to “think about it” can take the completed form home with him.

Guaranteed. The instruction rate will not increase for 6 months from the date of this agreement.
 Not Guaranteed. All program instructor fees will be assessed at the prevailing advance purchase rate in effect at the time training takes place. If rates change the number of purchased hours will differ from the above.

All program fees may be fully earned (non-refundable) when the anticipated certificate or rating is attained

The “Price and Performance Guarantees” are entirely optional. You may not want to guarantee anything. This section, however, gives you the opportunity to apply some of the creative selling trends emerging in the industry. Tailoring your flight training packages to individual Students will **ATTRACT NEW BUSINESS** and **ENHANCE OVERALL PROFITABILITY**. See the Marketing Tips at the end of this section.

The Prepaid Flight Training Agreement (cont.)

You may wish to point out these provisions to the Student BEFORE HE OR SHE SIGNS:

- **All program fees are fully earned** by the school (no refund is due the Student) when the anticipated certificate or rating is achieved. *This provision is for the exclusive benefit of the school, and of course may be waived by the school.*
- **The Student may terminate** the program at any time and receive a refund (credited to his finance account) of 90% of the unused/undelivered flight training services. The provision for 10% “liquidated damages” establishes a financial incentive for Students to finish the program they started. Any amount forfeited by dropping out goes to the flight school; *the flight school may waive this “penalty.”*
- **The school may terminate the flight training program** for the reasons listed in the agreement. Should this occur, the Student receives a refund (or credit) of 100% of the unused/undelivered flight training services.

Additional Terms and Conditions of this Agreement

Sale and purchase of Flight Training Program.

The Flight School agrees to sell and the Student and the Co-Buyer, if any (herein collectively referred to as “Student”) agree(s) to purchase the Prepaid Flight Training Program (the “Program”) described herein, subject to the terms and conditions set forth on the front (page 1) and the back (page 2) of this Agreement (the “Agreement”). The Flight School will provide the Program services and materials to the Student following the effective date of this Agreement at the address stated herein at times mutually agreed from time to time by the Student and Flight School. The Flight School may substitute instructors or modify training materials at its discretion.

Conditions for this agreement to become effective.

Certain portions of this Agreement may be completed for discussion and information purposes prior to its effective date. This Agreement shall not be effective until (a) it has been executed by both the Student and an authorized officer of the Flight School and (b) the payment obligations of the Student have been discharged in a manner satisfactory to the Flight School. *For instance, if the student's payment obligations are discharged only after the Student's finance application has been approved by the finance company, any required down payment has been received by the Flight School, and the related finance agreement has been fully executed and accepted by the Student, the Flight School, and the finance company.*

Price and performance guarantees.

The Flight School will provide the additional Aircraft Rental Hours, additional Flight Instruction Hours, guaranteed Aircraft Rental Rates and guaranteed Instructor Flight/Briefing Rates, if any, as stated on page 1 of this Agreement in the section “Price and Performance Guarantees Included in this Flight Training Program”. The Flight School's obligation to provide guaranteed services and/or rates terminates when the Student attains the anticipated Certificate and/or Rating or following the delivery by the Flight School of the guaranteed hours and/or rates, whichever occurs earlier.

All fees earned when certificate / rating is attained.

Flight Training Finance will fund the school for a Student's flight training that occurs *before* the flight school receives a Notice of Suspension, even if the Training Records are received after the suspension becomes effective.

Notices (cont.)

Termination Notices

A Termination Notice indicates that the flight training program is being cancelled.

As provided by the Prepaid Flight Training Agreement, Termination Notices may be sent by the Student at any time. The flight school or Flight Training Finance may send a Termination Notice under certain circumstances. No special form is required for a termination notice by a Student or the school, but the notice must be in writing.

When a Notice of Termination is issued, Flight Training Finance will credit the Student's account for the refund due for unused/undelivered flight training, as provided by the terms of the Prepaid Flight Training Agreement and the Retail Installment Contract. Normally, a flight training program will not be reinstated after it is terminated.

Flight Training Agreement **Notice of Reinstatement**

A Notice of Reinstatement will be emailed to the flight school and student anytime a suspension is being lifted or a termination is being reversed.

A reinstatement can only occur with a written notice received via email.
