# **Privacy Policy**

This Privacy Policy ("Policy") applies to www.wayfindhawaii.com, and Wayfind Hawaii LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include www.wayfindhawaii.com and www.wayfindhawaii. The Company's website is a tour booking site. ## **Collection of your Personal Information**

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

## **Sharing Information with Third Parties**
