Re: Dare County's Opposition to United Nations Agenda 21

We are writing to inform you that the Dare County Board of Commissioners passed a Resolution Reaffirming Opposition of United Nations Agenda 21 just a month ago. Our group feels extremely grateful that our local BOC wished to revisit this material in order to expose the destructive intent of Agenda 21.

We feel this resolution addresses the most critical issue in the modern-day history of Dare County. United Nations Agenda 21, also known as Agenda 2030 and The Great Reset, seeks to infiltrate America from within by declaring national sovereignty "a social injustice" and states that there should be a redistribution of wealth so that Americans should not own private property, homes, cars or farms...or make individual health and travel choices. In accordance with the World Economic Forum's website and the book Covid 19: The Great Reset by founders Klaus Schwab & Thierry Malleret, this plan is currently being implemented under the guise of climate change, "sustainable development" and the Covid-19 pandemic.
