ATHLETIC WAIVER AND RELEASE OF LIABILITY

In consideration of my son/daughter/ward (child) _____ being allowed to participate in any way in the practices and games of the team, THE FORCE, and related events, trips and activities, as his/her parent or legal guardian, I:

- Agree that prior to my son/daughter/ward participating in any practice or game, I will inspect the facilities and equipment to be used, and if I believe anything is unsafe, I will immediately advise the teams' coach of such condition(s) and refuse for my son/daughter/ward to participate.
- Acknowledge and fully understand that my son/daughter/ward will be engaging in activities that include the risk of serious injury, including permanent disability and death, and severe social and economic losses which might result, not only from his/her own actions, inactions or negligence, but the actions, inactions or negligence of others, including his/her coaches, the rule of play, or the condition of the premises or of any equipment or facilities used. Further, that there may be risk not known to The Force Basketball, Inc. the team, THE FORCE, its coaches or The Force Board of directors, or not reasonably foreseeable at this time by those aforementioned entities or their representatives.
- Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
- Release, waive, discharge and convent not to sue The Force Basketball, Inc., its affiliated clubs and teams, their respective administrators, officers and coaches: directors, agents, representatives or any employee or volunteer of the organization: other participants, sponsoring entities, tournament sponsors, representatives, advertisers; and if applicable, owners and leasers of premises used to conduct any event, including, but not limited to practices and games, all of which are hereinafter referred to as "Releasee(s)", from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property caused or alleged to be caused in whole or in part by the negligence of the releasee(s) or otherwise.

THE UNDERSIGNED HAS READ THE ABOVE WAIVER AND RELEASE, UNDERSTANDS THAT HE/SHE HAS GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAS SIGNED IT VOLUNTARILY.
