The Event: The Atlanta Fetish Content Festival

EVENT DESCRIPTION:

KinkEd Atlanta, LLC. (K.A.) is organizing the third annual Fetish Content Festival on Saturday, April 17, 2027. This event showcases fetish, kink, and BDSM artists and creators via an art gallery and live film screening. Performance artists and burlesque performers will be providing additional entertainment. The event highlights nationally known special guests and is expected to draw approximately 150 attendees. We are pleased to include the addition of industry- and fetish-themed workshops and kink/BDSM vendors to this year's event.

ENTITLEMENTS:

K.A. will provide you ("Vendor") with the following:

- Designated Vendor Space in the outdoor courtyard, approximately 10'x10"
- One (1) 6ft. patio table
- Two (2) patio chairs
- Marketing and cross-promotion on websites and social media
- Live on-site shout-outs by the event MC
- Exposure via live streaming during the event
- "Roll over" video footage of vendor wares and booth setup for promotional use
- Badge/pass for one person. Discounted badge for a plus-one (to cover meal)
- Invitation to the production dinner

Vendors are encouraged to provide their own tents, tables, displays, and other booth needs, as these supplies are limited onsite. Individual requests for additional tables, chairs, etc. are on a first-come-first-serve basis. Electricity is not provided without prior arrangement with the venue. In the event of rain, every effort will be made to move vendors under the outdoor awning and/or assist with pop-up tents to provide coverage from the elements.

MARKET VENDOR REQUIREMENTS & DETAILS

Market Vendors must fit the overall theme of the event. Your crafts must be Kink and fetish-friendly and include adult and alternative lifestyle themes such as leather, latex, BDSM, etc.

All sale items, if not new, MUST be clean and in good condition, with all reasonable effort to provide buyers with a quality product at a fair market value.

Businesses must handle their own permits, tax forms, liability insurance, etc.

Vendors are responsible for their own transportation, load-in, load-out, and any damages to goods as a result of said movement.

LIMITED AVAILABILITY

There is very limited availability for Market Vendors, so early application submission is strongly recommended.

RENTAL SPACE FEES

The applicable fees to be paid by “Vendor” to “KA” for market space and entry into the Fetish Content Festival are as follows:

\$100 per Vendor/Business

\$35 for one additional badge

The applicable rental space fee must be submitted to Madam Jess (Director, KinkEd Atlanta) via Check, Money Order, CashApp or Venmo. A card payment link may be issued by request (all credit card processing incurs a 4% fee). All agreements, applications, and payments are due to Madam Jess by February 28, 2027.

CANCELATION BY VENDOR

As occupancy of the event space is the essence of the agreement, no refunds shall be made in connection with any rental space fee after the acceptance of said fee by Madam Jess (or KinkEd Atlanta), except as otherwise provided in the agreement.

FORCE MAJEURE

In case of cancellation of the event or unavailability of the event space for specified use due to war, governmental action or order, act of God including, but not limited to, weather, fire, strike, labor disputes, or any other cause beyond the organizers’ control, this agreement shall terminate, and the “Vendor” shall be entitled to the return of the rental space fee for the event space less an amount equal to the total costs and expenses incurred by the organizers in connection with the preparation of “Vendor’s” event space. In case of damage to the “Vendor” through war, governmental action or order, act of God, including, but not limited to, weather fire, strike, labor disputes, or any other cause beyond the organizer’s control, the “Vendor” expressly waives all liability

and completely releases and holds harmless the organizer of and from any and all claims for damage to person and property and agrees that the organizer shall have no liability whatsoever.

SALE OF PRODUCT

“Vendors” are responsible for all their transactions, sales taxes, and personal cash needs. “KA” holds no liability/responsibility for any transaction disputes with “Vendors.” “KA” is additionally not responsible for theft, damage, or loss of goods over the course of the event.

BEVERAGES

“Vendors” are not allowed to sell alcoholic beverages. “Vendor” may not give away beverages as part of any offer to its customers.

RULES AND REGULATIONS

Should “Vendor” fail to strictly adhere to and follow the Rules and Regulations set by KinkEd Atlanta or Atlanta Utility Works, then “Vendor” shall be in default under this agreement and “KA” may immediately terminate this agreement upon notice to “Vendor.” In the event of a default by the “Vendor,” the “Vendor” shall forfeit as liquidated damages the rental space fee, regardless of whether or not “KA” enters into a further lease for the event space involved. Said damages are agreed to, and in no way constitute a penalty, but rather a reasonable estimate of “KA’s” damages which are incalculable with any degree of certainty.

SPACE ASSIGNMENTS

KinkEd Atlanta has complete control of event diagrams and space assignment. “KA” reserves the right to make modifications to event diagrams which are believed to be accurate but only warranted to be approximate. Further, “KA” reserves the right to assign space(s) in such a manner as it deems appropriate in its sole and absolute discretion, notwithstanding the foregoing.

ASSIGNMENT, SUBLETTING OF EVENT SPACE

No “Vendor” shall assign, sublet, or share the event space allotted to such “Vendor” without the knowledge and prior consent of KinkEd Atlanta. No products, parts, accessories or other goods, souvenirs, catalogs, etc. bearing names or other forms of advertising other than that of the Vendor may be displayed. No firm or organization not assigned an event space shall be permitted to solicit business within the event areas.

USE OF SPACE

KinkEd Atlanta reserves the right to restrict “Vendor” exhibits which, because of safety, noise, method of operation, materials or display, in the opinion of “KA”, may detract from the general character of the event as a whole. Accordingly, “KA” may, at its sole discretion, prohibit such exhibits from being kept or utilized by “Vendor” in or around the event area, in which event “Vendor” shall immediately remove such exhibits as directed by “KA.” KinkEd Atlanta reserves the right to prohibit any equipment that is deemed unsafe or appears to be unreasonable in “KA’s” judgment. All equipment and heavy machinery must be cleared and approved in writing and in advance by KinkEd Atlanta and Atlanta Utility Works staff. All demonstrations or promotional activities must be confined within the limits of the Vendor Event Space. Demonstrations or activities that cause annoyance to neighboring Vendors such as flashing lights or noise or result in obstruction of walk space or prevent ready access to a nearby booth will not be permitted. Stakes, spikes, or other pointed objects may not be driven into the ground.

COMPLIANCE & ORDINANCES

To ensure the safety of all participants, fire regulations, health and all other applicable ordinances must be strictly observed. In addition, all requirements imposed upon Vendor by KA must be strictly complied with by “Vendor.” Any “Vendor” found selling contaminated, unfit, or illegal items will be suspended from selling at the event and may be asked to leave immediately without refund of vendor fee. All “Vendor” items of an overt sexual nature may only be displayed/sold out of view of the sidewalk/general public. Smoking is discouraged but allowed no less than 30’ away from event space. Unlawful drug/alcohol possession will not be tolerated. Sexual solicitation is prohibited, and public nudity/decency laws are mandatory for all outdoor activities.

LIABILITY & INSURANCE

In no event shall KinkEd Atlanta, Atlanta Utility Works, nor their representatives, contractors, or corporate sponsors of the event be responsible for any injury, loss, or damage that may occur to the “Vendor’s” employees, agents, contractors, representatives, or property from any cause whatsoever. It is the “Vendor’s” responsibility to protect machinery, perishables, and exhibits so that no injury will result to the public visitors, guests, or persons, or property. If property does not appear to be properly maintained, it will be promptly withdrawn from the event site. All property of the “Vendor,” including perishables, is understood to remain in “Vendor’s” care, custody, and control in transit to, from, or within the confines of the event area subject to the Rules and Regulations. The “Vendors,” on signing the agreement, expressly release, hold, keep, save harmless, and indemnify the foregoing persons and entities, named organizations and committees, and individuals from and against all claims for such a loss, damage, or injury. “Vendors” must carry appropriate insurance through such carriers and containing such limits, terms and conditions as KinkEd Atlanta may require

and shall deliver to “KA” copies of all such policies of insurance and/or certificates thereof as “KA” may request.

VENDOR HEREBY AGREES TO AND UNDERSTANDS THE CONTAGIOUS NATURE OF COVID-19 AND VOLUNTARILY ASSUMES THE RISK(S) OF PARTICIPATION IN THE PROGRAMS, SERVICES, EVENTS OR FACILITIES OPERATED BY KINKED ATLANTA WHICH INCLUDE THE RISK OF BECOMING EXPOSED TO OR INFECTED BY COVID-19.

INSTALLATION OF EXHIBITS

Details for Load-in:

HOURS: 2:00 PM to 5:00 PM on Saturday, April 17, 2027.

Vendor check-in is first-come, first-served, beginning no earlier than 2:00 PM.

Please check in before unloading merchandise.

All Vendors MUST BE completely set up by 7:00 PM on Saturday, April 17, 2027. Failure to set up within the given time frame may result in “Vendor” losing its event space at the event.

The official hours of operation will be Saturday, April 17, 2027, from 6:00 PM to 11 PM at Atlanta Utility Works, 2903 RN Martini Street, East Point, GA 30344.

Vendors are welcome to make sales earlier than 6 pm if warranted.

Details for Load-out:

HOURS: Saturday, April 17, 2027 at 11:30 PM to Sunday, April 18, 2027 at 2:30 AM.

“Vendor” may request special approval from KinkEd Atlanta to be granted by “KA” at its sole discretion to close down early only if “Vendor” has completely sold out of merchandise or materials.

Load out with a vehicle may only begin when “KA” gives “Vendor” express permission.

Any items unclaimed by the “Vendor” as of 3:00 AM following the event shall become the property of “KA.”

“Vendors” are responsible for leaving their area free of all litter and debris.

AMENDMENTS

KinkEd Atlanta, LLC. reserves the right to make changes to these rules and regulations contained in the Agreement as “KA” sees fit. “Vendor” hereby agrees that “Vendor” and its employees, agents, and representatives will abide by the terms provided in this Agreement and any additions and/or amendments, which “KA” shall make to this Agreement, and that it will remain a “Vendor,” for purposes of this Agreement, as long as it maintains strict compliance with the terms of this Agreement, understanding that said terms have been formulated and adopted in the best interest and for the protection of the “Vendors” collectively as well as KinkEd Atlanta and its representatives. In any interpretation of this Agreement, “KA” reserves the right to accept or reject any reservation for any reason whatsoever determined to be in the best interest of “KA.”

The Rental Space Fee will be refunded to the "Vendor" should the Application be initially rejected by KinkEd Atlanta. Vendor's payment in full must accompany this Agreement and the Application. Once an Application and Agreement are accepted by "KA," "Vendor" will be notified with a confirmed receipt of payment and updated online "Vendor" listings.
