Speak Up by reporting suspicious activity and sharing information.

Support the groups that help survivors heal and rebuild their lives.

SEE SOMETHING, SAY SOMETHING: END HUMAN TRAFFICKING.

CONNECTING THE DOTS:

Recognizing how human trafficking intersects with other forms of violence and social issues (like domestic violence, poverty, mental health, and online exploitation).

STRENGTHENING COMMUNITIES:

Building protective factors and resilience at the community level to reduce vulnerabilities.

PREVENTING TRAFFICKING:

Focusing efforts upstream to stop the crime before it happens.

WHAT IS HUMAN TRAFFICKING?

HUMAN TRAFFICKING....

Involves the use of force, fraud, or coercion to obtain some type of labor or commerical sex act.

IT CAN HAPPEN IN ANY COMMUNITY AND VICTIMS CAN BE ANY AGE, RACE, GENDER, OR NATIONALITY.

HOW?

Traffickers might lure victims into trafficking situations by:

- Violence
- Manipulation
- False promises of well-paying jobs
- Romantic relationships

TWO MAIN TYPES: HUMAN TRAFFICKING



SEX TRAFFICKING

People in sex trafficking situations almost always know and even trust or love their traffickers.

Traffickers come from all genders, races, ethnicities and walks of life.

Anyone can be trafficked, but some people are far more vulnerable than others.

People may face threats against them or their families or violence if they complain or try to leave.

LABOR TRAFFICKING

When pay or working conditions are abusive and the worker cannot quit or complain.

Kidnapping or physical force are rarely part of how labor trafficking situations begin.

Traffickers can be business owners, bosses or other workers.

Anyone can be victimized by a labor trafficker.

The most common ways traffickers control victims are through threats or economic abuse.

2024 Statistics on Human Trafficking in the U.S.

- In 2024, it is estimated that approximately **24,000 individuals** fell victim to human trafficking within the United States.
- **About 75% of identified victims were female.**
- **40%** of human trafficking victims in 2024 were **minors**.
- The National Human Trafficking Hotline received approximately **2,000 reports** related to trafficking cases in 2024.
- Law Enforcement efforts in 2024 led to approximately **10,000 arrests** related to human trafficking.
- Human trafficking generates an **estimated \$150 billion globally** each year.
