Trucking company settles in fatal rear-end crash

Graduate student intern lived for 17 hours after accident

\$974,689 settlement

The family of a 23-year-old man killed when his car was rear-ended by a tractor-trailer settled its wrongful death lawsuit against the trucking company and its driver.

The parties settled during mediation with an insurance policy limit of \$1 million. Of that amount, \$974,689 went to Daniel Hartwig's parents with the balance to the driver of a separate vehicle also injured in the crash. The other driver settled separately with the trucking firm.

A light rain was falling as graduate student Hartwig drove to an internship job on the morning of July 1, 2004.

A tractor-trailer owned by Texas International Express struck Hartwig's vehicle from behind when Hartwig was stopped at a traffic signal on U.S. Highway 63 outside Jefferson City. Hartwig was hospitalized and survived for 17 hours.

According to plaintiffs' attorney Steven Kuenzel, the discovery process revealed that the truck driver had exceeded his driving hours limit in violation of U.S. Department of Transportation regulations. It was also discovered that the driver had allegedly altered his log book.

The truck driver did not take a postincident alcohol test and Texas International Express did not submit documentation as to why he was not tested, Kuenzel said. Defense lawyer Daniel Rabbitt said the situation was an unfortunate one that was good to have settled.
