GIFTED AND TALENTED STUDENT PROGRAM

In alignment with LCAP Goal 2, the Board of Education believes that all students deserve an education that challenges them to reach their full potential. The district shall provide gifted and talented students with opportunities for learning commensurate with their particular abilities and talents.

The Superintendent or designee shall identify students for the district's gifted and talented education (GATE) program on the basis of demonstrated or potential intellectual abilities, consistently high achievement levels, and academic ability.

The Superintendent or designee shall provide all eligible students, including economically disadvantaged students, English learners, students with exceptional needs, and students of varying cultural backgrounds, with full opportunities to participate in the GATE program.

The district's GATE program shall be designed to provide articulated learning experiences across subjects and grade levels and shall meet or exceed state academic content standards and curriculum frameworks.

Educational opportunities in the district's GATE program may include:

- 1. Seminar classes which are designed to meet specific academic needs of gifted and talented students and are appropriately differentiated from other classes in the same subjects at the school. Seminar class is comprised of 50 percent or more students identified as GATE seminar with the remaining students identified as GATE cluster.
- 2. Cluster groupings, in which students are grouped within a regular classroom setting and receive appropriately differentiated activities from the regular classroom teacher. Cluster classes are comprised of 25 percent or more students identified as GATE cluster with the remaining students reflecting the school's population.

3. Acceleration, in which students are placed in grade levels or classes more advanced than those of their chronological age group and are provided instruction outside the regular classroom in order to facilitate their advanced work, as determined by the GATE Team and site administrator.

In addition, the district's program shall support the social and emotional development of GATE students in order to promote student engagement in school.

Staff development shall be provided as needed to support teachers in understanding the unique learning styles and abilities of gifted and talented students and in developing appropriate instructional strategies.
