- the building air conditioning and safety doors, new lockers are complete
- Aug. 20 there is an adaptive school training
- K-5 related arts schedule will move from a 6 day to a 5 day schedule
- middle school: an "enrichment class" will be removed and add more time to language arts and math classes, this changes the schedule from 8 period to a 7 period day
- the budget was reviewed, we have purchased workbooks for next school year, as this year's are already paid for. PRT is focusing this year on funding for renewing IXL for the next 3 years.
- we have filled all 425 spots
- there is an additional special education assistant, district funded, that was hired - Monique Crowder Johnson
- there's a district funded special education teacher - Erin Olson
- Rick plans to have a meeting for parents at the new high school to see where CKCS will be located.
