V. Board topics

A. Dialogue iPad usage – presentation by Amy Argobash and Sarah Urban

Amy, Sarah, and Dan reviewed the internet filters that are used on school technology. There is a Children's Internet Protection Act that the federal government mandates that we use software to block access to inappropriate things. VASD uses Securly which is a cloud based filtering system that allows protection when iPads are brought home.

Games are now being filtered, this is new this school year. There is embedded content that shows up on Securly, which is why you might see certain sites show up even when children aren't on the actual site.

Students don't have access to the app store. There is a self service app that they can load approved apps onto their device. Teachers gave information on how technology will be used in his or her classroom at back to school night.

CKCS will start to use Seesaw, which is a personalized learning software, for K-5. Grades 6-8 use Xellow; this will be rolling out in the next few weeks.

VASD is using Common Sense Media digital citizenship curriculum. Emails have been sent to families with the resources; these will continue to be sent out monthly. This helps parents access resources that the teachers are using in the classroom.

Parents can look under settings if they want to see how much time their child is on the iPad.

B. Discuss CKCS Contract Draft 5th Renewal (Linda)

PASS met with Dean Gorrell today. GC reviewed the contract and the changes that have been suggested. Nov. 8 will be the presentation to the Curriculum, Instruction & Assessment Committee with the district. Dec. 2nd will be the first presentation to the school board, Dec. 16th for approval and process.

Erin Marriott motioned to approve the CKCS contract with VASD, Charles Gleason seconded, passed unanimously.

C. Discuss Curriculum review process (Nicole) Nicole created a curriculum review process as a standard that can be used for consistency from year to year. Anyone can be on the curriculum committee, now known as the Curriculum Standards and Assessment Committee, which is a subcommittee of GC. Nicole will add verbiage that we are keeping in mind all students, including students with special needs. She will email the updated document and this will be brought to the Nov meeting for approval.
