
The collaboration between My Right To Hear and SAMS in 2022 led to the establishment of the first cochlear implant program in North Syria with complete domiciliation of the services, serving a population of more than 5 million people.

During the first phase of the program, 13 children with severe hearing loss were treated successfully with cochlear implants, completed the comprehensive rehabilitation program, and are now able to hear and talk for the first time.

achievements

During 2022, a total of **103 children** with severe hearing loss where successfully treated and were able to hear and talk, go to school, and participate in normal activities for children their age. Those include:

- Palestine 90 children
- North Syria 13 children
