The meeting was called to order by Williams at 10:05 am.

- 1. There were no prior meeting minutes.
- 2. Meeting Objectives:
  - a. Discuss what the community engagement task force is for
  - b. Discussion on the open Albion EDC Board seats
  - c. Discuss what the community needs from the Economic Development Corporation
- 3. Introductions were made by all members of the group. Everyone described who they were and what they would like to bring to the Community Engagement Task Force.
- 4. Discussion was had about the EDC open board seats. Virgie explained the process of how a community member could obtain a board seat, noted residency in Albion is not required, and noted a strong interest in the betterment of Albion is an important characteristic of a board member.
- 5. Linda Lanoue asked about the time commitments of an EDC board member 2 hours a month for board meetings; an hour or 2 a month for committee work. An additional couple of hours a month for Executive/Officer duties.
- 6. Discussion was had about the Austin Avenue Corridor
  - a. Harry Bonner Jr. Suggested a community survey to gauge what the community would like to see in that area.
    - i. Would like to see restaurants. Theaters, community centers
    - ii. Recalls 'The Corner' as being central to the neighborhood.
  - b. Linda LaNoue spoke of making sure we focus on sustainability,
    - i. Pop-up Activations, Theater building sets to pay homage to what that area once was, bringing tourism and fundraising
  - c. Tramaine Williams asked if the spaces available in the corridor were privately owned
    - i. Virgie answered yes and we can work with private owners to assist in finding funding

- d. Council member Williams would like to see the area a cultural hub as this area is the cornerstone of the historical community.
  - i. He wants to see that the owners of the current buildings are supported and not bought out.
  - ii. Reinvest into McAuliffe park, T-ball field, daylife, nightlife, hands on grocery store similar to Horrocks.
- e. Virgie then explained (CIA) Corridor Improvement Authority and a TIFA that can be used to bring in new developments.
- f. Council member Williams expressed interest in being on a board to expand the opportunity zone or creating a new opportunity zone.
- g. We then discussed next meeting agenda
  - i. Lisa Houze motivational speaker author of Candy Girl Mentality
  - ii. What groups can help explore some of these ideals that were brought up today
  - iii. Discuss Pastor Amos' 5-Point plan on homelessness in our city
  - iv. How can the community interact with Harrington School

- b. Virgie to continue to socialize and investigate the CIA process.
