## **COMPLETED CARBON REDUCTION INITIATIVES**

The following environmental management measures and projects have been completed since the September 2024 baseline.

#### **Business Travel:**

Those undertaking business travel will be for the purposes of delivering training or providing consultancy services. We encourage those undertaking travel for business purposes to utilise public transport, such as trains, tubes and buses.

We also carry out video calls with clients to reduce the emissions associated with business travel.

As a small company, with Associates working across the country, we do not have an office. We also consider the location of any services we deliver to identify the Associate with the required skills who resides closest to the work being undertaken.

We do not have any direct employees, other than our director. Our services our provided by Associates. This means we have no employees commuting to offices.

# Waste:

Consilium Training and Support Ltd operates a paperless policy which means that we do not print paper unnecessarily. The processes we undertake are electronic in order to reduce paper usage. Any paper documents we produce are for the purposes of delivering in person training. Wherever possible we ensure that any documents produced for delegates are provided electronically to reduce printing and paper usage.

In the limited circumstances where paper is used, we ensure that this is shredded and recycled when no longer needed.

#### Heating:

We ensure that we do not use heating unnecessarily at our remote working locations. We do not operate from an office.

# Recycling:

Consilium Training and Support Ltd follows the waste hierarchy. We produce limited waste due to our processes being electronic. Any waste produced, of which is minimal, is recycled.

#### **FUTURE CARBON REDUCTION INITIATIVES**

In the future Consilium Training and Support Ltd intends to implement the following further measures:

- Mandatory use of public transport or electric cars for business travel.
- Reviewing the electronic equipment that we utilise to ensure that it is the most carbon efficient.
- Encouraging carbon reduction activities within our Associates homes.
- Community and volunteering days for carbon reduction activities, such as litter picking and planting of trees.
- Undertaking carbon reduction training/e-learning.
- Communicate sustainability efforts to clients and partners.
