- Amount of state and local income or sales tax paid (other than wage withholding
- Invoice showing amount of vehicle sales tax paid and / or personal tax on vehicles

### **K-12 EDUCATOR EXPENSES**

- Receipts for classroom expenses
- (for educators in grades K-12)

### **RETIREMENT & OTHER** SAVINGS

- Form 5498-SA showing HSA contributions

### FEDERALLY DECLARED DISASTER

- City/County resided, worked or property in
- Records to support property losses (appraisal, clean-up cost, etc
- Records of rebuilding/repair costs
- Insurance reimbursements/claims to be paid
