We, EB Leiby Farm, wish to provide you with fresh, local, seasonal food and you, the member, wish to receive a portion of our harvest. This agreement outlines our shared commitments to that relationship.

Community Supported Agriculture (CSA) is a relationship between our farm and you as a customer. Rather than simply purchasing food, our customers become “members” of this farm who receive a portion of the farm’s harvest.

Our CSA this year will run for your choice of either 10 or 15 weeks. It will start sometime in July, the start date is based upon the produce being ready, we typically plant to have produce by the beginning of July, however the weather can greatly impact that. You will receive a box of produce each week based upon your share size. Variety and quantity will vary from week to week.

We promise to do our best to provide you with a bountiful share each week. The quantity of produce, however, may vary from week to week due to extreme weather, insects, or other production factors despite our best efforts. By joining the CSA, you are agreeing to share the risk of crop failure with us and other members. If only a small portion of crops fail, we will compensate for the failed crops by filling you share with other crops grown on the farm that are ready for harvest at that time. We may choose to cover for a crop loss by buying in from other local farmers. However, this may not be a feasible option for all crops because of cost or widespread failure.

In addition to our CSA, our farm sells at our farm market, and some wholesale. We will balance priority of the CSA with our other market. This allows us to select a consistently full and diverse share to our members while avoiding over-delivering any one product.
