INFORMATION ABOUT THE COVENANTER SCOTTISH FESTIVAL

This year's event will be held in conjunction with the 6th Annual Covenanter Scottish Festival and The Penn's Wall Highland Games. The Covenanter Scottish Festival is held on the grounds of the Middle Octorara Presbyterian Church and the Octorara Covenanter Church at 1199 Valley Road (Route 372), Quarryville, PA 17566.

The Octorara Covenanter Presbyterian Foundation is a charitable and educational non-profit organization established in part to restore and maintain the Octorara Covenanter Presbyterian Church and its attached school room as an historical site. The Church is the oldest Covenanter Church in North America dating back to 1754. The schoolroom, a Presbyterian Academy, was added to the Church about 1880. From 1901 to 1927 the schoolroom housed Bart Township High School.

Information about the festival can be found at the website www.oldcovchurch.com. Advance tickets for Adults are available for \$13 per person.

The Festival will include Clans, Highland Athletics, solo amateur piping competitions, Highland Dance competitions, vendors, and entertainers. This is an example of past entertainers:

Rules & Regulations for Sanctioned Events

- All of the above events are sanctioned by the Eastern United States Pipe Band Association (EUSPBA), except 601. All competitors in sanctioned events must be a member in good standing of the EUSPBA or other recognized piping association. All EUSPBA rules and regulations apply. Visit www.euspba.org for rules, regulations, or membership forms.

2. The contest committee reserves the right to cancel any and all events.
3. Entries must be postmarked by August 24, 2019. To receive entry confirmation and ticket, send a Self-Addressed Stamped Envelope with your entry. Competitors will pay a Competition Entry fee per event as provided in the list of events. A Festival Entry Ticket is included for each registered competitor.
4. Additional advance tickets can be purchased for \$13 per ticket with your entry form or online at www.oldcovchurch.com. Tickets are \$17 on the day of the festival.
5. Registration will begin at 8:00 a.m. Competition is tentatively scheduled to begin at 9:00 a.m. on September 7, 2019. A tentative competition schedule will be posted on the internet at www.oldcovchurch.com by September 4, 2019. Generally, Grades 5,4, and 3 will be in the morning with Grades 2&1 in the afternoon.
6. The competitions will be held rain or shine.
7. All competitors (except Novice Practice Chanter) must compete in appropriate highland attire.
8. Gr. IV is split into two separate categories according to age: 17 & Under (Jr.) and Age 18 & Over (Sr.). See EUSPBA rules for details.
9. Competitors in Gr. IV Piobaireachd must play a Full Piobaireachd in the contest.
10. Order of play will be determined by the reverse order in which entries are received. The first entry received will be the last to play.
11. Awards will be given for first through third place in each event. The judge has the right to award one less prize than the number of competitors.
12. An overall trophy will be awarded to a piper in each grade (Grades 1 through 4). The winner will be determined by points with 1st Place = 3 points, 2nd Place = 2 points, 3rd Place = 1 point with Piobaireachd, then 2/4 March (or MSR) breaking any ties.
13. All protests should be made in writing and lodged with the Contest Committee before the end of the games day. All protests shall be dealt with by the Contest Committee, whose decision shall be binding by all parties concerned.
