We're looking for a bold, inspiring design that captures the spirit of our event. Your design should feature **one or more of the following themes:**

- 5K run/walk
- Superheroes (generic to avoid copyright infringement)
- Autism Awareness + Disability Inclusion
- Iconic scenes, landmarks, or elements of Clermont/Lake County

### Design Guidelines:

- Designs may be **hand-drawn or digital**
- Hand-drawn designs should be created on a **white sheet of printer paper** (*note: white areas may become transparent when printed*). The bigger the design on paper, the better!
- Designs must be submitted as a **JPG or PDF**
- The winning design may be **digitally enhanced or recreated** for print quality while preserving your original concept

### Prize:

- The winner will receive a **\$100 gift card of their choice**
- Your design will be featured on the official race t-shirt!

### Who Can Enter:

- Open to **Lake County residents of all ages with disabilities and/or special needs**

## T-SHIRT DESIGN CONTEST RELEASE & AGREEMENT

This Release & Agreement (“Agreement”) is entered into by the undersigned participant (“Participant”) in connection with submission to the Jack and Allie 2026 T-Shirt Design Contest (“Contest”).

### 1. Submission of Design

By submitting a design to the Contest, Participant affirms that the work is original, created solely by Participant, and does not infringe upon any third-party rights, including copyrights, trademarks, or other intellectual property rights.

### 2. Grant of Rights

Participant agrees that, if selected as the winning design, all rights, title, and interest in the design are irrevocably transferred to Jack and Allie. Jack and Allie shall have full ownership and unrestricted rights to use, reproduce, modify, adapt, publish, distribute, and display the design in any format or medium, worldwide, in perpetuity.

### 3. Modifications

Participant acknowledges and agrees that Jack and Allie retain full control over the final design. The winning design may be altered, edited, or modified at their sole discretion, including changes necessary to improve print quality, formatting, or overall presentation.

### 4. Selection of Winner

The winning design will be determined by a public vote conducted via the Jack and Allie Facebook page. Participant agrees that the results of this vote are final and binding.

### 5. Compensation

The winner of the Contest will receive compensation in the form of a \$100 gift card of their choice. No additional compensation, royalties, or future payments will be provided.

### 6. Release of Liability

Participant releases and holds harmless Jack and Allie from any and all claims, demands, or causes of action arising out of or related to participation in the Contest or use of the submitted design.

### 7. Agreement to Terms
