## **49th Easter Rally Guidelines**

Once again, we are all looking forward to the Border Steam and Oil Engine Club's annual rally. Below are the rules and guidelines that will ensure a smooth and safe rally for all. Please note that there has been changes, especially regarding movement around the property, please read carefully as strict compliance is necessary and mandatory to ensure we all get to enjoy the event for years to come.

### **Registration:**

- ◆ Please ensure all your registration is in order and you have all the current relevant information.
- ◆ All exhibitors and/or participants (any person inside the display area) at the rally **MUST** be registered and insured with a Club or have their own insurance.
- ◆ Membership with the Border Steam & Oil Engine Club is available at a cost of \$35, per person.

### **Biosecurity:**

The area which the Border Steam & Oil Engine Club leases is part of a working farm so there are items which need to be considered when entering and moving around the property.

- ◆ No animals of any kind are to be brought onto the property whatsoever.
- ◆ Please minimise the movement of the vehicle around the property. Vehicular movement is restricted to rally and camp grounds only.
- ◆ All areas outside the display, camping and vendor areas are private property and entry in areas such as creeks, dams, paddocks and buildings, other than the catering shed, will be considered trespassing unless express permission is given by the land owner.

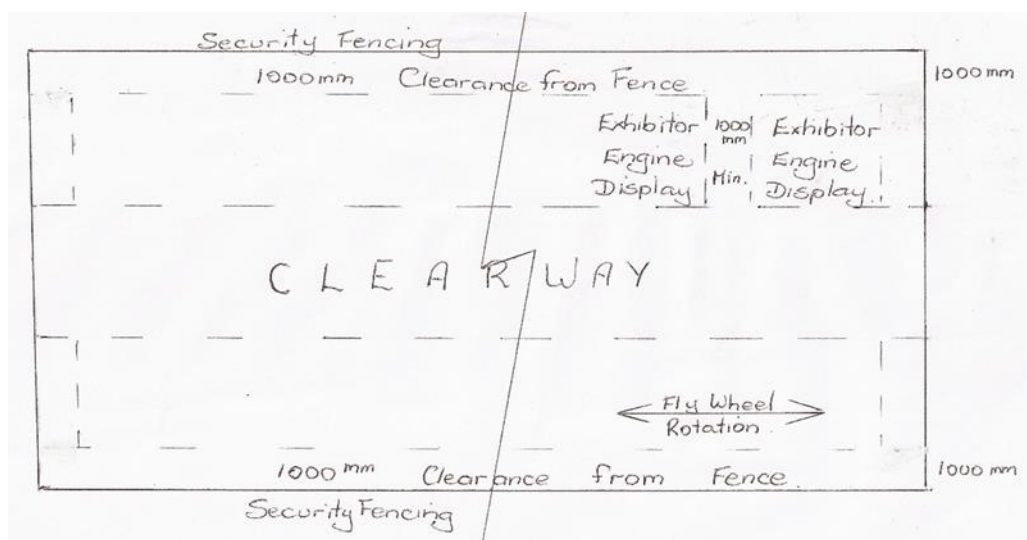
### **Camping:**

- ◆ Registered exhibitors in the rally are the only persons permitted to camp at the rally ground.
- ◆ Please be respectful of others using the camping area.
- ◆ No power is available for camping sites.
- ◆ No animals (see Biosecurity).
- ◆ Camping is on a first come first served basis and is only permitted Friday to Monday unless prior approval has been given.
- ◆ No trail bikes.

- ◆ Lighting of fires will be subject to CFA Rules and Regulations.
- ◆ As per Biosecurity, children of exhibitors must have a clear understanding of rules in relation to permitted access areas or must be in the company of an adult
- ◆ Movement around the property outside the designated areas will be classed as trespassing and will be dealt with as such.

### Exhibiting:

- ◆ Set up for exhibitors will be after 12:00pm Friday due to the club moving large equipment.
- ◆ All persons within display areas MUST have available for presentation, proof of membership or currency of insurance.
- ◆ There is a three metre wide clearway down the centre of the display areas for loading, and unloading, and shall be in force during the beginning and end of each day. This is for ease of loading and unloading equipment and displays.
- ◆ Shade gazebos are allowed to be erected during the day however, any gazebo obstructing the clearway/loading/unloading area may need to be moved where necessary. Gazebos can be erected next to the display fence.
- ◆ Cars and trailers cannot be parked in the display area (no exceptions).
- ◆ Each exhibitor's running display is to be a minimum of 1 metre from the display fence.
- ◆ Each exhibitor's display is to be approximately 1 metre from the next display.
- ◆ The rotation of the flywheels is to be parallel with the display fence.
- ◆ Alcohol is not to be consumed within the exhibiting period (10am-4pm).
- ◆ Minimum age of exhibitors is 10 years of age.
- ◆ All persons under the age of 16 years of age must be supervised by an adult while in display areas.
- ◆ All gates to exhibit areas area to remain closed and latched at all times.
- ◆ Fences, gates or posts shall not be moved or modified with out express permission of the rally safety offices
- ◆ NHMA safety guidelines apply



## **Vintage Cars**

- ◆ Vintage Cars exhibits are welcome when the exhibitor has other machinery exhibits.
- ◆ Other vintage cars may exhibit by prior arrangement only.
- ◆ Any vehicles on display must remain in the compound for the duration of the time that the event is open on that day.

## **General Information:**

- ◆ An evening meal is available on Saturday evening at a cost of \$10 per head. Meals must be paid for when collecting your plate.

## **Indemnity:**

1. I agree that the organisers, promoters and sponsors of the Border Steam & Oil Club Inc Easter rally accept no responsibility for any loss or damage suffered by or to any entrant, owner, driver or exhibitor by any means, act or omission or through any circumstances. The entrant agrees to indemnify themselves.
2. I release to the fullest extent permitted by law the Border Steam & Oil Club Inc, its officers and representatives from all claims and demands arising from any damage, loss or injury (including death) to persons or property caused as a result of any occurrence or state of affairs concerned directly or indirectly with the rally, whether or not the damage, loss or injury was caused by the negligence of the Border Steam & Oil Club Inc, its officers, employees or agents.
3. I acknowledge that except to the extent required by law, the Border Steam & Oil Club Inc make no undertaking, warranty or representation of the fitness for purpose, quality or performance of any premises, facilities or equipment used or available for use during the rally and that the Border Steam & Oil Club Inc excludes any other warranties, whether expressed or implied, relating to the premises, facilities or equipment.
4. I recognise and agree that during the conduct of the rally, I will be required to comply with directions from the Border Steam & Oil Engine Club Committee Members on site.
5. I acknowledge that I enter and participate in this Rally at my own risk and have read and understand this indemnity form.
