

**2025 Fall Professional Art Show**  
**Co-Sponsors: Jefferson City Art Club, Capital Arts Gallery**

**Exhibit Dates:** Entry deadline Monday September 9th, Drop off artwork on Tuesday, September 16th, from 11 to 6 pm at Capital Arts Gallery. Artists' reception on Thursday, September 25th, from 5:00-7:00 p.m. at Capital Arts Gallery at 1203 Missouri Blvd in Jefferson City. The exhibition continues through Saturday, October 18<sup>th</sup>, pick up time is Tuesday, October 21<sup>st</sup>, from 11 to 6 pm.

**Exhibit Information:**

This is a public exhibition for professional artists. Please review the following to determine if you are eligible to enter...

- A. Anyone who has earned an art degree in any area of art from a college, university, or accredited art school, or
  - B. Anyone who earns at least 50% of his/her yearly income from artwork, or
  - C. Anyone who teaches art classes for reimbursement, or
  - D. Anyone attending graduate school in art.
  - E. Anyone who considers themselves a professional artist. (Once professional always professional)

- The purpose of this show is to provide an opportunity for artists to show and promote their art to the public in a professional venue. This is a family-oriented event. A qualified judge will award ribbons. Cash awards are: Best of Show -\$125, 1<sup>st</sup> Place-\$100, Second Place-\$75, Third Place-\$50. In addition, Honorable Mention awards will be given at the judge's discretion. Winners will be announced on the JCAC and CAG websites and or Facebook pages to the public. Gallery visitors can also vote on their favorite artwork by casting a ballot for the "People's Choice" award.
  - Framed hand produced art must be original-no copies or prints. Photography is welcome. Photos may be traditional film, enhanced digital photography or digital with no photo base. Work previously shown in the Adult Fine Art Exhibit or Professional Art Exhibit is not eligible. **Artwork may not exceed 144 inches in perimeter including frame.** For example, a 48 inch by 24-inch artwork is the maximum size. (48x2=96 inches, and 24x2=48, 96+48=144 inches.)
  - No art should be older than three years. Photos used for reference to produce hand created artwork must be taken from the artists' own photos. However, copyrighted images may be used in the artwork provided they are significantly transformed into new creative art forms. Artist is solely responsible for copyright legal challenges. Art must be ready to hang with wire hanger on back, no wet paint. **Artwork without wire hangers will not be accepted.** Gallery wrapped canvases must have edges painted. Artwork must be for family viewing, no nudes, partial nudes, or graphic violence. **Please identify your artwork by copying the ID tag below and filling it out and attaching it to the back of artwork.**
  - Three entries per artist are allowed. However, we reserve the right to restrict to one or two entries if space requires. No refunds will be given.
  - Artwork may be for sale. If not for sale, write NFS on entry information. Capital Arts requires 25% commission on all sales. The gallery will collect payments on all works sold and will pay the artist a



few days after the show. A sold sticker can be placed on the artwork during the exhibition if sold, but artwork must remain in show until the conclusion.

- All artworks must be dropped off on Tuesday Sept. 16<sup>th</sup>, from 11 to 6 pm. Mailed artwork is not accepted by the sponsors and they are not responsible for artwork at the end of the show. Artwork must be picked up at the end of the show or make other arrangements by calling Fred Schollmeyer 573-690-4831 or Ashley Blankenship (Capital Arts) at (573)635-8355.
- To promote yourself and your work, please submit images of your work by emailing JPEG files to [artsadmin@capitalarts.org](mailto:artsadmin@capitalarts.org) and/or [cherylarti@aol.com](mailto:cherylarti@aol.com) These images will be posted on the JCAC and/or CAG websites.
- All artworks must remain in the gallery until pick up date of Tuesday, Oct. 21<sup>st</sup>, from 11 to 6 pm. Contact JCAC committee members with questions. Fred Schollmeyer 573-690-4831.
- Artist assumes complete responsibility for insurance of artwork. All reasonable care will be given to artwork in custody of the Jefferson City Art Club and Capital Arts Gallery. Works submitted are at the artist's risk. The Jefferson City Art Club and Capital Arts Gallery do not assume responsibility for damage or deterioration incurred before, during or after the exhibition. Submissions of any entry in this exhibit constitute agreement from the entrant to the conditions above.
- All entries are checked for meeting entry requirements, size, proper classification, and entry field on the tag. Any artworks not meeting requirements will be rejected. Entry field may not be changed unless deemed necessary by the committee.
- Sculpture may be clay, metal, glass, wood, papier mâché or other media.
- No refunds will be issued.
- Volunteer staffing helps Capital Arts keep the doors open to the public. Entrants are encouraged to support the exhibit in some way, preferably by volunteering. **Entry fee:** \$7.00 per entry for art club members (not Capital Arts members) and \$15.00 per entry for non-members. Make checks payable to Jefferson City Art Club. Non-members may join the art club for one year for \$25. The art club year runs from July 1<sup>st</sup> through June 30<sup>th</sup>. **Reception:** Thursday, September 25th from 5:00-7:00 pm. This is your opportunity to show and promote your artwork. Artists are strongly encouraged to attend and be available to the public. The reception will be in the Capital Arts Gallery at 1203 Missouri Blvd. in Jefferson City.
