## Safety Rules for Proofing Behaviors Canine Obedience LLC 2020

- 1. It is the client's responsibility that all dog(s) must have complete proof of vaccination records certified by your veterinarian prior to training, a copy of vaccination record will be received by Proofing Behaviors Canine Obedience LLC
- 2. It is the client's responsibility to verify all equipment for proper fit, use and follows Positive Reinforcement Fear Free Training during lessons
- 3. It is the client's responsibility when children under the age of 18 are involved to monitor, provide and follow all safety, heath policies and procedures established by Proofing Behaviors Canine Obedience LLC
- 4. It is the client's responsibility to wear proper clothing footwear and any or all garments to participate in class.
- 5. It is the client's responsibility to follow all instructed leash handling procedures
- 6. It is the client's responsibility to never let go of the leash
- 7. It is the client's responsibility in group classes or private lessons to follow a proper distance of 6 feet apart from another client,dog(s) during training lessons

  Note there will be times when working closer then 6 feet deemed to be necessary in those time(s) please follow health policy.
- 8. It is the client's responsibility to NEVER force a dog into a behavior
- 9. It is the client's responsibility to learn, recognize and identify stress in themselves or their dog(s) and remove themselves or the dog(s) from lesson(s).

## Health Rules for Proofing Behaviors Canine Obedience LLC 2020

- Trainer/Client will be diligent in identifying any sign of illness or disease in you and your dog
- If illness occurs Trainer/ Client will reschedule following Terms and Condition
- Trainer/ Client will follow proper hygiene guidelines including your dog
- Trainer/Client will verify their dog(s) is on a broad-spectrum deworming product include a dewormer
- Trainer/Client will wear follow PPE guidelines as described in Covid 19 Policy and Procedures
- Trainer/Client will clean and disinfect Training facility, house and backyard
- Trainer/Client will clean up feces after your dog goes to the bathroom
- Trainer/Client will Curb your dog to keep your community clean
- Trainer/Client will properly dispose of all cleaning items, PPE, trash and feces
