#### **Background Information**

WAC will host the 2025 NSW Aboriginal Rugby League Knockout on behalf of the 2024 winning team, WAC.

The carnival will be staged from Friday 3rd October - Monday 6th October at Riverside Sporting Complex, Tamworth.

All Aboriginal Rugby League and sporting clubs who wish to participate must read and complete the following documentation and submit your nomination along with payment of your entry fee by the due date. Acceptance of your nomination is conditional on your compliance with the terms and conditions set out in this nomination pack. An incomplete nomination could result in your team being excluded from the Event. Please read these documents carefully.

For Clubs wishing to enter a Youth Team in any age group, you must also provide a Working with Children's Check Clearance Number for each Team Official. You can apply for a Working with Children's Check through Service NSW by clicking the link below:

Please note that submission of a nomination form and payment of the nomination fee does not constitute acceptance into the 2025 NSW Aboriginal Rugby League Knockout. WAC reserves the right to decline club or team nominations and refund the nomination fee at its discretion, and your club official will be advised of the reason for this decision. Team acceptance into the 2025 NSW Aboriginal Rugby League Knockout is not approved or official until you receive a formal acceptance letter from WAC Sports confirming your registration.
