1. The undersigned hereby assigns to the **Academy of Latin American Business and Sustainability Studies (ALBUS), a NJ Nonprofit Corporation**, all rights under copyright that may exist in and to:
 - a. the above Work, including any revised or expanded derivative works submitted to ALBUS by the undersigned based on the Work; and (b) any associated written or multimedia components or other enhancements accompanying the Work.

CONSENT AND RELEASE

2. In the event the undersigned makes a presentation based upon the Work at a conference hosted or sponsored in whole or in part by ALBUS, the undersigned, in consideration for his/her participation in the conference, hereby grants ALBUS the unlimited, worldwide, irrevocable permission to use, distribute, publish, license, exhibit, record, digitize, broadcast, reproduce and archive, in any format or medium, whether now known or hereafter developed: (a) his/her presentation and comments at the conference; (b) any written materials or multimedia files used in connection with his/her presentation; and (c) any recorded interviews of him/her (collectively, the “Presentation”). The permission granted includes the transcription and reproduction of the Presentation for inclusion in products sold or distributed by ALBUS and a live or recorded broadcast of the Presentation during or after the conference.
3. RETAINED RIGHTS/TERMS AND CONDITIONS

General

1. Authors/employers retain all proprietary rights in any process, procedure, or article of manufacture described in the Work.
2. Authors/employers may reproduce or authorize others to reproduce the Work, material extracted verbatim from the Work, or derivative works for the author's personal use or for company use, provided that the source and the ALBUS copyright notice are indicated, the copies are not used in any way that implies ALBUS endorsement of a product or service of any employer. The copies themselves are not offered for sale.
3. In the case of a Work performed under a U.S. Government contract or grant, the ALBUS recognizes that the U.S. Government has royalty-free permission to reproduce all or portions of the Work and to authorize others to do so, for official U.S. Government purposes only if the contract/grant so requires.
4. Although authors are permitted to re-use all or portions of the Work in other works, this does not include granting third-party requests for reprinting, republishing, or other types of re-use. The ALBUS Intellectual Property Rights office must handle all such third-party requests.
5. Authors whose work was performed under a grant from a government funding agency are free to fulfill any deposit mandates from that funding agency.

6. **Personal Servers.** Authors and/or their employers shall have the right to post the accepted version of ALBUS copyrighted articles on their own personal servers or the servers of their institutions or employers without permission from ALBUS, provided that the posted version includes a prominently displayed ALBUS copyright notice and, when published, a full citation to the original ALBUS publication, including a link to the article abstract in ALBUS Proceedings DOI repository and Web Page.
7. **Classroom or Internal Training Use.** An author is expressly permitted to post any portion of the accepted version of his/her ALBUS-copyrighted articles on the author's website or the servers of the author's institution or company in connection with the author's teaching, training, or work responsibilities provided that the appropriate copyright, credit, and reuse notices appear prominently with the posted material. Examples of permitted uses are lecture materials, course packs, e-reserves, conference presentations, or in-house training courses.
8. **Electronic Preprints.** Before submitting an article to an ALBUS publication, authors frequently post their manuscripts to their website, employer's site, or another server that invites constructive comments from colleagues. Upon submission of an article to ALBUS, an author must transfer the copyright to ALBUS, and the author must update any previously posted version of the article with a prominently displayed ALBUS copyright notice. Upon publication of an article by the ALBUS, the author must replace any previously posted electronic versions with either:
 - (1) the full citation to the ALBUS work with a Digital Object Identifier (DOI) or link to the article abstract on the ALBUS Proceedings webpage or
 - (2) the accepted version only (not the ALBUS-published version), including the ALBUS copyright notice and full citation, with a link to the final, published article in ALBUS Proceedings.
