Dear Matt Hancock,

further to my recent notice, dated 3rd March 2020 reference number: JS 2558 8655 4GB. You were offered, in good faith, 10 (TEN) days to provide proof of claim of the following;

1. That I am a person and not a woman.
2. That I am a P or (“P”) and not a woman.
3. That I have a lawful contract with your Company registered as Members of Parliament, Portcullis House Bridge Street, LONDON, SW1A 0AA, D-U-N-S® Number: 211807693.
4. That I have a lawful contract with your Company registered as House of Parliament Westminster, Houses of Parliament, LONDON, SW1A 0AA, D-U-N-S® Number: 217827830.
5. That any of your Companies rules apply to me.
6. That there is a law obliging me to provide you, or your company, with any service or duty.
7. That I have signed an international contract.
8. That I am a member of the Armed Forces.
9. That the Common Law right to travel does not exist.
10. That the Magna Carta 1215, along with the Declaration of Rights 1689, is not our lawful foundation of the British Constitution, and as they are peace treaties between the Monarch and the people, they take complete precedence over any statute, act or regulation passed by Parliament.

I claim the right to be entirely free to determine my own medication needs at all times and never under any circumstances be forced to ingest or otherwise receive into my body by way of vaccination, electro-magnetic energy, audio or visual energy or any other method any substance or alien energies I choose not to accept.

I claim that if I am ever forced to undergo any such action against me which is not of my own free will. The transgressors be they peace officers, military, government principles, agents of the justice system, agents of the medical professions, or anyone else will forfeit to me the sum of Five Million Pounds Sterling. Per Claimant reasonably involved.

Furthermore, I claim the right to convene a proper court de jure in order to address any potentially criminal actions of any peace officers, government principals or agents or justice system participants who having been served notice of this claim fail to dispute or discuss or make lawful counterclaim and then interfere by act or omission with the lawful exercise of properly claimed and established rights and freedoms.

Furthermore, I claim the right to fulfil my duty, and to use any force necessary on any foreign troops in the United Kingdom who are armed and attempting to police or govern me or my fellow countrymen without consent and to view them as an invading force which must be lawfully defended. And I further claim the right to nominate as many deputies as may be necessary who by their own free will and consent are prepared to assist me in the fulfilment of this duty to my Country.

Furthermore, I claim the right to deal with any counterclaims or disputes publicly and in an open forum using discussion and negotiation and to capture on video tape said discussion and negotiation for whatever lawful purpose as I see fit.

Failure to register a dispute against the claims made herein and then successfully defeating these claims in a proper court of law will result in an automatic default judgment securing forevermore all rights herein claimed and establishing permanent and irrevocable estoppel by acquiescence barring the bringing of charges under any statute or Act or regulation against My Self [Enter name] for exercising these lawful and properly established rights, freedoms and duties.

No reply in ‘substance’ or otherwise has been given, this has been taken to mean that you (nor any other interested parties) have no objections whatsoever to my lawful standing and, that I will not come into conflict with anyone from the military troops, foreign or otherwise, Police Constables, nor will they make any demands on me unless they comply with Common law. Common law is ‘of’ the laws of God (commandments) and constitutional law.

Therefore be it now known to any and all interested, concerned or affected parties, that I [Enter name] do hereby state clearly specifically and unequivocally my intent to peacefully and lawfully exist free of all statutory obligations, restrictions and that I maintain all rights at law to travel, trade, exchange or barter and exist without deceptive governance and to do so without limitations, restrictions or regulations created by others and without my consent, and that I reserve my inalienable rights not to be bound by any unrevealed contracts.

I claim my Fee Schedule for any transgressions by peace officers, military troops, foreign or otherwise, government principals or agents or justice system participants is Five Hundred Thousand Pounds Sterling. Per hour or portion thereof if being questioned, interrogated or in any way detained, harassed or otherwise regulated and Five Hundred Thousand Pounds Sterling. Per hour or portion thereof if I am handcuffed, transported, incarcerated or subjected to any adjudication process, and Five Hundred Thousand Pounds Sterling if I am ever forced to suffer the effects of what has come to be known as non-lethal weapon such as a Taser, without my express written and Notarised consent.

Silence is acquiescence, agreement and dishonour this is a self-executing contract deeming all parties to mean that you, and your principal, or any other agents or parties, abandon all demands upon me, now, or in the future.

All words, terms, phrases, symbols, and numbers herein mean what I say they mean and are not open to reinterpretation.
