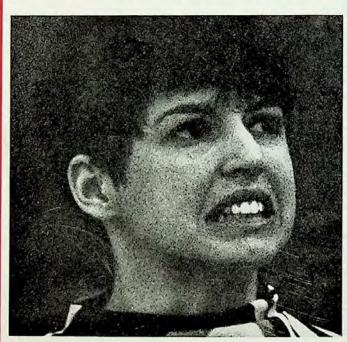

Jacobs-Decatur No. 5—Only Repeaters . . .

Singer Takes Over Singles Throne; Brady-McGuire Win Masters Doubles

Stuffy Singer becomes the No. 1 man in four-wall handball. Jim Jacobs and Marty Decatur repeat as doubles champs and rack up their fifth victory in as many tries. Bob Brady and Bob McGuire become the new Masters doubles champs.

Supplanted are: Paul Haber, two-time singles titlist, knocked out in the quarterfinal round by Steve August after gamely trying to give it a try for No. 3 despite a torn abdominal muscle . . . a four-in-arow record by Chicagoans Ken Schneider and Gus Lewis, eliminated in the semi-finals by the fine team of Alex Boisseree and Dick Weisman.

Pleasant and biggest surprise of the tournament — the sudden emergence of burly Ray Neveau, Oshkosh, Wisconsin, as a strictly top level singles performer. Neveau scored an exciting and well earned three game victory over a favored Marty Decatur in the quarterfinals, 14-21, 21-13, 21-20, powered past August in the semis, 21-12 and 21-14.

It appeared that the pressure of the sudden limelight of the national finals would provide a one-sided win for Singer against Ray. The pride of Oshkosh was tight and ineffective in the opening game and it was all Stuffy, 21-9. But, Neveau came back solidly to knot the match, and the third game was one of those pressure chamber affairs. At 20-17 Stuffy double-shorted, reminiscent of the double short Bill Yambrick had at Salt Lake City against Haber in 1966. Ray could not take full advantage, added one point, and then Stuffy went on to win on a fine lefthand fly kill from the short line.

Shumate Impressive

In addition to the crowd-pleasing play of Neveau throughout the week it was the strong play of Buzz Shumate that had onlookers "buzzing". This was, without a doubt, the Dallas A.C.'s rep. best performance in our nationals. He pulled a big one in eliminating the runnerup of the past two years, Bill Yambrick, in the quarter-finals in three game. Again, it was a case where the loser completely dominated in the first game but from that juncture Shumate took charge with his thrilling two-handed shooting. He had a good first game against Singer in the semis but

faded after losing it 21-19. He then bounced back impressively against August to win third place.

Three players were singled out as the "most likely to succeed" in this 19th edition of the singles classic — Haber as the champion to beat, No. 2 man Yambrick, and the obviously hungry and at the top of his game, Singer. Only one proved himself on the form charts and he is USHA's fine new champion.

Much credit must be given the Obert brothers — Oscar and Ruby — for a fine final match showing against the "Monster Team" of Jacobs and Decatur. After a week of veritable breezes in their matches, Jacobs and Decatur were not visibly tired or tested. However, as I put it to a sports scribe covering for a St. Louis daily, "Despite a lack-luster performance by Jim Jacobs, the defending champions repeated in the open doubles." Jacobs was not the letter-perfect player he had shown in earlier matches and the Oberts took full advantage of this in almost pulling the first game out, going down 21-19. Jacobs could not muster an effective serve, twice double shorting on cross court serves and was

simply not sharp in his shooting.

"I told Marty before the final match that my back was once again acting up and not to expect too much from me," Jim told us after the match. "I couldn't bend properly for either the serve or in taking balls off the back wall, but with Marty as a partner there was nothing to worry about."

Jim added, "This is the one big reason I won't go in the national singles. After three or four days my back definitely gives out."

Jacobs had carried much of the load in the earlier matches as Decatur was trying the "Hat Trick" in playing both singles and doubles, getting tripped up in probably the most exciting match of the week — a three-gamer to Neveau with the final game a spinetingling, 21-20.

Dopesters had Schneider and Lewis again getting their biggest test from the boys from the San Francisco Olympic Club, Bob Brady and Bob McGuire. But, they aidn't reckon with the new team of Alex Boisseree and Dick Weisman, Those who watched this pair lose a close one to Brady and Bill Keays in the West regional should have known better. In a stunning and comparitively easy fashion the Los Angeles A.C. team disposed of the four-time winners, Schneider and Lewis, in the semi-finals and then battled right down to the wire in the championship all-California Masters match, before losing 21-19, 21-19.

Muck Again Champ

Terry Muck of St. Paul's Bethel College notched his second USHA National Intercollegiate A singles championship over a 14-player field in the three-day competition held at the St. Louis JCCA, May 3-5. Muck, already a highly regarded open national tourney performer had played earlier in the week, being eliminated by the new champ, Stuffy Singer, after winning three matches.

As was expected the showdown came between Muck and University of Miami's Fred Lewis, a product of both New York City and the Beach's Flamingo Park. Lewis wasn't sharp enough for the speedy, well-poised Muck, losing 21-11, 21-14.

Joel Galpern, another U. of Miami representative, had played Muck in the open singles and lost, 21-4, 21-8. He improved his performance in the semis of the intercollegiate, losing 21-12, 21-17. Galpern, an intense, scrappy player, had stopped Larry August, University of Michigan, in the quarters in a real battle 21-10 20-21, 21-18. He salvaged third place over the West Africa youngster, Joe Vasquez, 21-19, 21-15.

John Paveletz, Bronx Community College of New York, has come fast in his conversion from one-wall. He had won the B singles in the East divisional held at Penn State U., and added the national B honors by beating Mike Darnell, Purdue University, 21-14, 21-4. There were 14 entries in the B singles also.

George Riggins, Drake University, took B singles third place over Zbignew Jackowski, DePaul University, 21-4, 21-9.

The Texas A & M team of Ozzie Burke and Dan Kennelly won the doubles bracket, beating the University of Texas team of Love and Squires, 21-17, 14-21, 21-3. However, the Longhorns from Austin took the team honors on the point basis to retain the Fred Miller Memorial Bowl.

Notes of the Tournaments

The collegians on hand Thursday night were guests of the USHA at the big open nationals award banquet... and were treated to dinner allowances on Saturday night. With 46 entries overall a new mark was set in the USHA sponsored event... Marty Laser, playing in the doubles with Dick Cashmore, and representing Southern Illinois University, is the youngest son of Ray Laser, national Masters champ with Bob Kendler in 1952 and 1953. Ray no longer is able to play the game because of a bad leg, lives in Miami,

Florida . . . Air Force Academy had two aspiring singles players and report interest in getting more tournament play at their home base . . . Local handball buffs were touting Bill McGreevy's southpaw son, Bill Jr., of U. of Missouri, but he got eliminated by the West division winner, Dick Gesswein, 21-13. 4-21. 21-12 . . . Vasquez stopped the South-Southwest division A winner, Steve Crossen of North Texas State, 21-13, 21-4. Steve is the son of Red Crossen of the Dallas A.C. Tom Kopatich, our under-19 national junior winer last December, won his first A singles match over Stan Henson, U. of Texas, 21-5, 21-8, but then got his upbringing in a fine match with Fred Lewis, 21-19, 21-14. Kopatich attends Oshkosh, Wisconsin, College . . . We'll have to change this name — Zbignew Jackowski of Chicago's DePaul University, trained on the 23x46 college courts, but wound up fourth in the B singles. Ben Loiben, president of the Bernard Horwich JCC handball club in Chicago, brought in his son Allen, but the North Park College rep. lost to Dave Ackerman, Harris Teachers of St.

Louis, 21-3, 21-8.

20th Anniversary USHA Nationals Set For U. of Texas Mar. 16-22, 1969

Official dates for the 20th National United States Handball Association Four-Wall Championships have been confirmed by host chairman, Pete Tyson, March 16-22, 1969, at the 13-court facility of the University of Texas at Austin.

It was decided to utilize the earlier March dates prior to the Easter and Passover religious holidays. Tyson reasoned that any dates after these holidays might pose a climatic condition. Expected warm weather in April could lead to wet playing conditions in the courts and hamper play. However, the weatherman promises fine, Springlike temperatures in mid-March and an ideal time to conduct the competi-

tion.

Masters singles will be added to the schedule of events in the 1969 action — to that of open singles, open doubles, Masters doubles and Consolation singles (for those eliminated in the preliminary and first round of open singles. The annual USHA-sponsored national intercollegiate tournament will also be played, the final two days of the championship handball week.

This will be USHA's second national tourney visit to probably the finest handball facility in the world, barring none. The 1965 nationals were held at the State university with a record 1100-attendance for the singles finals between winner Jim Jacobs and Dave Graybill. The centralized glass amphitheater court that can be expanded in spectator facility to seat upwards of 1200 is surrounded by 12 conventional courts.

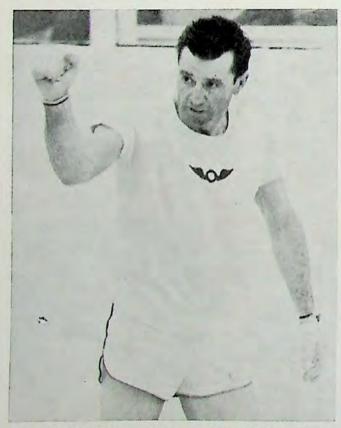

Joe finally won out, 21-19, 10-21, 21-20.

USHA Congratulates Our Commissioner Judge Shane

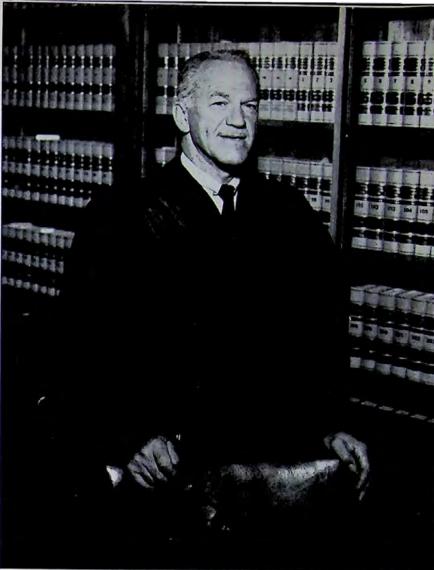

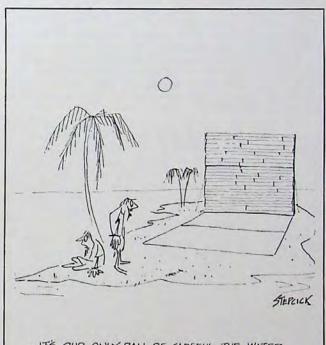

Player's Fraternity Leader Gives
Annual Convention Meeting Report

ENTHUSIASM-PLUS . . . USHA President Bob Kendler exudes the intense feeling for the game and its Association as he addresses the convention gethering at the St. Louis JCCA.

The vocabulary of those of us who pioneered handball includes three words that have been both imminent and omnipresent in our lives, — Revolt — Change — Progress. The past 40 years will be recorded in handball history as the period that began with Revolt, — struggled with Change and grew with Progress. It started with hayloft handball and ended with amphitheater handball. It started with confusion and ended with order. It started with mediocrity and ended with glory. It started with bigotry and ended with fraternity. It started with one handball great and ended with another, — this period from Banuet to Haber.

I have been a part of handball for nearly 40 years. I have been a part of this Association for nearly 20 years. The evolution that I have witnessed has made me very proud to be a part of both. The Fraternity and Fellowship that has emerged gives me a wonderful sense of achievement. Men like Joe Shane, Hymie Goldstein, George Brotemarkle, Mort Leve and many more can be equally proud. For theirs has been no less a contribution than mine.

The courage and determination of these men have brought about a new order, — an order so fine and so far removed from the old order that many of our young players do not even know the disorder that went before them . . . they do not even know the jurisdiction that oppressed their handball predecessors . . . they do not even know the scorn that racked our ethnic groups and suffocated our game. And it is good that they should not know all this. It is enough for them to see the improvements that self-government has brought to our sport and the inevitable dividends everywhere evident in this tournament.

The past 20 years will be recorded as the period in which men who had been punished by A.A.U. bans and harnessed by A.A.U. jurisdiction, finally lifted the bars from the barred athlete, and set about the task of building a new handball union, — of the player, by the player and for the player. It will be known as the period in which they asserted their freedom and saved the sport. Through Friendship and Fraternity, modern handball came into being.

USHA Spells 'Freedom' . . .

Sometimes, in this changing world, that for which we should show our most concern, gets lost. So, these words are intended only to remind you that the United States Handball Association has NOT lost sight of the freedom we now enjoy . . . the right to play anywhere we please with anyone we please. I ask you never to relinquish this right, — it was hard won and should be well guarded.

Handball should never again permit the injustice that befell Al Banuet, who passed away in March. He was to handball what Babe Ruth was to baseball. And Babe Ruth was no less a fun-lover. To have denied you and me and all handball the prowess of this phenomenal player was one of the blackest pages in A.A.U. history. All of us have paid a price for this folly. To have had the influence of his skill passed on to this generation of players, — to have had his teaching and strategy, would have forever enriched the sport.

The USHA has demonstrated not only a deep concern for the game but for the players as well. The banning of Banuet and Lewis, — Coyle and Baier, — Laser and Kendler and the threat to Jim Jacobs — demonstrated that the A.A.U. does NOT have the capacity to govern the game. The players have not only demonstrated that they have this capacity, — they have proven conclusively that in every one of their 20 years they have elevated the game to a higher level and their play to a higher skill

higher level and their play to a higher skill.

Now, what are the broader implications of these words? To begin with, there is a priceless ingredient

that is a consequence of this vast body-building program we are engaged in. I like to think the most valuable of all is the respect that we have for each other, not only as individuals, but as groups. I like to think that our relentless innovation has broken the barriers that keep people from recognizing the unbounded good that is inherent in all handball players. I like to think that we add more health to more lives, - more sportsmanship to more athletes, - more horizon to more youth, - all through this common denominator HANDBALL, - by the spirit it brings to the body, mind and soul. I like to think that 20 years ago we pioneered the principle of one family of men and one caliber of sportsmanship.

I like to think that race and religion have no role in our drama and that Fraternity is the tenet of our Association. I like to think that without bayonets and bullets, without bombs and blasts, we quietly market our product of Liberty and Justice for all. I like to think we integrated whites with non-whites, - and people of all ethnic backgrounds. I like to think that we were the first, if not the only organization, to lift these barriers. I like to think that by demonstration, rather than *declaration*, we became the model for all Associations to live by. The great need in America is for MORE of this religion that has been our priceless ingredient in handball.

Needed Change, Progress

Disraeli once said: "The health of the people is really the foundation upon which all their happiness and all their powers as a state depend." These are the broader implications of Revolt, Change and Progress.

Did it ever occur to you that we are also successful because we are a purely amateur organization? Money has never been a factor in this sport. Those who say that money brings out the best in athletes forget that it also brings out the worst. Greed, selfishness, cheating and gambling are the inevitable by-products of the play-for-pay boys. The sacrifices that all of you make are motivated by your heart and not by your pocketbook. And for this I am grateful to everyone who gives handball a helping hand in the little tournaments as well as the big, - in the small towns as well as the large. Don't think for a moment that I am not aware of the wonderful work that all of you do. Believe me, what you do is much harder than what I do.

I think it is remarkable that without professionalizing the sport we are able this year to give some \$4,000 to 25 Regional Finalists, - that we are able to give some \$2,700 to 13 open players and some \$2,000 to 84 college players. Add to this the \$1,500 we gave to 34 junior players and \$5,000 to 15 different tournaments and you begin to get an idea why we need more than \$100,000 a year to run this business, \$15,000 of which this year went to 156 players and 15 tournaments. And, you know what's wonderful about it? Handball income is slowly but surely growing big enough to pay these handball bills. And that's never happened before. So you see, we are not only on our way to Handball greatness, we are also dem-

onstrating fiscal responsibility. There are many pleasant moments in this job as president of your Association. I think I enjoy the reports I get from our traveling players. We get many calls for names in distant cities where visiting players can get a game. Well, they always get a game and sometimes a great deal more. I couldn't begin to describe to you all the hospitality, all the good fellowship these visitors report. Life-long friendships have developed, - home and home matches arranged, partnerships planned and playing secrets traded. You know this has more than entertainment value. Different parts of the country have different styles and when East meets West, - each player will take home

with him some fruits of his journey. No one has ever doubted that a good one-wall player makes the best four-wall player and when they share each other's skill, as well as their hospitality, better handball is played in more areas.

Changing Times

As times change, - so do people's needs. What the players of the 20's needed is entirely different than his needs today. We have tried to anticipate this need and to project our thinking far enough into the future that we may be ready when the need arises. For that reason, I would like to tell you about the evolution that is taking place in handball and ask you what we should do.

We began having growing pains as soon as our Nationals began making money. To begin with, we have more entries than most clubs can handle in one tournament. To compound this problem, we have more clubs bidding than we have tournaments to award. There are several obvious solutions. Break up the Nationals as we now know it by playing separate singles, doubles and Masters tournaments, thus providing two additional tournaments for two additional cities. Or we could reduce the entries in the Nationals by permitting only the State and National winners to enter. Even this might not appease the tournament-hungry clubs. That suggests another alternative. Instead of eight regional tournaments we could have 16. Or we could have 50 state tournaments and that I think would provide for the forseeable future. In this alternative we would again allow only the finalists and past National champions to enter the Nationals. Now, in the beginning, many of you might feel the absence of some of the old gang, and so would I. Nevertheless, in a relatively short time, you would have just as many friends in whatever event you entered. Remember, - when the old-timers began, we all started with new friends.

Many Facets of Game Fundamentals,

Position, Strategy in Two-Hour Session

Moderated by President Bob Kendler

TYSON AT THE MIKE . . . University of Texas handball coach and instructor handles lead questions given him by USHA President Bob Kendler.

Clinic-Seminar held at the Jack Srenco Memorial Court, JCCA, St. Louis, Wednesday, May 1, 1968.

... USHA President Bob Kendler, moderator ... Dick Roberson and Pete Tyson, Austin, Texas, instructors. Dick was the first handball coach at the University of Texas, a former "Top Eighter" in national singles, co-author of "Beginning Handball," largely instrumental in getting the addition of 13 courts at the university, including the famed glass amphitheater center court. Pete is now the Texas coach, national doubles champ with Bob Lindsay in 1966 at Salt Lake City, and with Dick finished fourth in this year's national doubles.

Pete, how do you start your students off in learning the game of handball?

... Our classes are usually mixed, half advanced players, the other half beginners. I start the beginners with the basic fundamentals, first just throwing the ball, first with the strong hand to get a feel of the court . . . then use the offhand to learn some sort of coordination, trying to stroke the handball with the baseball throwing motion. The classes are 35 minutes long, three days a week . . . I will talk to them for a short time, show them a shot or two, and then split them up into the 13 courts available. I don't try to cover too much in one day. I may show them initially where the ball contacts the hand and then have them bounce the ball and hit it to the front wall. The second time out we'll have them throw it up to the front wall

and line up in proper position to return it. Then we will go into serving, followed by serving and receiving practice, and taking it off the back wall. I will rotate from court to court trying to pick out obvious mistakes and weaknesses. I find that although the baseball motion is stressed most of the boys will stiffen up their wrists in hitting the ball and it takes time to loosen them up.

The advanced students are given a clinic-type treatment . . . shot, serve, hook, return, fist ball, defensive position, anticipation — ten or twelve things covered at least once a week.

On use of the off hand I stress facing a side wall, getting off on that back foot and getting the good motion.

Pete, I think your introduction is very good. Now, let us go to the serve.

most important shot we have in handball. You have your opponent in back court, in a horrible position near the back wall. The server is on the offense. I try to emphasize how easy it is to score when you have that short line position with the opponent back and how difficult it is to score from deep court. I try to emphasize how important it is to serve in such a way to keep the front court position. So, when the serve is returned you can go for the score.

We try to teach some basic serves, going to what I call "the proper place."

The beginners can serve just about anywhere against a beginner

and score, and often this can lead to bad habits and the mistaken idea that it isn't important to have a good, controlled serve. The idea of a good serve is to force the opponent to return the ball with his off hand from as deep a corner court position as possible, before the ball gets to the back wall. In serving the straight or cross court ball it must be kept low to be effective. There are many variations to serve . . . from different parts of the serving zone, with varied speeds.

If you don't know your opponent you can experiment the first five or six points with different serves to find which one is effective. The three-wall or Scotch Toss, or Z serve can be delivered overhand, side arm or underhand. If it is served too easy the opponent can move in and take it out of the air. We like to term such execution with "reasonable authority."

In speaking of hook serves it should be emphasized that the ball must be hit close to the short line to have effect . . . otherwise, it will probably come off a side or back wall and spend any break the ball may take. The walls, will in other words, neutralize the hook.

Bob — I think it is very important to watch the opponent while he is warming up and then you can get a pretty good idea of how he should be served.

Dick Roberson — I think if we really work on our serve we should make anywhere from six to ten points a game with it. It's not necessarily the number of aces achieved, it is that weak return that leads directly to a kill. You want to exploit your opponent's

weakness and the serve is the easiest way. This will save a lot of running around the court — getting getting an ace or a weak return.

The success of two championship doubles teams — Phil Collins and Johnny Sloan — and the current champs — Jim Jacobs and Marty Decatur — can be traced mainly to their ability to deliver the big serve, get that weak return and then put the ball away.

We like to stress the "safe" threewall serve in which you will not have the danger of shorting but still give a serve that doesn't give much to shoot from. Note: Jacobs shorted twice in the finals, using the "safe" three-wall serve, hitting it too hard.

We feel the player is weakest with his off hand from the waist and above and that three-wall serve can put the ball in this position. Many, many players handle that low serve very strong and they'll commence to play "boom boom" with you. The lob serve down the weak hand side can be very effective. A knowledgeable player, will of course, move in and take the ball before it has a chance to get in deep court, moving into the so-called "pocket" area behind the short line. A wide-awake server can offset this at times by speeding up the serve or switching it quickly to the opposite side, or throw the receiver off stride by not stroking the ball on that bounce . . . remembering you have three bounces allowed.

Bob — Will you explain how, in serving down the left you look over your left shoulder and when serving down the right you look over your right shoulder.

Dick — I think the secret of real good pressure handball against your opponent is positioning. Good positioning starts with anticipation. In order to be a good handball player you have to learn to anticipate well . . . watch the ball at all times . . . watching the opponent position himself, position of his feet, whether he is hitting the ball from a high or low position, and angle. A good player will hit the ball with his body, not against it. You can gain a full step by watching him and knowing where he is going to hit the ball. We like to teach these boys to get that elbow up by the face as a protective measure in turning to watch the reaction and shot of the opponent.

Pete — I find that many good players have varied ideas about the game, the shots. You have to go with your own physical ability. There are some players who can serve a high lob with their off hand. I personally would never attempt it. I like to emphasize to the students to go with what they can do well when in competition. If a man has great stamina he should develop a strong ceiling

and passing game, as Jacobs has for years. Myself — with much less stamina — I have tried to shoot from all parts of the court . . . the longer the volley, the worse off I am. So, it is not wise for me to play the control game and patiently wait for that sure, fat setup.

Dick — Good positioning means the ability to obtain it by achieving a good shot in the right place . . . the sooner you can get to a spot to hit the ball the better you are going to hit it. The more time you have to get set, the better your angle will be. This puts pressure on your opponent — points or weak returns.

Bob — You touched on a very important facet of the game — angle of the shot.

Dick — When you come in contact with the ball high you will invariably be hitting the ball high, to the ceiling or around the walls . . . if you try to shoot it low from this position the ball will naturally come up. However, if you get low, and shoot properly that ball is going to go in low and flat.

Note: We queried Jacobs about the lob serve at this juncture. — What lob can't you rush? Jim — The lob serve is not impossible to rush. By the very nature of its name it goes very slowly. I would never, never permit a lob serve to hit the floor. Anytime a man gives me this serve I'll take three steps in and punch the ball into the right side wall. Once you let that ball bounce it might get very tough to return from back court. However, a hard overhand three wall serve does not give this

opportunity. You have to make your judgment on this serve because it will come off different — off the left side wall, presuming it is to a right-hander, or it may come around off the back wall . . . Note: Ray Neveau powered this serve so hard at Stuffy Singer in the finals that the ball was coming around all the way off the right side wall low and it was most difficult for Stuffy to return.

Jim — There are three aspects to handball...(1) The physical aspect — ability to hit the ball properly. (2) The intellectual aspect — trying to do the right thing at the right time...it has nothing to do with the physique. I can get a handball player — a D player — but he might be smart enough to rush a lob serve, whereas right in this national tournament we have seen regional winners fail to do this and get in trouble. (3) The psychological aspect.

Bob — The question then comes up... whether to take balls out of the air or let them go to the back court. In the past generation with a deader ball a player like Joe Platak would maintain that short line position and take everything out of the air. Today, with the ceiling ball and the velocity of the ball many players are inclined to let the ball go to the back wall.

Pete — It is very difficult to fly a ball if you don't watch your opponent. Obviously, you don't have as much time to move into position as you do with a bounce of the ball: I think the fly shot is the big difference between the Eastern game and

International Paddle Racket Association (See page 25 – Milwaukee Nationals)

At first glance some of our real handball buffs will think we're pulling an Aaron Burr . . . treason to handball because we're giving a helping hand to a limping cousin named "paddleball". Through our resources and the known leadership of Bob Kendler we are bringing together many splinter groups of paddleballers, unifying their rules, equipment and offering a democratic Players' Fraternity just as has been done with your game.

After almost two years of extensive examinations, questionnaires, and first hand observations we concur that the hands and racket must live together. Both games are played in the same size court, both are played with practically the same rules, and . . . probably most important, so many of the same people are involved in both.

Will the paddle game stymie the growth of handball?

All of our tally sheets add up the same . . . handball is growing by leaps and bounds at the same time the paddle game is gaining stature.

We have found that many youngsters and adults who take up the simpler one-handed paddleball soon look for the bigger challenge of handball and make the switch. On the other hand there are many exhandballers, slowed by age and varied physical limitations that find extended court life through paddleball.

When so many physical directors tell us that the extended reach afforded players with the racket keeps men physically active in the courts years longer we could hardly turn our back on the men who have asked us to bind them in a smooth-operating international association.

We went to Milwaukee's JCC to watch, listen and then talk to men from some seven or eight states who had gathered there for a national paddleball championship in the so-called "gut" racket version, using a ball that is lively for this game. Larry Lederman, athletic director of this JCC, chairmanned the event and has been most instrumental in paving the way for our aid.

Thus, it is only logical that Larry with his many credentials for leadership, promotion and hosting of major successful tournaments, be named national commissioner for the new organization named — INTERNATIONAL PADDLE RACKET ASSOCIATION. There were some key men present who will assume important roles as district commissioners. Others will be recruited throughout the United States and

Canada.

What part does the USHA play? These so-called splinter groups who have been operating on a small scale for some years now can hard-by afford to finance an international headquarters office, publish a magazine, and do the pioneer work so important in its first years of growth. ACE magazine will provide the medium to bring the Paddle Racket message throughout the court scope.

It is important to note that the "IPRA" will be entirely separate from USHA. NO FUNDS coming into handball will go toward paddle rackets. Only those funds gained through IPRA memberships, official products tie-ins, and any other possible source of revenue will be used in its promotion and operation.

We have found that there are many handball men vitally interested and participating in the paddleball game. Simie Fein and Jim White of Milwaukee won the national paddleball doubles in this recent competition. Both are State handball champions and won our first national contenders.

Those who are already membersubscribers in USHA will be able to have a dual membership if they wish affiliation in both sports, and this will be offered at a nominal fee. Paddleballers can become IPRA members and receive ACE magazine. A section of the magazine will be given over to their game. This will be IN ADDITION to the handball material . . . NO PAGES will be taken away from handball. In time the IPRA will be able to handle its own magazine.

We realize the shortage of courts in many sectors. Handballers will holler that their play is being curtailed by the paddleballers. But, we know what inevitably happens . . . more and more players simply spell more courts . . . and there are more and more courts being constructed

everywhere.

Those of you who want to build up handball in your own baliwick can take a more active role . . . teaching the youngsters, introducing the game properly. You cannot selfishly remain in your cliques and expect men to acclimate themselves to our game. For handball is not an easy game to learn. It is frustrating for the neophyte to battle the angles of the walls, the sting of the ball on the hands, and the futile waving of that off hand. Without anyone to guide — whether it be in the colleges or Y's — we can expect the easier course — to the paddle game.

Singer vs. Neveau Play-by-Play Report On National Singles Final Round Battle





RAY NEVEAU

STUFFY SINGER

Stuffy Singer, Los Angeles (Encino Health Club)

vs. Ray Neveau, Oshkosh, Wisc., YMCA.
Saturday, May 4 — culmination of eight days of competition. Both No. 1 defending champion Paul Haber and No. 2, Bill Yambrick have been knocked out in the quarter-final rounds, thus leading the way to a surprising emergence of Ray Neveau into the final match.

Singer won the serve and scored first on a straight kill. He just missed with a strong serve down the right, then went to a so-called safe cross court serve and double shorted. Neveau tied it at 1-1 with an ace to the left, got a weak return on another power serve down the left but didn't take advantage and Stuffy ultimately put him out on a pass down

It was 2-1 Singer on his first ace - to the left. He then served to the right, took Ray's return out of the air but missed with his right. On a serve to the left, Stuffy tried to go to the ceiling and muffed it and the score was 2-2. Stuffy put him out after a good volley, taking a ceiling shot off the right back wall, and shooting a left front wall kill.

In the third inning two right hand errors by Neveau gave Singer a 4-2 lead, the second error being off the serve. Stuffy, in turn erred with his right, and Ray regained the serve. Neveau appeared to be too tight and wasn't shooting nearly as effective as he had in the victory trail to the finals. Stuffy went to a lob serve and was throwing Neveau off stride. A left hand error by Singer going for the ceiling made it 3-4. Then Neveau took a "handle" coming around to the back wall but missed with his right.

Singer lobbed the serve to the left . . . return was high . . . Singer gave him, during the volley, a back to front wall return. Later Paul Haber told us, "Whenever this desperation shot is made the opponent should rush in and fly the ball as he has his man in back court and the ball is coming off that front wall fat. But, Neveau did not do this once until the last game and then it was successful."

Stuffy made it 5-3 when he killed off a ceiling shot with his right. And, then he regained the serve and commenced to break the game open, going all the way to 13-3, on a sharp right corner kill, a left hand Neveau error, two passes, straight kill and a left hand Neveau miscue. Singer was staying with the lob serve and forcing Neveau into defensive positions. Neveau's ceiling shots were being stroked too hard and coming off the back wall and allowing Stuffy to get drive shots off of it. This slowed up game was having its effect.

Stuffy lobbed a serve to the right, got a weak

return and passed to the right for point No. 12 and got his 13th tally on a right hand error on a scoop attempt.

Ray then went in and got his fourth point when Singer missed on a right hand fly shot and another miss off a ceiling shot return for No. 5. A straight kill put Neveau out and it was 14-5 on a right corner kill with his right. Again, it was a case of getting a weak return off a lob serve to Ray's left. Neveau

put him out with a driving shot past his left side.

Stuffy missed a right hand shot and it was 6-14. Neveau then used a lob serve to the right, it came off the back wall and Stuffy killed it. Ray was getting some balls off the back wall but was shooting high whereas in the preceding rounds of play was really flattening the ball off the back wall. A right hand pass to Ray's left made it 15-6. Stuffy couldn't take advantage of a high return from short court and missed with his left. This just wasn't the Neveau that had worked his way into the finals.

Neveau then went into a cross court serve to

Singer's left. Ray killed sharply into the right corner, possibly his best shot of the game thus far. It was 8-15 as Singer missed with a left, but the spree ended when Singer dug up a tough one and put in a right hand kill.

The score went to 18-8 on a brace of three points — a right hand pass down the left, another one down the right and a lob ace to the left . . . then was stopped on a ball that was too hard to handle coming low off the back wall. Neveau couldn't score and missed with his left. No. 19 for Stuffy came on still another right hand pass down the right. Neveau got his ninth and final point on a Singer left hand error. No. 20 was a left corner kill with Singer's left and then a right hand kill into the right corner

First game rundown - Singer found he could gamble with his left because of Neveau's tightness . . . he was digging up Ray's shots and had a comparitive breeze throughout . . . the lob serves did throw the vaunted Neveau power off. Quick and painless could well describe the first game.

SECOND GAME Neveau serving. Power serve down the right coming off sharply off the side wall, too hard to handle for an ace and the opening point. Then, a serve hard off the left side wall over to the right, exchange of ceiling shots and then an error by Singer with his right for 2-0, and at this point we made the observation, "Better not get complacent, Stuffy."

Then Stuffy put Ray out on a right corner kill with his right off the serve. Stuffy started off with a lob serve to the right, Neveau returning around the walls, and again Singer erred with his right.

Neveau scored an ace on a hard serve coming all the way over to the deep right side wall low and followed with No. 4 with a kill off the back wall. He was now looking like the player who had earned his way into the prized final championship round. Singer then drove the ball past Neveau on the right off the serve.

A lob serve to the left by Stuffy and he counted his first point on a right hand shooting error. A lob serve to the left on which Neveau moved up and killed it. Singer moved in like a cat and put Ray out on a fine fly kill, but couldn't score in his third inning. Again a lob serve was taken up in the "pocket" by Ray and driven down the right to put his opponent out. After a long volley Singer put Neveau out, taking a ball deep off the right side wall and killing it straight into the front wall.

It was 2-4 . . . lob to the right, a weak return and Stuffy killed into the right corner with his right. Cross court serve, low off the back wall . . . return on volley left hand error by Singer and out. Neveau drove a pass down the right for his fifth point and followed with 6-2 on a straight kill off the back wall. Neveau had a shot opportunity, brought it up too high, and Stuffy took advantage to kill in the right corner with his right and put him out.

Cross court serve that Neveau moved up and tried to fiy into the left corner with his left and missed for 3-6. Cross court coming to Neveau's right . . . scoop shot attempt by Singer with his left misses and he is put out.

6-3 . . . Nice serve down the right by Neveau but deftly returned. Left hand shot by Singer good and he regains the service. 3-6 . . . short on a lob serve . . . lob to the left, off the back wall . . . Neveau's return too hard to handle, low coming off back wall and hand out. 6-3 . . . Stuffy misses with a fly shot with his right — 7-3. Hard serve to right in which Stuffy killed to put him out. 3-7 . . | "Stuffy is going to have to make his move or it will be a three-game match" . . contemplates the scene, very deliberate, serves just short to the right, hit the crotch but not quite over that line. Now he moved to the right, off left wall deep . . . Stuffy missed a setup off the side wall with his right.

7-3 . . . power serve to the left. Neveau shoots and kills on ball coming off right side wall for 8-3 and follows with two more on right hand front wall straight kills for 10-3 . . . ninth point on a "shovel" kill . . . tenth point with Singer hanging back, deep court kill, right wall, front wall. Stuffy then killed off the serve with his left.

3-10 . . . Singer then got back into the ball game with five points to take it 8-10. Nos. 4 and 5 on right hand Neveau errors. Ray tried a "hammer kill" in the left corner and missed on point No. 4 . . . Stuffy was attempting hard, low reverses to the right and just missing aces, and then would lob to the left on his second serve.

Neveau returned high off the back wall and Stuffy fly killed for No. 6. Singer got down low and flattened one in for 7-10 and Neveau took a "strategic" time out. When play resumed Stuffy aced to the right for 8-10. Ray then stopped the rally with a strong pass to the left.

10-8 . . . Ray erred with his right and Stuffy regained the serve. 8-10 . . . three more tallies and Singer went into the lead, 11-10 . . . killing with his left, then an ace to the left, serve to the left, weak return and a pass to Neveau's left. A miss

with his left took the serve away from Singer.

10-11 . . . a pass to Ray's right off the serve and back to Singer for the serve at 11-10. It was 12-10 . . . after three hinders Stuffy served a lob to the left and gained the point when Ray missed with a right hand shot. In the next volley Stuffy hit one of those back to front wall shots but Neveau stayed back and put the return up to the ceiling . . . finally, Ray made a driving shot past Stuffy on the left.

10-12... Ray went back into the lead on a pass to the left, a ceiling shot to the right corner that was too hard to handle, and a left hand front wall kill before being put out on a pass to the right off the serve, one that came low off the right side wall.

12-13 . . . wet gloves time out . . . more action in this second game. Neveau shooting better, Stuffy not getting as many weak returns off the lob serve, changed to the hard, low serves, and also cross court . . . ceiling shots not particularly effective for either . . . so at this time it is an even battle. Note: Bob Kendler waving to the cigar smokers to cease and desist. Serve to the left . . volley . . . to the back wall, low, too hard for Neveau to handle and the score is knotted at 13-13. Neveau then put one up to the ceiling that went into the left corner and was too hard to handle.

13-13 . . . Neveau serving. Serve to the left . . . Ray shot in a kill with his right from three-quarter court for his 14th point, but was put out on a crisp right corner kill by Stuffy's right, taking the ball off the right wall.

13-14 . . . Singer serve to the right, maintained front court position and put one down hugging the right wall which Neveau couldn't handle to once again tie the score. Just missed the ace serve . . . handout on kill into left corner with Ray's right.

14-14 . . .Ray's cross court serve and Stuffy erred with his right. Lob cross court serve . . . Stuffy had a setup off the back wall but banged it too hard but Ray didn't take advantage and was finally put out on a right hand miscue.

14-15 . . . Stuffy tied it on a brilliant "re-kill" of a strong right corner shot by Neveau, diving and putting in the point. Singer took command with two more points to 17-15 with the pressure now definitely on the Oshkosh challenger. It was 16-15 after a

Mike Kelly Champ Class Winner in Nor-Cal Annual

Mike Kelly, flashy Olympic Club star, defeated Bob Des Meules, South End Club, to retain his crown as king of handball in Northern California, by the scores of 21-14, 17-21, 21-14. The Ninth Annual Nor-Cal USHA singles classic attracted a record high of 204 entries, representing 24 clubs, competing in six classes of competition. The 1968 trophy winners in the six classes are:

Championship Class: First-Mike Kelly, Olympic Club; Second-Bob Des Meules, South End Club; Third-Jim O'Brien, Jr., Olympic Club; Fourth-Rudy Stadlberger, South End Club.

Master Class (over 40 years): First-Bob Little, Olympic Club; Second-Harold Dill, Oakland YMCA; Third and Fourth-Dr. Roy Cauwet, Palo Alto Elks vs. Al Sayers, Olympic Club (match delayed).

Junior Championship: First-Jeff Capell, Jr., San Jose YMCA; Second-Gary Ryan, S.F. Central YMCA; Third-Ronald Simpson, University of California; Fourth - Jay Danzig, South End Club.

First Class: First-Al Soulies, Sacramento Elks Club; Second-Denis Moser, South End Club; Third-Ed Mendell, Palo Alto Elks Club; Fourth-Al De La Torre, Palo Alto Elks Club.

Advanced Novice Class: First-Reverend John Shanahan, Olympic Club; Second-Douglas Wedel, Jewish Community Center Third-Joe Cadena, S.F. Central YMCA; Fourth-Wayne Russell, Golden Gate Park.

Novice Class: First-Agustin Uribe, Oakland YMCA; Second-Joseph Mc Donald, S.F. Embarcadero YMCA; Third-Patrick Hanley, Palo Alto Elks Club.

It is to be observed that the 24 above trophy winners represented 11 different clubs; with top club honors going to the Olympic Club and Palo Alto Elks Club, each with five winners of trophies.

Mike Kelly, eighth ranking in the 1967 USHA Nationals at the San Francisco Olympic Club, a brilliant stylist, was forced into three tough three-game matches before retaining his Nor-Cal title. In the quarter-finals, Kelly led young Mike Treacy, O.C., 20 to 14, in their third game, after losing the first 19-21 and winning the second 21-13. The two Irish lads exchanged the serve nine times, with Treacy moving up to 19 points. Kelly finally caught Treacy slightly off balance and passed him with a sizzler down the right side to pull the game out of the fire 21-19.

In the semi-finals veteran Rudy

Stadlberger, a resourceful South Ender, with a house full of trophies, won the first 21-14, by pushing Kelly all around the court. Kelly needed every trick in his bag, plus a youthful edge of about 20 years to win the second and third games, 21-16 and 21-13.

In the finals, Kelly again met Bob Des Meules, South End Club, an ex-professional baseball catcher in the Milwaukee Braves farm system. Des Meules, a determined takecharge handballer, extended Kelly to his limit before yielding the title 21-14, 17-21 and 21-16.

Jim O'Brien, Jr., another new, rapidly improving Olympian, won consolation from a weary Stadlberger 21-10, 21-16. O'Brien also lucked out in defeating spectacular Jerry Cooke, Sacramento Elks Club's hook shoot artist, in a sensational quarter-finals, 9-21, 21-13 and 21-20.

Junior Thriller

The finals in Jr. Championship between Jeff Capell, Jr. and Gary Ryan, San Francisco Central YMCA was considered the most exciting match of the tournament. Ryan, in superb condition, displayed a tremendous back wall kill game and terrific hop serves, to win the first 21-15. He seemed to be a cinch. But, Gary made the fatal mistake of slightly easing his terrific pressure, and lost the second 21-20, in a cliff hanger. The third game was another thriller. Capell maintained his momentum and steadiness, and with a roaring finish finally won the match and Jr. Championship title, 21-14.

Ronald Simpson, University of California physical ed. department, displayed a flossy all-around game to win the third place trophy over Jay Danzig, a rugged South End Club performer, 21-11, 21-14. Several other younger players in Junior Championship displayed future potential greatness, namely; Tom Gallegos, Golden Gate Park, who lost to Ryan, 21-20 and 21-18 and John Parent, South Ender, who yielded to Jeff Capell in a three-gamer. Each of the players mentioned under this Jr. Championship section are destined for rapid promotion into Nor Cal Championships.

Al Soulies, Jr., Sacramento Elks Club phenom, only 16 years old, 6 feet-2 inches, and about 194 lbs, will throw fear into many handball players in the near future. Al moved up two classes since last year and promises to be near the top within another two years. Al survived an imposing field of 48 eager experienced and adult players to defeat Denis Moser, another natural athlete, South End Club, in the

finals 21-15, 19-21 and 21-10.

Ed Mendell, Palo Alto Elks Club, won third trophy from his club mate, Al De La Torre, 21-12 and 21-16. Mendell, a durable, steady performer, is a former West Point footballer and heavyweight boxer.

Real Dedication

Al Soulies, Sr., a Sacramento police officer, tells an unusual story in response to the question as to how his young son developed his amazing assortment of kills and power drives with a slight twist of either wrist at such a tender age. The youngster was a high school pitcher and for a while developed a sore arm. For months, young Al accompanied his dad to the Elks Club where he watched and closely studied the adult handballers in action, without attempting to go into the court to try the game. After months of such observations, the lad spent several more months practicing alone in an unused court, scientifically practicing and trying each shot by the hour. Next, the lad thought he was ready for his first competition. He soon learned that his left hand was weaker. He disappeared from action for a few more months while he practiced alone to strenghten his left, until now he use it proficiently just about as good as his deadly right. The advantage of perfecting each shot in a systematic manner (a system used by the fabulous Al Banuet) has been demonstrated by Al Soulies, Jr., a coming champion from Sacramento, Soulies has a tendency to be overly spectacular with many shots, and will try for a bottom board kill from the rear when he would be able to make a cinch passing drive down the sides. However, young Al will improve with experience and lessons which can only be learned by competition against the wily experts.

In another fascinating contest, Rev. John Shanahan, Olympic Club, beat Jewish Community Center star Douglas Wedel, 21-9, 21-8, to win the crown in the Advanced Novice category. The Padre, employed a theme from the Bible against the strong serves and smashes of his opponent: "A soft answer turneth away Wedel".

The 43-year-old priest from San Francisco, St. Edward's Parish, a left-hander, used a tantalizing overhand lob serve and rally routine along the left wall to pin his opponent deep into the rear left corner. As soon as a decent opening appeared, the Padre brought his deadly hand kill into the play to end the rally, usually in the right corner.

National Convention Meeting Rundown



The United States Handball Association met in convention at the Jewish Community Centers Association, St. Louis, April 30. The 18th national meeting of the Association was called to order by Hymen Goldstein, past national commissioner and 1968 tournament vice president, who welcomed the players. William Kahn, executive director of the Center, delivered the invocation after which Mr. Goldstein introduced the officers of the USHA and members of the local committee present.

Joseph Shane, Los Angeles, national commissioner, was introduced as convention chairman. Mr. Shane thanked the local tournament committee for the use of the JCCA facilities, and for the warm hospitality accorded both players and their guests.

The chairman then called upon those Helms Hall of Fame members of the USHA present to stand and be recognized. They were: Bob Kendler, Hymie Goldstein, Les Shumate, Gus Lewis, Ken Schneider, Bob Brady, and Joe Shane.

Standing committee reports were then delivered by: Bob Kendler, president of the USHA. His report was most informative and inspiring. A copy of his report is included in this issue.

Joe Shane reported on the need for the Association members to continue to support the royalty program from which funds are obtained to carry on the work of financing the Association.

Mort Leve, executive secretary, reported on the activities in the regional tournaments as well as the Contenders and other tournament play and predicted the development of a new crop of handball stars.

George Brotemarkle, treasurer, gave his report on the income and expenses of the Association, emphasizing the fact that the Association had income in excess of \$50,000 and expenses of approximately HERE COMES THE JUDGE!!! \$48,000, leaving a net cash balance on hand of about \$2,000.

Joe Ardito, national juniors chairman, reported on the junior tournament held last December in Tulsa, and emphasized the growing success of this part of our educational program, pointing out the many benefits being derived by the teenagers participating in the tournaments and clinics we arrange.

Bob Davidson, rules and referees chairman, then reported on the present draft of our rules, advising that no material changes have occurred in them except for language clarification and the need for experienced referees to assist in our program.

Pete Tyson, intercollegiate chairman, advised that the young men in our colleges are showing great enthusiasm for the sport of handball and that the last three days of the present tournament would include clinic instruction for these young men in addition to the tournament matches to be played during that time.

John Fabry of the Saranac Glove Company was introduced to the convention gathering. He expressed his thanks for the opportunity of meeting the members of the Association and of his desire to manufacture gloves to suit our needs and particular specifications and invited those persons with special hand size problems to contact him personally.

Ken Schneider, USHA insurance program chairman, reported that the members of the Association

can now purchase \$15,000 worth of term life insurance, and also cover any members of their families, an increase from the previous \$10,000 maximum. He also advised that plans are being formulated to arrange for health and accident insurance, details of which would be reported at the next convention meeting, assuming such a program is deemed feasi-

The Nominating Committee, through its chairman, Bill Binger, recommended to the convention group the election to office of the following persons and offices designated. A unanimous ballot followed.

President - Bob Kendler; National Commissioner Joe Shane; Executive Secretary — Mort Leve;
 Treasurer — George Brotemarkle; National Juniors Chairman — Intercollegiate Chairman — Pete Tyson; Rules and Referees Chairman - Jim Jacobs; National Director of Court Construction and Specifications - Duane Dickey. It also recommended the re-appointment of the area commissioners now serving in their particular locals.

Bids were then invited by the chairman to determine the site for the 1969 national four-wall tournament and convention of the Association.

Ed Kelly, Long Beach, West Area Commissioner, entered a bid on behalf of the University of California at Irvine, having duly been authorized by said university to do so.

Pete Tyson entered a bid on behalf of the University of Texas at Austin, having duly been authorized by said university to do so.

A general discussion followed by the members of

the Association in which the benefits and advantages of each of the college facilities were reviewed.

The convention group thereupon voted to accept the bid of the University of Texas at Austin, and by majority vote the 1969 national four-wall championships and convention of the USHA were awarded to said university.

A general discussion next followed about re-installing the Masters singles tournament. A general and lively discussion followed in which the dangers physically of such a tournament were voiced. However, upon motion duly made, seconded and carried, it was recommended to the officers of the Association that the Masters singles tournament be re-installed and made one of the tournament events at the 1969 national four-wall championships.

There being no new business, upon motion duly made, seconded and carried, the convention was ad-

journed.

MILWAUKEE JCC HOSTS NATIONAL PADDLEBALL PLAY

It was an all-Madison, Wisconsin singles championships and an all-Milwaukee doubles finals as these two cities battled it out for the first National Paddleball "Gut Racket" championships held at the Jewish Community Center, Milwaukee.

Bill Schultz won the singles crown in three games by defeating his partner, William Schmidtke, 14-21, 21-12, and 21-18. Simie Fein and Jim White captured the doubles title with a triumph over another Milwaukee team, Dave Glinberg and Dan Trost, 14-

21, 21-11, 21-9.

In winning the singles titles, Schultz established himself as one of the country's foremost players in the game having won the wooden paddle ball title in 1962 and a runner-up in every tournament since. His smashing backhand shots and kill placements spelled the difference in emerging as the first national champion.

Schultz, a YMCA executive director, has been instrumental in popularizing the wooden paddle game, having initiated two national tourneys in Madison. However, his introduction to the game with the gut racket began on a home and home sociable arrangement between the Madison YMCA and the Milwaukee Jewish Community Center.

He seriously began working out with the gut racket only three weeks before the tourney with a purchase of four rackets and a half dozen Pennsy Pinkies at the JCC from Larry Lederman. His daily sessions on his own home courts with partner Schmidtke reveals the remarkable transformation one can make

to adjust to a new game and ball. Schmidtke didn't do so badly for himself as he eliminated the highly touted Tom Sanicola, Milwaukee's top-seeded star, in the semi finals, 20-21, 21-11, 21-15. Prior to the tourney, Sanicola had beaten all "comers" in exhibition matches and was a pre-meet favorite.

Sanicola paced third in the tourney beating Dan Wood, Lansing, Mich. 21-9, 21-13. In the consolation championships, Sam Carl, Evanston, Ill., YMCA turned back Mike Weiner, Milwaukee, 21-12, 19-21, 21-18.

The doubles tourney was a toss up as the meet got started and nobody had any idea that a Milwaukee combine would climb to the top. Handball stars — White and Fein, who captured the first USHA National Contenders handball tourney in Milwaukee four years ago, teamed up to win this national title as they mixed their handball, squash, and paddleball into terrific melting pot "brew" which spelled victory.

White was his own sensational self as he wielded the racket with deadly accuracy in kill shots and pass placements. He played paddleball as he plays squash and in squash he has won Western Racket titles covering half of the country. He made allowances for the ball to drop very low and then converted them into pass plays which are totally unorthodox in paddleball.

Third place in doubles went to Marlowe and Jay Phillips, a father-son duo from St. Louis. The youthful Jay Marlowe showed promise of greatness as he extended the champion to three games in their singles quarter final match, losing the first 21-7, winning the second 21-18, and dropping the third by a

21-8 score.

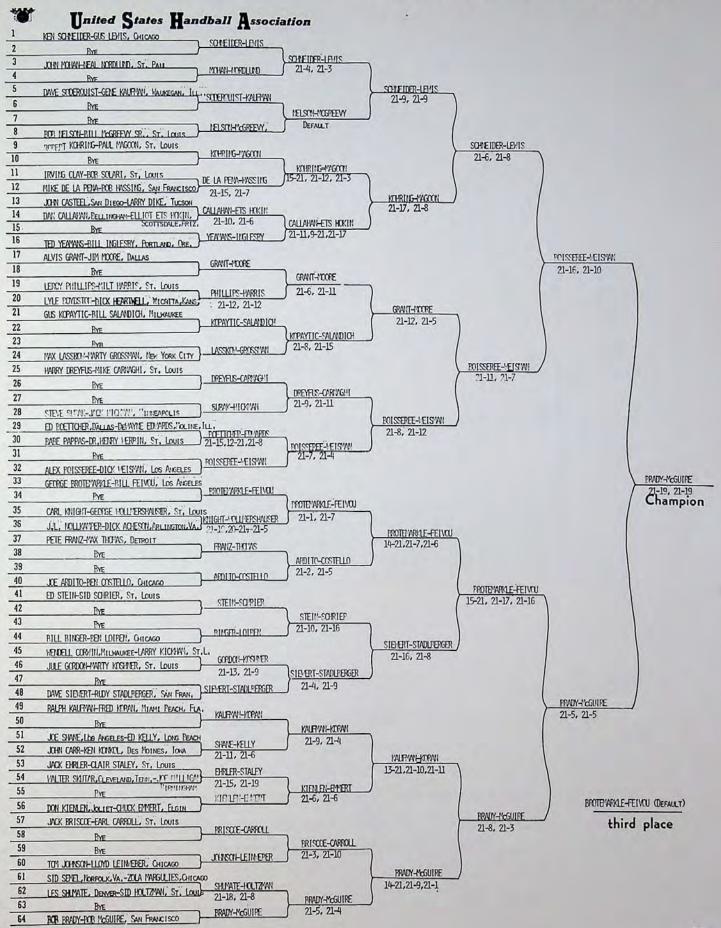

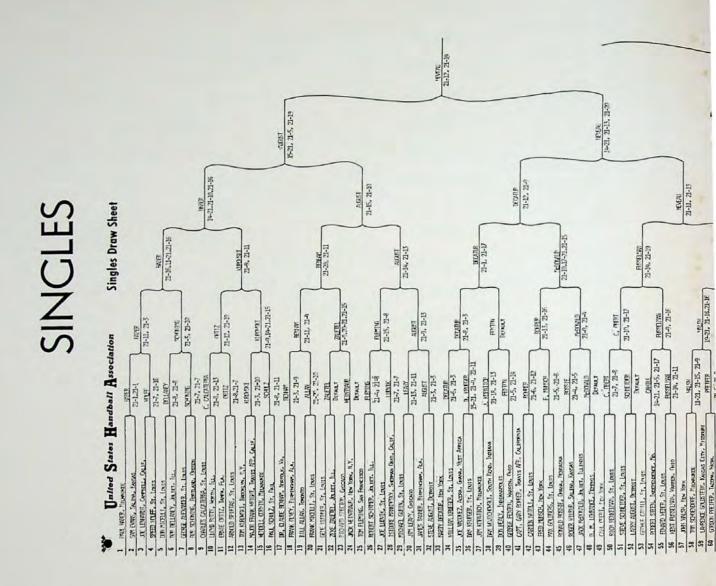

Yambrick, Schulz Spread Good Will, Handball Lore in Extensive Clinic Trip

For four months I had the sincere pleasure to really find out what being a member of this fraternity means.

Last Fall Mort Leve asked me if I would be interested in going on a tour for the USHA, conducting clinics and exhibitions. I had the time available and agreed to do it. Mort put a notice in the ACE and I received many inquiries. After receiving these, we planned our tour route to include the Kansas City Handballesta, Dec. 1-3. We then made a mailing list of Cities where we wanted to go. We started the tour on Nov. 16, and ended it on February 3. I was accompanied on the tour by my good friend, and excellent handball player, Paul Schulz. Paul and I started playing the game of handball under the coaching of Al Warren over 12 years ago. During our travels we met many enthusiastic handballers and had an opportunity to play in many different courts. If any of you hand-ballers are ever in any of these communities, here is what you can look for ward to:

Our first stop was in Duluth, Minnesota at the New YMCA. The Duluth Y has just completed its new building this past year. It's right in the downtown area, about a block from the old building. Upon arriving we were shown around the building by Chuck Henderson, physical director. The Y has an outstanding Health Club and a beautiful L shaped swimming pool. The handball courts (3) are placed side by side and are standard. The walls of the court are poured concrete and the lighting and the floors are exceptional. We conducted a clinic to about 70 people who were seated in a limited, hallway-type gallery with risers. After our clinic we put on an exhibition game of singles. Then I had the pleasure of playing Chuck Henderson and Paul played Jim Mattenin, the two best players in Duluth. By asking a few questions, we found out that they play more paddleball in Duluth than THE GAME!

Next Cedar Rapids, Iowa and the YMCA. Wally Emmons was the man responsible for arranging our visit. When we arrived he was waiting for us and really made us feel at home. In Cedar Rapids we stayed two days and conducted two clinics. The YMCA is an old building but the handball courts are regulation. Because of the very limited

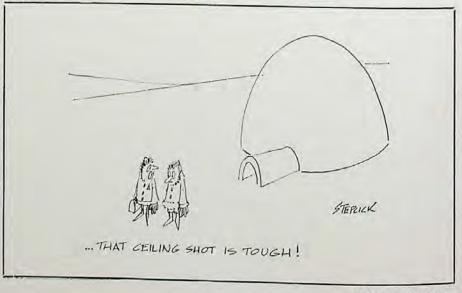
spectator gallery behind all three courts, we had only 35 persons at each session. GOOD NEWS for Cedar Rapids . . . they are planning on an addition to the existing building which will include three more handball courts and a gym. When this materializes Cedar Rapids will have one of the finest facilities in Iowa for handball. While we were in Cedar Rapids they were in the middle of their A, B, C, Turkey tournaments, so we didn't get a chance to play the city champ, Ray Crites. Ray is one of the top players in the State, and not a bad architect either. After our second clinic Paul played Paul Nissen, one of the better players at the Y. I think the clinics stimulated interest, because after each session, we opened it up for any questions anyone might have, and we spent over 15 minutes on this portion of the clinic alone.

Our last town in Iowa was Sioux City and the YMCA. We really ran into a group of enthusiastic handballers in Sioux City. The group is headed by Merle Oakes, chairman of the handball club. The USHA has a real promoter in Sioux City in the person of Perry Swalley, a real fireball. The Y has two 20 x 40 x 20 courts with good lighting and solid walls. The floors have a true bounce and the gallery, with the addition of risers can accommodate about 75 people. We had a full house and then some at our clinic. Paul and I played a one game exhibition match and then I played

the Sioux City champ, Gerald Snieders. Paul played another Sioux City top notcher, Lee Yanney. After the exhibition was over Paul and I were invited over to Skip McGoon's home for dinner. Skip is a local enthusiast and his wife is a darn good cook.

After leaving Sioux City we headed south toward Kansas City, Mo., and the Kansas City A.C. Handballesta handball tournament. We arrived a few days early in Kansas City which gave us a good chance to get used to the courts. The courts at the A.C. are about 18 x 42 x 18. The floors are dark, but very solid and the lighting adequate. They have a very limited gallery behind each of the three courts. What they lack in first class facilities, they sure make up for in hospitality. A lot of the credit has to go to Wayne Berry, the A.C. athletic director. They always have a strong field of entrants in both singles and doubles. Paul and I played in the doubles this year and Terry Muck represented St. Paul in the singles. We were fortunate in making it a Twin City sweep. Terry played Dick Fedro of Des Moines in the singles, and we played Stan London and Al Goldstein of St. Louis in the doubles.

After the tournament Paul and I set out for our next city, and the YMCA. As the handball towns go, Springfield isn't a very large community, only 90,000 or so. But, as for enthusiasm for the game, they rate way up on the ladder in my book. When we walked into the Y, the first man we met was Jerry Lehmann, physical director. Jerry showed us around the Y and told us a little bit about the city and the role of the YMCA in it. He explained, Springfield has only one regulation handball court which was built 3 years ago. He then showed us the other court they've been using before the new one was constructed. Believe me when I tell



you, it looked like a "match box."

After the grand tour of the building we were greeted by the top two handball enthusiasts in Springfield, Rex Roberson and Barry Aton, the city champ. Rex is the one who really got handball going in Springfield. He learned his handball while living in Little Rock, and when he moved, he brought his gloves and knowledge of the game with him. Just before our clinic they arranged to have us inter-viewed by the local TV sportscaster. We had a packed gallery of around 85 people, several from out of town. After the clinic and our singles exhibition, Paul and I each played Barry Aton a game of singles. Barry is only 26 and plays a real fine game of handball. He's also a very fine host and showed us a royal time. As we left Springfield, Rex and Barry told us to tell any and all handball players traveling in the Springfield area to make a point of stopping in, because COMPETITION AND HOSPI-TALITY ARE GUARANTEED!

Next stop, Memphis, Tenn. and the YMCA. The Memphis Y is the home of the glass court, without mullions. The glassed-in portion of the court is along the right side wall. They have 8 ft. sections of glass starting at about 5½ ft. from the floor. This affords excellent viewing for a gallery which can accommodate around 300 people. We presented our clinic to over 100 spectators.

After the clinic Paul and I played our exhibition game of singles and then split up in different courts and played a few of Memphis's finest. The perennial Memphis champ is Jack Gillespie. At the time we were in Memphis, Jack was just getting back on his feet after undergoing knee surgery. Paul had the opportunity to play Jack a couple of games and agrees, with out a doubt, Jack's well on his way back to recovery. I had the treat of playing Paul Schulz's double in a game of singles. Kent Gieselmann is his name, and he's one of the finest players in Memphis. Kent looks so much like Paul you'd think they were brothers. And even when they're in the court, they both throw a heck of a reverse hop. Larry Creson, Jr. is the president of the Memphis Handball Assn., who were responsible for promoting our clinic. They did a wonderful job of promoting and making us feel at home in Memphis.

From Memphis we moved south to Birmingham, Ala. and the YMCA. The Birmingham Y has the best handball complex in the South. They have six regulation courts and four of the courts have partial glass backwalls. The Birmingham handballers are a real enthusiastic group and are very much interested

in promoting the game in any way they can. Our clinic was very well received and prompted many interesting questions by the Birmingham group.

After the clinic Paul and I put on our one game exhibition. Then I had the pleasure of playing Alan Clark, the Birmingham city champ. Paul had a real good match with Danny Kallman, one of the top players in Birmingham for years. The name Dorsky and handball in Birmingham have been synonymous for years. We met Manny when we first arrived at the Y. We were sorry to learn Jack Dorsky, the long-time Birmingham champion, had suffered a stroke, which resulted from a torn muscle in his leg. Jack is making progress and tries to get down to the Y every day and work out a little. Birmingham also has some outstanding young players.

We noticed a 14-year old boy, Brewer Kitchings, who really loves the game and showed us a lot of ability. If he keeps at it, he might just be the Birmingham Y champ someday. Duncan Moon was the individual responsible for arranging our visit to Birmingham. Duncan plays a good game of doubles. Paul and I had a chance to play him and his partner after our singles exhibition. The Birmingham Y is very active in all forms of physical fitness. A true handball enthusiast, Charles Nesbitt, gave Paul and I a personally guided tour around the entire facility. The Y has one of the most complete running tracks I've ever seen. It measures 220 yds., and at one end they have a walking track inside the running track. In the Summer most of the handball activity switches to the roof of the Y, where they have several screened in one wall courts.

The very next day we headed even further south to New Orleans, and the Athletic Club. Much of the interest of the sport of handball in New Orleans is centered at the New Orleans Athletic Club. They have two courts in excellent condition which are a little larger than regulation. The floors have a very true bounce and the lighting is good. The gallery is about 20 ft. from the floor on the back wall and is very limited to spectators. We only had about 35 people for the clinic. Again, after the clinic, Paul and I played a game of singles. Then I played the New Orleans champion, J. P. Blanchard, a game of singles. J. P. plays an aggressive game and is only in his middle 20's. The No. 2 man in New Orleans is Manuel Sala, and Paul played him in singles. After the singles was over we played a game of doubles with Con Demmas and his partner, who both played very well.

While we were in New Orleans

we were the guests of Harry Gamble. Harry owns a hotel in the French Quarter, that has to be the best in New Orleans. The name of the hotel is The Bienville House and believe me it's the greatest, as was the hospitality of all the New Orleans handballers. The New Orleans Athletic Club promotes an annual tournament that has to be ranked with the top weekend affairs in the country. It's the Mardi Gras Invitational singles and doubles. They always have a good draw from all over the country and with all their Southern hospitality you can't help but want to come back for more. Lee Early is the athletic director and does an outstanding job with all the sports at the club. The man responsible for contacting us for our visit to New Orleans was Val Vogel, a real handball promoter and great host.

When we left New Orleans we headed east for Florida. Our next clinic was in Orlando, at the University Club. We had three days to get there from New Orleans so we had a chance to stop and see some of the sights in northern Florida. We drove through Jacksonville and spent the day in St. Augustine, the oldest city in the United States. We then spent a day at the Silver Springs, before arriving in Orlando. Ed Lindblom, Jr., was the man who contacted us for the clinic at the University Club. This Club is a very exclusive social and business club in downtown Orlando. The courts at the Club are constructed entirely of wood, front wall in-cluded. They're in beautiful condition, but it took time acclimating to the crazy bounces. We presented our clinic to one of the most enthusiastic galleries on the tour. Afterward we answered questions for 20 minutes. After the exhibition game of singles, we took on two of the best in Orlando. The outstanding player we saw was Paul Katz, a transplanted Bostonian, who has recently moved to the Orlando area. Paul just started playing again after several years and he showed us he knows what the game's all about. After our clinic at the Club, Paul showed us the town and took us out to dinner and really made us feel at home. It's great to be a handball player away from home when you've got fraternity brothers the likes of Paul Katz. They also have a brand new YMCA in Orlando with two regulation courts. We were told most of the handball activity was at the Y, although we didn't get a chance to see the courts.

After the clinic in Orlando we had three weeks to spend in Florida before we had to head north for our next clinic in Akron, at the YMCA. We spent one week in Miami Beach with Al Warren our

the Western game. The New Yorkers all fly the ball, probably the result of earlier one-wall play. Dick and I both learned to play on small courts where even the low shots would come off the back wall. We learned to kill off the back wall but our fly game suffered. Now, with the standard courts at the University of Texas we have been learning to fly shoot the past four years.

Note: Johnny Sloan, brought up on the low-ceilinged Irving Park Y courts in Chicago, nevertheless learn-ed to fly shoot when he got the word from Jack Gordon, the ex-New Yorker. Sloan would go into the court by himself and practice the fly shots by the hour and this facet of his game helped make him a champion performer. Dennis Hoff-lander, now serving in Vietnam, learned the game on the small 111th St. Y courts in Chicago and has become a nationally-ranked player without a strong fly shot. We are sure, and have stated this many times, that Dennis will gain the top rung only if he works on this "cutoff" shot.

Pete - On this fly shot you let the ball drop, but not necessarily real low because if you go side wall, front wall the ball will die very quickly. If you roll over on top of the ball you can kill it from a higher position. It is a way to keep the ball down from the higher position. Jim Jacobs does this exceptionally well from the short line position. My students will say to me, after watching a film of the nationals in which Jacobs has played, "You tell us to let the ball drop low before shooting it, yet we see Jacobs seemingly shooting from a higher position." What they don't notice is the follow through that gains practically the same effect.

Bob—That brings us to the point. In the old days the players would stroke the ball with their fingernails down. When the fast ball came along it became necessary to stroke the ball rather than slap it with the fingernails pointing to the side wall. Now, give us your description of how the hand should be positioned.

Pete - I believe you should try to play the ball from a low position whenever possible. From there you have the threat of a score. There's only two places you can hit a ball so that it cannot be returned . . . hitting it so low, or passing it. When you take a ball from the low position you have such shots possible. If you take a ball high you can pass but your chances of a kill are greatly minimized. There are some of the older treatises on the game that emphasize the underarm shot . . . I think the most important shot is the low sidearmed stroke.

Bob — Tell us about the so-called dump shot — or fist shot. Explain the dump shot and when it should be used, and the fist shot and when it should be used.

Pete — The dump shot can be used after a weak return when the opponent is in deep court as it is easy to control and need not be powered. The fist shot as employed for ceiling shots has become an important part of the game and can be learned relatively easy. A fist shot, if controlled, can be very valuable with the offhand as a pass when you are head to head with the opponent at the short line area.

Dick — In use of the angles, we find 99 out of 100 players will go to the left side with their shots if they are on the right side. However, you can remain a gentleman, load up the right side with your body and shoot straight into the right front wall, and the worst that can happen if you don't kill it is a probable hinder.

hinder. Pete - It is illegal to block when you have time to get out of the way . . . in shooting in front court with your opponent also up, you should attempt your kill so that the ball comes back and you are between your opponent and the ball. When he's in the middle and you are to the right the best shot is down the right . . . if you shoot the ball right in front of your opponent it's a mistake every time because you have to flatten the ball. When you get your opponent to the right you could shoot front wall, side wall to the left or down the left, keeping your body between him and the ball. Anytime you attempt a kill shot it should remain a good shot even though it isn't bottom board. There are basic rules about attempting kill shots . . . when you are in rear court attempting a kill you had better "let out on it" and you better hit a driving kill and it should angle close to the side wall so if you don't flatten the ball it may still be a passing shot or at least move the opponent back to a defensive, non-scoring position. If he's in deep court with you the side wall, front wall shot can be most effective. If both of you are in front court I believe your best shot is not the corner shots but down the walls where you are between the opponent and the ball . . . but, again, there is the place for the corner shot if

body.

Dick — I have discussed the two player up front position with Jacobs in New York and we set up a rule of thumb . . . sometimes the better player won't win the volley if it gets into an all-out shooting duel. We feel that if you don't succeed in your first kill attempt the second time to hit front wall side wall, a driving pass shot . . . get him out of the front court . . . remember in this front court, fast play you don't have the time to set yourself for the kill and you'll be frantically reaching.

you angle it across in front of your

Getting back to anticipation, Many

of the good players will tend to anticipate a bit too soon, and if you wait longer, get low you are then in position to kill or pass much better. or even punch to the ceiling . . . this will also give you an opportunity to change your shot at the last second as the peripheral vision notes that the opponent has made his move. The real good boys can even change during the swing with wrist action. Vic Hershkowitz used to say, "I load up one of the corners, and then know my opponent must shoot into the other side, and then I anticipate and move toward that area."

Bob — The advantage of scoring with a pass is the fact you not only get the point but a piece of his "guts" as well. And, if you do it often enough you get all of his "guts" and his kill shots don't work anymore. What is your thinking on this, Pete?

Pete — I might point to the Terry Muck-Stuffy Singer match. Terry is extremely fast. Stuffy started slowly and wasn't killing sharply so he went for more passing shots. Terry kept on moving in, anticipating the kill and Stuffy would go for a pass and even though Terry was moving back and making tremendous gets and would return the ball, by the second game we saw a very tired young man, slowed down and ineffective.

Bob — On the serve just how close can that ball come to the body and still be within the rule?

Pete - This rule is not too exact in itself. The finest officials in the country will disagree as to what the shadow serve is. There are a number of players I know who will start off with their "tails" against the side wall, serving down that wall. If the referee hollers "shadow", they'll move out a bit — a couple of inches and try again . . . another shadow call and they'll move just a little more. They will find a point where they can serve as close to their bodies as possible, and if an official won't stop it then it will continue. An effective serve from this position can be rough. Marty Decatur used it against Dick and I in 1962 at Houston. He was serving, not only close to himself but between himself and his partner, Jacobs. He had the advantage of a very good serve, many of them hitting the side wall crotch, and also passing in front of Jim's dark, hairy legs. I played Bud Simpson from Seattle, a gentleman in the court, a big 200-pounder, and he served from that close to the left wall position down the left . . . I tuned my ear for the shadow serve but didn't hear it. At the time I was leading 13-6 . . . I finished with 14 points. I felt these were shadow serves but again. it was the referee's judgment. I think this is one of our most controversial rules.

Dick — It is most important to learn strong serves . . . it is also important, somewhere along the line

to learn that punch to the ceiling because when you are exposed to these serves yourself you can only get the opponent out of front court with this shot. It's not a difficult shot to learn. I didn't learn it until four years ago and it has made all the differences in the world to my game. It will definitely neutralize the serve and give you time to get into center court position . . . it moves your opponent to the deep court.

To you top tournament players. I think it wise to train playing two players at a time with one serve against two.

Pete — In returning with the off hand . . . the punch to the ceiling . . . or front wall, right wall coming back in deep left court is very effective. Otherwise you'll find yourself returning with your off hand to his strong hand, left to right. You've got to catch that side wall out of his reach. This brings us to the two kinds of pass shots. It is obvious if you have your opponent well over you can shoot right down the opposite side . . . the other is use of the side wall — front wall, side wall.

Note: We questioned Ken Schneider on the "safe" second serve. Is there any percentage in going for your strongest serve considering that you might get an ace or weak return?

Ken — No, there is too much danger of losing the serve and this is your big advantage. The Three-wall serve is easiest to control and safe and it still does not give your opponent an opportunity to shoot off the serve and gets him into the volley. Again, the important thing is you can't make a point unless you're serving.

Pete — The ball should be met at the fingers, not on the palm . . . this is where you get the action, snapping off those fingers.

Second part of the question — (When do you shoot?) I like to think of handball basically as an offensive game, and anytime you can get into position you can go for the kill or pass. Why get into a volleying ceiling game unless you are so outstanding that you want to wear the opponent down and know you will make fewer errors?

Dick — In speaking of the ceiling shot . . . it must not be hit too hard . . . keep it off the back wall . . . you want your opponent to take it in deep court with an overhand stroke, or dig it out of either corner. It is a judgment as to how you should play the ceiling shot. And, the ceiling stroke is sort of a flick, a touch.

Woerner New Jersey Singles Champion

Ed Woerner, Plainfield YMCA, captured the New Jersey State Four-Wall singles championship May 10 at the Montclair YMCA, defeating champion John Sabo, Newark YM-YWCA, 21-18, 12-21, 21-5.

Woerner, an unseeded entry, surprised a record tourney field of 43 players by sweeping through five opponents to capture the crown for the first time. He lost only the second game in the finals of 11 he played, and had been relatively unchallenged until the title match.

In the three-game final set, the 33-year-old Woerner rolled out 31 kill shots for points while committing 25 errors which led to Sabo tallies. It was felt that the winner of the first game could probably win the match in two, particularly if the defending champion came out on top. With the score 18-13 in Sabo's favor at the top of the 12th inning, the game seemed to be moving as expected.

Woerner suddenly came to life and tied the count at 18-18 with five points in his half of the 12th, and then shut out Sabo for two frames, picking up the necessary three points in his half of the 14th. Sabo came strongly in the second game, winning 21-12, but it apparently cost him too much, because he could summon no energy for the third tilt. Woerner ran up a quick 7-0 lead in three innings, and captured an easy 21-5 victory by reeling off five points in the ninth and final frame.

The new champion had never advanced past the quarter finals in State singles competition. It was always felt that he had the tools, but lacked the stamina required in tournament play. However, he left no doubt about his conditioning after it was over.

In the second round Woerner conquered Bob Oberlander, Jersey City YMCA, 21-8, 21-6; defeated Jim Westdyke, Paterson YMCA, 21-14, 21-4 in the third round; upset Ed Morkevich, Jersey City, second-seeded and 1967 runnerup, 21-12, 21-18 in the quarter-finals, and dumped 23-year-old Emil Saporito, 21-14, 21-17 in the semi-finals.

The first-seeded Sabo had been pushed a little harder throughout the tournament. He knocked off Bill Kennedy, Montclair, in the second round 21-13, 21-6; edged Harvey Poppel, Paterson, 21-15, 21-20 in the third round; eliminated Fred Romeo, Paterson, 21-8, and won the second by default in the quarter-finals; and outlasted Tom Ciasulli, Orange YMCA, 19-21, 21-11, 21-10 in a 2½-hour semi-final battle.

Officiating by Tom Bria, Ben Buchansky, Sol "Whitey" Lustig, Joe Eichler, and co-chairmen John Schmerber and Bill Kennedy, was outstanding.

PATERSON YMCA JERSEY CHAMPIONS

New Jersey . . .

The Paterson YMCA Handball team captured the North Jersey YMCA Four-Wall Handball League championship by finishing 27 games ahead of the Newark YM-YWCA squad in the standings. The champs, who had placed fourth in a league of six teams in 1967, lost only two team matches out of 20 played en route to the title which they wrapped up two weeks before the season finale.

Second place Newark, which won the crown in 1967, had to defeat the fourth place Jersey City YMCA team 12-0, in the last match to gain the runnerup spot. Newark was aided by Paterson, which handed the third place Orange YMCA squad a 7-5 setback to oust the losers from the second position.

Paterson was led by Captain Fred Romeo, who has played in the league since it was founded in the mid-1930s. While Romeo, 44, is not the oldest player in the circuit, he is the elder statesman of New Jersey inter-YMCA handball competition.

"Back in the 30s, we used to call up some guys from another YMCA and get together for a match on Friday nights," Romeo said. "It wasn't as well-organized, but it was a lot of fun and good experience."

Championships are nothing new to Romeo. He and his brother, the late Nick Romeo, teamed to win the New Jersey doubles title in 1939. Since then Fred has been State doubles champ 12 times with four different partners. He has also taken the State singles crown twice, and this is the third Paterson team he has led to a league pennant.

Romeo was ably assisted by Emil Saporito and Bill Walkowitz, who played first and second singles, respectively, for Paterson. Larry Blomberg, Joe Russo, Harvey Poppel, Jerry Cohen, Ben Buchansky, Bob Ryan, Joe Nardella, Frank Nolan, Mat La-Porta and Jim Westdyke, rounded out the squad.

The league, which was officially chartered in 1953, has been the center of handball activity in New Jersey during the past three decades. Each YMCA fields three singles players and three doubles teams in its Friday night matches which are played from October to March. Nearly 100 men play in the league during a typical season.

Trophies are awarded to each member of the first and second place teams, at an annual league dinner-dance which will be held this year on May 11 at the Far Hills Inn in Somerville.

Singer time out to add the pressure . . . serve to the left and after a short volley Ray erred with his right . . . lob to the left on the second serve . . . serve over when the ball, during the volley, hit the vent which is a court hinder in the Jack Srenco Memorial court (located about 9 feet up on the right and left areas of the back wall) . . . another back wall, front wall return by Stuffy, Neveau shot to the right, a little too high and Stuffy put it away with his right. Serve to the left, weak return, Stuffy moved in with his left and hit it into the floor and Neveau took over the serve.

15-17 . . . With his back now definitely "against the wall" Neveau got a point when Stuffy came in fast on a cripple, banged the ball and hit himself. Big point for Ray . . . Neveau had a back wall setup and shot too high and Stuffy put a right hand shot away to regain the serve.

17-16 . . . Singer made it 18-16 and a third time out for Stuffy. Short serve, moves further to right, serve down the right . . . fine kill into left corner puts him out, exchange of ceiling shots . . . as Stuffy misses comparitively easy shot with his right . . . again a tied score at 17-17. Neveau then took the lead with a kill off the back wall. Cross court serve, off the back wall but Stuffy hit Ray with the ball | . . 18-17 . . . cross court serve, Stuffy took it with his left, shot for Neveau and he grounds it. Had position, Singer behind him.

17-18 . . . Lob to the right, Neveau moved up and went to ceiling . . . Neveau apparently killed in the right corner and the crowd moaned loud and long when the referee called it no good and it was thus tied at 18-18. This could have been disastrous to Neveau but he bounced back . . . lob to the left after the first volley ended in a hinder . . . Neveau drives a fly shot into right corner to get serve back.

18-18... Stuffy missed on a right hand fly off right side wall for a Neveau 19-18 lead. Singer put Neveau's serve to his right into the floor and it was 20-18 Neveau. Ray then shot Singer's return of his serve into the right corner with a fine right and the second game was his, 21-18.

Game Notes: Game changed complexion in last few innings. Looked like Singer was going to have a two-game championship with a 17-15 lead. An analysis would lead to me to believe Singer was inclined to be a little too "loose" at various stages and then when he would make his move to get back in the groove he made some very telling errors, with Neveau shooting much better.

THIRD GAME -

In the third game it was felt that neither player had a particular advantage. Neveau was definitely over his championship "stage fright" and we were sure Stuffy would come out determined to go all out and not allow the damaging lapses that cost him the second game. To win Stuffy would have to be at his best, if not, Neveau would win the title.

Before the match started the ringside "experts" felt that Neveau would definitely have a chance to take it all if it were to go the three-game route, and this is just the situation as the third game commenced.

Neveau put Stuffy out of the first serve with a

right wall-front wall kill after a long volley, and drew first blood when Stuffy grounded a left hand shot. Neveau maintained the short line position, shot with his right and missed.

0-1 . . . It was 1-1 on a pass down the right. Neveau moved in on a ceiling return, and fly killed into the left corner with his right to regain the serve.

1-1 . . . Singer hit a back wall return into the floor for a 2-1 Ray lead. Ceiling exchange . . . Singer in deep court, passed Neveau on the right to take the serve. Tied at 2-2 on a left hand kill after shooting too high off the back wall . . . it was a shovel shot. Stuffy lobbed a return and Ray took it and put in a fine right corner kill with his right to stop any further scoring.

2-2 . . . Cross court, rather soft serve, return off the back wall and Neveau killed with his right for 3-2, then lost the serve on a left corner kill by Stuffy with his right.

2-3 . . . Serve down the right . . . Neveau tried to drive off the serve and Stuffy maintained short line and fly killed with his right for a tie 3-3, then went out on a pass to his right.

3-3 . . . Again a one-point inning as Neveau scored with a right hand straight kill and then went out on a pass to his left. An ace to the left gave Stuffy a 4-4 knot before still another pass to his right put him out.

4-4 . . . Neveau put out on a pass to his left and then Singer went to 8-4 on a fly kill into the left corner with his left, a Neveau right hand error, a pass to the right with his left and another Neveau error, this one off the ceiling with his right. Stuffy was now using his left hand much better and appeared ready to take real command. However he was put out on a right hand error and then Neveau came back roaring with eight points to take an 12-8 lead.

This was accomplished on a left hand error by Stuffy off the serve, a right hand pass to the left, a right hand, right corner kill, pass to the right with the right hand, an ace to the right, a right corner kill with the right, another trustworthy right hand pass to the right, and then a straight kill with his right. Stuffy finally stopped the rally with a left corner kill with his left.

Singer would find himself in command of the vol-(To next page) ley and have several shots but couldn't put the ball away, and then Ray would get his shot and do the damage. The seventh Neveau point was made after Stuffy made one of his back wall to front wall shots, Ray moving in and fly killing into the right corner with Singer left in deep court (a sitting duck). The ace for No. 9 point was a hard cross court serve that came off so low off the right side wall that Stuffy couldn't return it.

Stuffy took a time out trailing 8-12, regaining the serve but was in turn put out on a ball down the left wall that was too hard to handle. Neveau could not pad the lead. Power serve to the left, ceiling return . . . Stuffy shot off the back wall and put him out.

8-12 . . . Serve to the left and Neveau put him out once again. 13-8 on a left hand Singer error before Ray erred in trying to go to the ceiling stopped him from further scoring.

8-13 . . . Stuffy then charged back to tie the score at 13-13 with a five-point inning . . . straight right hand kill, a right hand kill into the right front wall, a pass down the right, an ace to the left, and a fine right hand fly kill into the right corner, and then missed with his right on the lead point attempt. The No. 9 point was on a deep court kill . . . No. 10 hit the crotch off the right wall . . . No. 11 was a shot off the back wall that passed Neveau and then Ray took time out. Quoting Ken Schneider at this pause: "Stuffy definitely has the shots and Ray can't afford to volley with him. When he gained that 13-8 lead he should have thrown caution to the winds and gone for all-out shooting rather than play cautiously as he has done and allowed Singer to close the gap.'

After scoring No. 12 on that ace to the left, Stuffy got into a volley that culminated in a hinder, Stuffy digging up a couple of real tough ones. No. 13 was after a power serve to the right and a fly kill on the return. "Now we've got a real ball game."

13-13 . . . Power serve to Stuffy's left . . . up to the ceiling, then ceiling exchange . . . around the walls, Stuffy to the ceiling. Stuffy got the serve back with a driving pass to the right.

13-13 . . . Stuffy serving from the left, down the left, and gets an ace. And, then to 15-13 on a weak return off his serve on which he killed with his right hand . . . another serve to the left, short . . . lob to the right on second serve, up to the ceiling to Stuffy's left on which he erred in trying to return with his left.

13-15 . . . Lob on second serve to Stuffy and he grounded it . . . 15-15 on a Stuffy fly error off a cross court serve to his right, and then a regain of the serve with a left hand straight kill.

15-15... Lob to the left on second serve and Stuffy flattened his return with a right hand fly shot to make it 16-15... Neveau then took a ceiling shot and passed Singer to the right but couldn't score on his turn, erring with his right.

16-15 . . . Time out Stuffy . . . then a hard serve to the left and Neveau put him out on a pass to the right.

15-16 . . . Serve down the right, coming off the back wall . . . volley, Neveau shooting and tying it at 16-16 with a pass to Singer's left. The points were coming real tough now. Another serve down the right, that came off the back wall . . . and a hinder after a short volley . . . beautiful returns and Stuffy ended the rally with a brilliant, diving shot that went past Ray.

16-16 . . . Again, Neveau stopped Singer, on a ceiling shot to the left that was unreturnable.

Neveau took a 17-16 lead when Stuffy attempted to fly kill with his left and missed, but Ray lost the serve on a left hand, left corner kill.

Then, Stuffy broke things wide open, scoring four

times, going to 20-17, when Neveau erred with his right off the back wall, a right wall, front wall kill with his right, a pass to the left and then an error by Neveau with his left. At 20-17 Stuffy's first serve was a power short to the left, and on his second serve, an attempted lob to the left, he DOUBLE SHORTED and Neveau was given new life.

However, Ray missed with a right hand shot, then Stuffy still couldn't end the match when Ray put him out on a left corner kill with his right.

17-20 . . . Neveau added his last point on a wellplaced ceiling shot, then missed with a right.

20-18 . . . Stuffy Singer then went out and won the game, match and NATIONAL CHAMPIONSHIP, maintaining front court position after the serve and putting in an excellent right hand fly kill to the left front wall.

His Dad, Marty, was the first one to rush on the court to congratulate him, and you can rest assured this was a real big moment for both. For Neveau it was a tough loss but an outstanding tournament achievement for a player who wound up sixth a year ago and who has lost out twice in national contenders appearances.

Stuffy Singer has learned to be aggressive and kill and it paid off with

the national singles championship over Ray Neveau.

He put away more shots throughout the big week than I have ever seen him do before. In my opinion Stuffy would not have won the title playing his former "possum" volley and wait type game. At St. Louis he gunned on every opportunity and scored a fine percentage.

Our new champion still does some sloppy things with his left and

overhand right but now that he is on top he will concentrate and no doubt

rid himself of these bad habits.

It was a great victory over Ray Neveau, who in this tournament reached high level maturity. Ray can shoot, volley, has tremendous desire, and should definitely be back even stronger next year. The strong Wisconsin

lad had one of his finest wins when he defeated Marty Decatur in the quarter-finals in three games, the finale going to 21-20. These two fellows showed tremendous effort in trying for point game and match. It was a tough one for Marty but he gained solace in again winning the doubles with Jim Jacobs.

Play-To-Shape

The grueling three-game match with Decatur didn't slow up Neveau one bit, as he followed with an impressive win over Steve August. One thing for sure, the week-long grind sliced about 20 pounds off the "football tackle" Neveau frame.

August looked good in his match with the two-time winner, Paul Haber. Paul went the singles doubles route though he came into the nationals with a torn side muscle. Give him loads of credit for the try as he wouldn't give up until knocked out of both singles and doubles, loaded with pain-killing pills and shots. He'll be a very determined ex-champion in 1969, believe me.

This was August's best tournament to date. His stamina was much improved and he was shooting exceptionally well. Only the continuous bombing of Neveau kept him

from taking shots.

Buzz Shumate was in real good shape this year. After being down in the first game against Bill Yambrick, he came back blasting and shooting as he can with both hands to take the final two. Yambrick looked great in the first game but couldn't bend too well from that time on.

Shumate then gave Stuffy a real go in their first game but simply ran out of petrol in the second one. Yambrick's comeback battle seemed to take too much out of him.

Benham Not 'Up'

Dr. Claude Benham, the class of the Southeast, disappointed us this

time out. He came in with several imposing credits - Virginia Open, S. E. Regional and National Contenders — but went to a volleying game against August and this was his downfall. What made Claude use these tactics amazes me because he is one of the better shooters in the game, and he was trying to wear down an opponent some seven or eight years his junior.

An unusual game was played by Zeke Zaletel, the muscular young man from Joliet, Ill., against Benham. Zeke got off to a fine 19-5 lead and then had no less than 14 serves to make the 21 points, but couldn't do it. Benham won, 21-20.

Tom Kurowski of New York's West Side Y, proved to be the "dark horse" in his first national effort.

Tom almost knocked out Haber in three.

Jack McDonald lost to Decatur in two games. He must get away from his safe type of play to get into serious title contention. Kent Fusselman was at hisbest in eliminating Carl Obert in two. The Warren, Ohio, fireman is coming strong in both three wall and four-wall play.

Ernie Ortiz, formerly of the New YorkBronx Union Y, now of Tampa, did quite well before losing to Kurowski. Ernie is working with the

youth in Florida.

Paul Schulz gained some measure of satisfaction after a three-game loss to Kurowski by taking the consolations over hard-hitting Gordie Pfeiffer of Tacoma. Pfeiffer is only in his third year of play and should continue to develop fast.

Doubles Repeat

It was a case of back and foot trouble in the open doubles finals.

Jacobs needed Decatur desperately in the first game with the Oberts as his back woes slowed him up considerably. The Oscar-Ruby team was coming fast at the finish of that game but couldn't quite make it and it was an eked out 21-19 win for the defenders. Oscar seemed to

Romeo-Saporito Jersey Doubles Winners

Fred Romeo, winner of 13 New Jersey four-wall handball doubles tournaments since 1939, and Emil Saporito, Paterson YMCA, captured the 1968 state doubles crown at the Plainfield YMCA.

The Paterson team defeated Ray Barrett and Ed Woerner of the host YMCA, 9-21, 21-20, 21-12 in the final match lasting nearly two and one half hours. Romeo, 44, and Saporito, 23, rallied from defeat in the first game to force the Plainfield due to accept the runnerup trophy for the second straight year.

Romeo has now won the N. J. crown with six different partners, one of whom was Barrett, his adversary in this year's finals. Ironically, he and Barrett had teamed to capture the title in 1958.

The path to the title was long and treacherous for the Paterson pair, who did not face an easy foe in the four matches they played. Upset-minded Ed Purcell and Mat Boscaino, Orange YMCA, were eliminated in the second round, 21-16.

21-8, by the fourth-seeded champions. In the quarter-finals they outlasted Don Wernes and John Schmerber of the Montclair YMCA 21-17, 18-21, 21-9, and topped Ben Buchansky and Harvey Poppel, Paterson, 21-12, 7-21, 21-13, in the semi-finals.

Tournament Chairman George Kilday and Head Referee John Ward combined to run an excellent tournament.

The 42nd National YMCA 4-Wall Handball Championships were conducted at the Akron Central YMCA, March 18-23. There were 48 singles entries, 15 teams in the open doubles and 13 teams in the Masters doubles. A total of 91 players participated in the six-day tourney.

The poised and steady Bill Yambrick, St. Paul, became the first handball player since 1937 to capture three consecutive National Y senior singles titles by besting Stuffy Singer 21-19, 17-21, 21-13, in the taut and exciting conclusion.

Singer salvaged a fair measure of glory as he and partner Dick Weisman, breezed to the senior doubles championship over Kent Fusselman and George Fenton, Warren, 21-7, 21-14.

John Sammon and Paul Trujillo, Cleveland, handily defeated Steve Subak and Virgil Mylan, Minneapolis 21-6, 21-12, for the Masters doubles crown. It was the second National Y crown for Sammon and Trujillo, who won the same title in 1966.

Third place in the singles competition went to Al Drews, Cleveland, who polished off Ron Annotico, Cleveland, 21-16, 21-13.

The team of John Sloan-Bob Koenig of Chicago disposed of Tony Felice and Frank Pecora of Cleveland for third place in senior doubles, and the Leon Levin-Luke DiPomio partnership, representing the Philadelphia YMCA, defeated John Hamm and Bill Biederman, Cleveland, 21-7, 21-14 for third in Masters doubles.

Congratulations to Dick Zaveson and his fine handball committee for conducting such an excellent National tournament.

High schooler Willie Yee came along with him to watch the action and then drive back to Lake Forest College with his coach-to-be Mike Dau.

We hope to have the National Juniors at Flamingo Park in Miami Beach next December. With the help of Ed Rubin, the maitre d' of the

Forte Tower restaurant, a member of the publicity department of the city, we hope to make this an annual event there. They hold the annual junior tennis championships during the Christmas holiday period so the junior handball is a natural addition. I think this program would lead to many more friends than you realize and would give you personal contacts in every state in the Union. It is my honest opinion, regardless of what you think now, that one day the economics of this game will force us to adopt something of this nature because it is obvious that the handball explosion has now only begun.

Personally, I get a great thrill tackling these problems. It is like seeing a wonderful family grow up, — or a new business take root and thrive. If you look at a handball map of the nation today, you will discover that we are evolving in a very definite pattern. California is the center of four-wall handball. Detroit is the center of three-wall and New York is the center of one-wall. Wouldn't you think that California, with its wonderful weather, would be a mecca for one-wallers? Or maybe Florida? They have never even heard of one-wall in most of the sunshine areas. Now, the place where four-wall should thrive is New York. Actually, I can't name a dozen four-wall courts there, — and only one with a fair gallery. One wall? I think they have 2,000 in the New York parks alone.

I remember the day I was the speaker at the annual Sports Banquet at Col. Rupert's Brewery. Sitting next to me was Robert Moses, then head of the New York Park System. I casually asked him how many handball courts he had constructed that year, and

he just as casually replied, - 125.

You know in every club there is a strong leader. If he likes one-wall, — that will be the big sport. If he happens to know four-wall better, one and three-wall will be a dirty word. Moses, I gathered, was a one-wall man. The same is true in other areas. Some Irishman way back was the head of the Detroit Park System. He liked three-wall. Now they have three-wall courts coming out of their ears in the Detroit parks. But whether it's one-wall, three-wall or four-wall — The end result is always better citizens and better health.

Little by little handball is being recognized as the lifetime sport. Like Social Security, it is yours to enjoy from the cradle to the grave. You know when we started this Association handball was ranked 13th in popularity at the Y. What do you think it is today? Second! Give me a couple of more years, and it will be first. Then give me a nice big gallery and I will show you how to make \$5,000 profit from a National tournament, just like we have done in every

city that holds our Big Show.

Some of you may not know we run six National, eight Regional and four Divisional tournaments each year. Here is a brief report on these events. We started last year with the 18th International Three-Wall in Detroit on Labor Day weekend. I just can't say too much about the wonderful job John Scopis and his Michigan Handball Association has done. It is the oldest continuous tournament in handball and if you have never been there you haven't lived. Following this, we put on the Fifth National One-Wall in Brooklyn at the Brownsville Boys' Club in October. Irv Ehrlich has the biggest committee to run the biggest tournament in the country and it is our good fortune that he has the biggest heart to go with it. He is a quiet giant and we owe him a lot. In December we put on the National Juniors at the Tulsa YMCA. This is the pride of Joe Ardito and he has reason to be proud. It is a meaningful tournament that builds character as well as skill. The Fifth Contenders followed in Seattle in late February. We have two treasures in the west, - Andy Anderson and the Washington Athletic Club. They do an outstanding job. Our fifth tournament is the National Intercollegiate with its finals this weekend here at the Center. To build up to this event, we run four divisional intercollegiate tournaments in February and March to qualify for the Nationals. The same thing is true with the Senior Tournament now being played. We build up to this event with eight Regional tournaments in February and March also.

You know, this Regional business has become a major undertaking. If you could see the entry list of all eight Regional Tournaments, you would suspect that we are on the threshold of a vast change in handball. There is a tremendous demand for these tournaments, — from many widely separated points around the country. This means, of course, that we may have to give financial help like we do with the Nationals. It means considerable promotion. It also means we must then find a way for the Regionals to make money on their own. This will get the job done.

The West Side YMCA in New York was the site for the East Regional and brought in the metropolitan area players as well as the best from New England and New Jersey. Our Mid-East regional was staged at the Warren, Ohio YMCA and covered upstate New York, Pennsylvania, Kentucky, West Virginia and Michigan.

In Dixie we had the Southeast hosted by Richmond, Virginia. Originally, we had planned to hold it in Fort Lauderdale, but after learning the high cost of in-season-motels, — we thought better to move.

The South Regional was held at the fine air-conditioned facilities of Birmingham's YMCA.

The Rocky Mountain Regional was held at the University of Texas in Austin. Now Austin wants the 1970 Nationals.

Up in the Northwest they separated the singles and doubles. The singles were held in Vancouver, British Columbia. The doubles were held at the new Elks Club in Spokane, Washington. Early balloting indicates this will be a one-shot deal as the players just can't take that much time off.

The Mid-West was held in Milwaukee at the Jewish Center and, like all of their affairs, it was strict-

ly National Championship caliber.

Out on the Coast, a new entry record was set at the West Regional at the University of California's six-court facility in Irvine. There were 266 entries in

the singles, doubles and Masters.

Just to show you how good Regional Tournaments incubate handball, here is a letter from the University of California that accompanied their bid for the 1969 Championships. The Athletic Director wrote: "Here are some points in regard to the 1969 Nationals I would like you to consider. First, we have our own six courts, - two more at Newport Milo Club, - two more at Santa Ana, - two just opened at the Newport YMCA, - two at the Balboa Bay Club and five courts in a club within a mile of our campus, - one of which will be the finest exhibition court in the country. Handball activity at the University has provided the stimulus for this building program, and we believe that the 1969 Nationals would cause us to grow into the leading center for four-wall handball in the United States. Handball at the University of Texas is firmly entrenched because the USHA helped it get that way through holding the 1965 Nationals on the campus. Certainly, California deserves the same consideration. Since we plan to enlarge the present exhibition court through the addition of right and left glass walls and an enlarged back court bleachers. Our future plans call for two courts, back to back, with all walls of mullion-free glass and surrounded by grandstands seating upwards of 4,000 spectators." It was signed by Dr. Henry H. Burke, Department of Physical Education, University of California. Which just goes to show you that you can't stop the handball enthusiasm that is sweeping the country today. This should encourage your clubs and Y's to provide more courts and bigger galleries or watch the colleges take over all the tournaments. The standard practice of calling a corridor a gallery won't help you against this kind of competition.

After the Regionals we run the Nationals. For 18 years men like Hymie Goldstein, George Lee, Bob Hassing, Les Shumate, Pete Tyson, John Scopis, Irv Ehrlich, Wayne Player, Andy Anderson, Alex Boisseree, Al Shepherd, Steve Subak and many others have made this tournament so formidable that all other so-called National events are meaningless. Only the uninformed press, fed by the dying gasps of a decaying A.A.U. continues to report these socials as National Championships. When all this political chicancery is exposed to people of good conscience, another one of the walls of the AA.U. will come tumbling down. It should be noted here that some of our members played in the A.A.U. tournament and although we do not believe in giving the enemy life, we had no objections. You see, one of the rights we fought for was the right to play anywhere we please with anyone we please. So we certainly don't criticize anyone for playing in the A.A.U.'s makebelieve tournaments. We have only one course to pursue, - stage bigger, better and more competitive tournaments than anyone else and never give a thought to our imitators. That will bring all the defectors home, - to the Association that belongs to

Now, our total product is eighteen tournaments a year and what I like about it is we still do it with only one salary, — and no overhead. That's what's fascinating to me about handball players, — every one of them helps, giving something of themselves for the good of the game.

We realize that it is tough for many players to take a full week off for National Tournaments. That's why it it is so important that we promote State and Regional weekend events. The travel costs are thus cut down and the time away from home limited to free weekends. We have witnessed the tremendous growth of the invitational tournaments and it is getting to the point where every weekend of the season finds a worthwhile tournament going on somewhere. In recent years, in the Midwest alone, — invitationals have been started in Oshkosh, Sioux City, Salina, Benton Harbor, Springfield, Tulsa and here at St. Louis the switch was made from the Ozark A.A.U. to Ozark USHA.

On several occasions in the past you have heard me speak about scholarships for our deserving young players. Now, I haven't talked too loud about this because we haven't had all the money we need to make this program a big factor in our Association. Little by little however, we are getting results. For example, in my home town of Lake Forest, — the Lake Forest College has just approved four grant-inaids for some really wonderful kids. At a cost in excess of \$11,000, four of our Juniors will have a chance to study in one of our really good schools. All four of them are National Junior Players, - Wesley and Willie Yee from New York, Steve Jarom from Miami Beach, and one of them is Dave Smith, - son of Phil Smith, the Health Club director here at the Center. The new two million dollar Lake Forest College gym will have three courts, one with glass side walls and seating for more than 300. This is the first step in what I think will be tremendous college participation in our program. I can tell you now that I think we are sitting on a college volcano, — when this erupts it will dwarf anything we have ever done in the Regionals or Nationals.

Besides encouraging Invitational Tournaments we would like to experiment with Teaching Tours in the form of a little world series. Let's take, for example, matches between Haber and Jacobs played in New York and Los Angeles. There should be worthwhile awards with tournament rules and refereeing. Besides settling the question of who is best, — it brings championship caliber play to those unable to come to the Nationals. The teaching value of this Tour

could be far more beneficial than anything we have ever done and we would like to try it. All we need is the nod from Jimmy and maybe Stuffy Singer, Marty Decatur and Bill Yambrick.

You know, we are now federally chartered as a non-profit organization so donations from the membership are tax-free. In fact, we were very gratified when John Eichler of New Jersey made the USHA, the beneficiary of his \$10,000 insurance policy, I am hoping that more of you fellows will do likewise.

The special, USHA life insurance program is also rolling right along, and we have moved from \$10,000 coverage to \$15,000. This is without a doubt the cheapest protection you can get anywhere outside of G.I. Insurance. You can cover your wife and children — all through the benefits of your membership in the United States Handball Association.

We were most fortunate in getting a real film producer in Hollywood to make a professional film for us. The University of California gave its full cooperation and a long weekend went into the actual shooting, Joe Shane, Mort Leve, and I gave technical help . . . Jim Jacobs and Stuffy Singer were the star performers . . . and a brilliant Hungarian, Gabor Nagy, was the Director. The film is in color and is narrated by Art Linkletter. The film will be available on a purchase basis and it is a "must" for every handball club.

We finally solved our glove problem. We just started to market the most improved handball glove ever manufactured. Just like everything else we have done in handball, this is another step forward for the player, the game and your Association. Like the glass gallery, — the standard courts, — the uniform rules and the ACE ball, — The new ACE glove will now take its place as standard equipment in our tournaments. There has been so much controversy concerning glove design that we think the time has come to adopt uniform gloves. There is no reason why we can't all play with the same ball, the same gloves and the same rules. The uniforms and shoes should also be standardized and will be.

John Fabry, president of SARANAC, is not only a very successful glove manufacturer, — he comes from a family of highly skilled glove designers. His father is one of America's foremost glove experts and their firm is more than 100 years old. John is a handball player from Green Bay with that famed Packer spirit. His frankness and enthusiasm in these long negotiations were positively refreshing after years of frustration with the glove trust.

The printing costs of the ACE Tournament issue alone exceeds the cost of your membership. This is only possible because we have never paid rent, postage, telephone, legal or office costs, — you are being gifted this by the lot of men sitting at this head table.

The 76-pages in our Tournament ACE adds up to 600,000 pages of handball news going throughout the world. And when we say "throughout the world" that includes our newest group of buffs, headed up by Joe and Steve Vasquez in Accra, Ghana in West Africa. As you might have seen in the December ACE, — the family practically imported a Rodriguez-planned court and now have upwards of 30 players.

This was truly a bonus year for the membership as far as ACE Magazine goes.

We had 100 pages of instructions and members' names in the December Guide issue.

And, by the time it was in the mails, the member-

ship list was practically outdated, as we had 2,000 new members that came in too late to be included.

Two other publications were printed . . . Championship Handball, a booklet that will be included in every box of gloves and this includes instructional articles from Jim Jacobs, Vic Hershkowitz, Ken Schneider, Gus Lewis, and Bob Davidson, plus our official USHA rules. The other publication also has the USHA rules and 12 pages of the latest handball court specifications, covering conventional indoor and outdoor courts, and courts with glass walls. This publication is being used to cover the many requests that come in to our office.

Finally, no organization can stand still. Your Fraternity will continue to promote the game and give you bigger and better tournaments. It won't be long until we will be fully involved with State Tournaments as well as Regional and National events. That's why we experimented with the Florida State Tournament at Fort Lauderdale and sent the singles and doubles winners on up to the Regional Tournament at Richmond a week later. All you have to do is spread the USHA product gospel — support ACE balls and ACE gloves and then we can spread the rewards that come from such patronage. All we do is turn these funds loose to build up the game.

I would like to conclude this report with a physical fitness comment that should answer all the questions I have been asked about my leg. For two months I was out of handball. And for two months I might just as well have been dead, I meant it. Without handball I wasn't living. Just vegetating. I can't conceive of life without handball. For two months I nursed a torn Achillies tendon. That broke a record of nearly 14 years of almost daily handball workouts.

You know what happened? My whole personality changed. I became a complete sourpuss. My smile vanished. My appetite disappeared. I lost all my enthusiasm, I loafed at the office and my wife even became suspicious.

You know, I always said handball was a cure-all for everything. Now I can prove it. One day I slowly returned to handball and lo and behold, the whole world looked brighter. Business was better, — I am sleeping again and singing again. Everyone noticed the change. My wife trusts me again and the office is a frenzy of activity. Even Mort Leve, who caused all this trouble, looks beautiful. So, let me give you a word of caution. Cherish the days of your handball. They are the best days of your life. Cherish the opponents that make the game such an intriguing challenge. Cherish the Association that returned this game from the dead. But more than all else, cherish the good body the good Lord gave you to play this good game.

And always remember that every night I ask God to bless those who help me help handball.

Benham Retains Virginia State Open Singles

Benham's other recent tourney titles include the singles crown in the USHA National Contenders held in Seattle; the USHA Southeast Regional singles at Richmond; the Old Hickory singles at Nashville. He also had a very respectable second to Jim Jacobs in the New Jersey Invitational Tournament.

Jack Weintraub, New York West Side Y, took third place in the Virginia State, a field of 32 singles players and 15 doubles teams.

Fred DeNuccio and Bill Morecock, Norfolk, downed New Yorkers Pat Kirby and Steve Lott taking the doubles title in three games.

Kirby and Lott, recent winners of the Wilmington, Del. doubles tournament, and the USHA Eastern Regional, took the first game 21-8. Kirby's kills couldn't miss and his excellent serve seemed to stymie Morecock, a rising newcomer to the tourney circuit. Morecock regained his composure and his game and with his experienced partner turned the tide in the second game. Kirby lost his kill shot and DeNuccio further frustrated the New York duo with aggressive play and speed in the front court. The final two games were 21-12, 21-13, with the match and title going to the Norfolk team winners of the Southeast regional doubles in Richmond.

NOTES: Pat O'Keefe, New York, was presented the Sportsmanship Trophy at the annual banquet sponsored by the Norfolk Handball Club for tourney participants and their wives. Weintraub defeated Al Mc Cullock, Washington D.C., in the quarter finals 16-21, 21-17, 21-13. This was one of the toughest matches of the tourney and lasted over two hours. The Straus twins of New York met DeNuccio and Morecock in the semi-finals. Scores were 21-12, 21-15. They lost third place to Fred Lewis, Miami, Fla., and Ken Smolack, of New York. Upset . . . Phil Norusis, Washington, D.C., lost in the first round to Norfolk new-comer, Lt. Garry Zintgraft, 21-14, 21-16. This was the first year since 1956 that Jim Brown, Falls Church, Va., wasn't on hand for the annual Virginia State Open. A fine competitor and sportsman, Jim was missed on the courts.

Fusselman Wins Nat'l Fire Fighters' Singles

Kent Fusselman defeated his Warren, Ohio, partner, George Fenton, in the Third National Firemen's championships held March 26-30, at the New York A.C. Fusselman was a 21-9, 21-14 winner in the 28-player field. He had eliminated Gilbert Maga,, Los Angeles, in the semis, 21-17, 21-5, while Fenton was stopping Joe Danilczyk, New York, 21-12, 21-16. Danilczyk salvaged third place over Maga, 21-20, 13-21, 21-16.

Vic Hershkowitz, all-time national winner, added one more in taking the open doubles with Joe Danilczyk, over fellow New Yorkers, Harry Hyde and Harry Beattie, 21-11, 17-21, 21-7. The Fusselman-Fenton team took third place. They had lost in the semis to the eventual winners, 21-16, 21-12, while Hyde and Beattie stopped Maga and Zink of Los Angeles, 21-18, 21-7. There were 28 doubles teams.

A Masters doubles division tourney was held with Chicagoans Bob Pillon and Dick Giangreco defeating another Chicago duo, Casey and Fraley, 21-10, 21-14, for the bunting.

The championships were sponsored by the New York Fire Department.

If you ever have any doubt that this is a self-governing Association, you should attend one of our Conventions. Like the one at St. Louis this year. It was the healthiest and most enthusiastic demonstrations of democracy at work I ever saw. Everybody got into the act. And that's good. Unlike all the unrest about us, this meeting was full of constructive criticism. We made numerous changes that not all of us agreed with but which the majority wanted. For example, we have always been opposed to a Masters Singles Tournament. But most of the members present voted for it so we went along. On the other hand, some of the members wanted to drop the Consolation which we think is good for the tournament. The voters agre-d with us.

with us.

What I would like to point out to you is that we listen, we learn and as long as the thinking is in the best interests of handball, we abide. There is always a danger, however, that some sudden emotion will erupt and bring about a vote that is neither sound nor progressive. It's like the guy who yells, "Lynch him," to an excited mob. It is important to keep in mind that a very small portion of our membership is in attendance at our annual convention, Your Board of Directors must always try to protect the rights and interests of ALL our members.

When your organization was formed it was based on complete self government by orderly processes. Therefore it became necessary that we provide safeguards against takeovers by self serving opportunists. This was done in a parliamentary way by the election of directors, who, in the final analysis, make all the binding decisions. By-laws provide for a nominating committee of three members of the USHA who shall be appointed by the president of the Association prior to the expiration of the terms of the board of directors, to select and nominate candidates for such office of director. Such list is then submitted to the members of the USHA at the annual meeting, and elected at said annual meeting.

Now there is a very good reason for this. A good example took place at the convention. Some well-intentioned member proposed a staff of referees that would be trained and paid,—thus lessening the struggle for officials at every tournament.

Everybody liked the idea and all were ready to vote for it. Except me. When we get to the point where we can afford another \$5,000 tournament cost, we will gladly appropriate it. Until then we must conserve every penny for our really urgent needs.

Now we liked the idea that the players keep pressing for more and better tournaments and as long as it makes good sense we will go along with any worthwhile, workable suggestion that is proposed. One thing is sure, however. In good conscience we cannot let a small group of uninformed, self-interested troublemakers topple the structure we all have worked so long to erect. Proper parliamentary procedure based on Roberts Rules of Order will always be our order and the only master this Association will ever serve is its members. But I think we have seen enough of the student sti-ins at our universities to know now we cannot trust the final judgment to a vocal minority. Just like in handball, it still takes experience to win the game and to administrate a great Association.

Don't get the idea that our convention was a battleground. There was a wholesome amount of cussing and discussing and the sparks flew just like they do when the score is 19-all in the third game. I thought it was a wonderful meeting and I was proud of everyone who had a voice in it. It was the most meaningful convention of all and to show you how amenable your officers are to good thinking, — most of us thought we were going to California next year when lo and behold, the voice of the members spoke and now we are Texas bound.

We will always liston, fellows, and we will always go along with right thinking. But you should never forget that there are 12 of your fellow members who have given a good portion of their lives to handball and, who, as directors of your Association, have the task of making final decisions. For nearly 20 years this has been the case and we honestly feel with justifiable pride that the results speak for themselves. Our members throughout the years have enthusiastically endorsed our actions after thorough, intelligent and constructive discussion at our conventions. It has proven to be our formula for success and has resulted in a most priceless Fraternity. Let's keep it that way.
