The second tournament of the year will be Oct. 16 through Oct. 18 at the Mt. Clemens Racquet Club. It has 20 courts, two of which are exhibition courts with both the back and sidewalls of glass.

## 1981-82 MRA official rating system

The MRA Board of Directors voted to modify the existing rating system for 1981-82. The following guidelines were approved and will be implemented at the September tourament in Petoskey.

For the men's and women's divisions, the following point groupings will be used:

Open	2000	Golden Masters	1900
A	1800	Masters	1900
В	1600	Seniors A	1900
C	1400	Seniors B	1700
D	1200	Juniors17	1700
Juniors15	1500	Juniors13	1300

#### **GUIDELINES:**

- 1. Winners of each round will gain 5 points and players will accumulate points for BYES and forfeits.
- 2. Losers of any round will not lose points.
- 3. Tournament winners in A, B, C, D and Seniors B divisions will be required to play in the next higher division and will be given the base points of the next division for their next tournament.
- **4.** Any person reaching the finals in 2 tournaments for the A, B, C, D and Seniors B divisions will be required to play in the next higher division.
- **5.** Upon written request, any player losing in the first round of 3 tournaments will be allowed to drop back to the next lower division and will be reassigned the average number of points for that division.
- **6.** In cases where players have the same number of points for any given tournament, a seeding committee for that tournament will decide who should be seeded in what order based on past performances in MRA tournaments.
- 7. The rating list printed by the computer will contain the names of those players participating in MRA tournaments for the current year.
- 8. Points will not be carried over from year to year. The seeding for the first tournament (September) will be based on the final total from the preceding year.
- **9.** In the interest of fair competition, the MRA Board reserves the right to re-classify any entrant.

## MRA Board vacancy

The MRA is a player organization. The board of directors decided to give the general membership more time to nominate those who will represent the ideas they want. This is an opportunity for those with new ideas to have them presented and implemented. And it is an opportunity for those who have been disappointed with MRA policy to help change it. All names must be submitted in writing to one of the present board members. The vote on the new board member will be October 6, 1981.

### **Rules Review**

#### Ten Second Rule

Both Server and receiver are entilted to 10 seconds between railies. The calling of the score by the referee begins the 10-second rule. The receiver, to indicate his request for 10 seconds, must raise his racquet, or otherwise make it obvious that he wants to take 10 seconds. (Kneeling to tie a shoe, back to opponent while adjusting equipment are some other methods.)

It is the server's responsibility to check their opponent for readiness. If the server checks the receiver and finds them ready, then turns and serves, and the receiver then attempts to signal, the serve counts. The server may take his 10 seconds immediately after the receiver by delaying the serve by 10 seconds.

## MRA function and purpose

The recent re-organization of the MRA Board of Officers has resulted in the evolution of a new philosphy and direction for the MRA. Once again, the association will be running its own tournaments. It is our goal to provide racquetball players of this state with high quality tournament experience. To achieve that goal, we encourage constuctive criticism and ideas as the season advances.

## Hogan wins fourth time

One of the least exciting things about the 1981 Nationals held recently in Tempe, Arizona, was Marty Hogan blasting his way to a fourth consecutive title. But while he was doing that, others were busy blasting each other.

Hogan took the crown with ease, losing only one game in the tournament. He beat 11th seed Craig McCoy in less than an hour to collect more than \$35,000.

Along the way, however, Dave Peck, the 2nd seed, knocked out player Lindsay Myers, literally. Following an exchange of words outside the court, Peck hit Myers with a backhand punch. Peck later apologized for embarrassing the National Racquet Club, but not for hitting Myers.

Later, DP Leach vice-president Charlie Drake ripped the shirt off referee Terry Fancher over a controversial call involving a player Drake manages.



## MRA sponsors referee clinics

In an attempt to upgrade the level of refereeing, the MRA will again this year be sponsoring referee clinics. We believe these were successful last year and helped provide members with valuable information. knowledge of how to referee, and the ability to use that knowledge, are key factors in the success of MRA tournaments.
