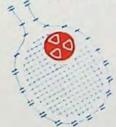

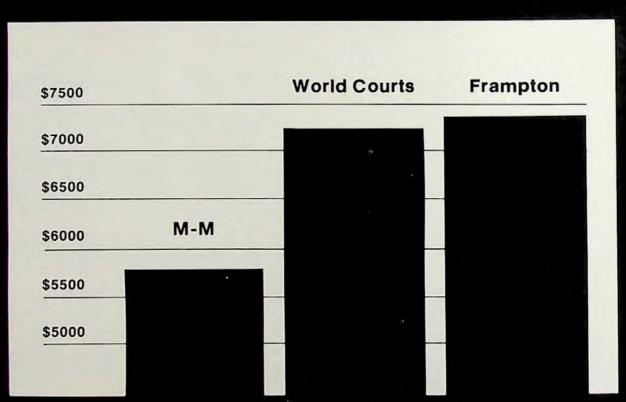

What members are saying . . .

Speak the speech !#&* + & #! trippingly on the tongue . . .

 Again ol' Shakespeare said it best when he commented on the vulnerability of the human condition by saying, "All the world is a stage." Truly all of us in our day to day living reveal the inner man for all to see-both our good qualities and the bad. And if this be true in the world at large, how much more so is it in that microcosm of the racquetball court.

Here, a score of floodlights focus on the near naked man in a white walled pit. In this confined cubicle, one does not need giant telescopic lenses to peer beneath helmeted facemasks as gridiron cameramen attempt to do. Here, every facial grimace, every movement, every word is carefully recorded upon the spectators.

Were Shakespeare alive today, methinks he would smell something foul not only in Denmark but also in the victory charged atmosphere of tournament play,

specifically racquetball championships. The lack of sportsmanship that too often struts and frets on the stage at racquetball tournaments is largely due to a Lombardian ethic that winning is every-

Sometimes tainted advantages are sought under the guise of "psyching" an opponent, i.e., upsetting his mental state so that his physical play is impaired. Many social sins are committed under the name of this so-called "psyching." No need to list these devices to those who play the game. Suffice it to say that they are legion and become the ugly racqueteer.

This is not to say that psychology has no place on a racquetball court. Just as our everyday transactions are filled with psychological ploys, so too do they filter into our play—consciously or unconsciously. It is the unhealthy "psyching" that I abhor; the type that poisons the perpetrator as well as the atmosphere of those who look down from the galleries. Unhealthy psyching is the last resort of desperate men-men who ultimately lack confidence in their ability to beat an opponent on talent and heart alone.

It bears stating that the vast majority of racquetball games are what they should be-a fantastically fast and gripping game of compatriots who believe in fun and fair play. I pen these words more as a caveat than an indictment of tournament play, lest a cancer grow that could curtail the increasing popularity of a game we all love.

Shakespeare was right and Lombardi wrong. All the world is a stage, including the racquetball court where the mark of the man is extremely visible for all to see. Grimaces, a smile, dark looks, how a ball is retrieved for an opponent after a point lost-all reveal the inner man to be a gentleman, a scoundrel, or some gradation in between.

There is a substitute for winning (despite Lombardi's dictum) and that is walking off the racquetball stage a better man, rather than merely a better racquetball player, though I suspect the two are very closely aligned.

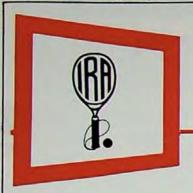

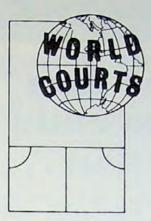

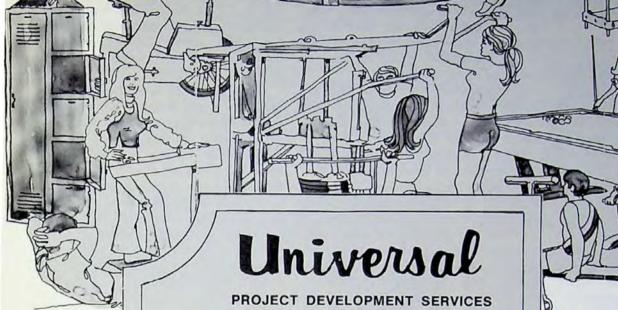

The

5th annual Cowboy Open Racquetball Tournament was held in the Colvin Center, Oklahoma State University campus, Stillwater, Oklahoma, and played over three beautiful days. This year the weather cooperated and gave us some brisk but beautiful days to play. About 275 matches were played between 152 entries (largest ever) in those three days.

Fourteen brackets were played this year—A, B, women A, women novice, men novice, seniors, "masters" (over 40), open doubles, B doubles, masters doubles and special Stillwater division (men's and women's brackets).

A surprise party

Nine of the best woman racquetball players in the nation showed up at the beautiful Muehleisen courts in Del Mar, California, in response to invitations sent out by Dr. Bud Muehleisen. The event wasn't a party. It was to decide who's best.

To that extent it was a surprise party, and sitting in the position of the guest least likely to be surprised was the unflappable, and unbeatable Peggy Steding. Peggy knew that. Thousands of miles away, in New York, Charlie the Gar" Garfinkel knew it. Somehow Janell Marriott did not know that.

On the closing day of the tournament Peggy and Janell met in the last match of the tournament. Each had taken the measure of seven other players. Oddsmakers were already assuming they knew the outcome of this one, but with Peggy Steding deserting her usually strong offensive game in favor of a defensive attack—ceiling balls, rather than shooting—the tables were turned and Janell, unquestionably one of the sport's best women players wrapped up the one game 31-point match by a score of 23-31.

She had dropped Peggy Steding-

Super-Girl, cape and all—by a surprisingly sound margin of 8 points.

Garfinkel, on being asked to write the story on the Del Mar Invitational, replied that his readers already entertained a credibility gap that would not withstand further onslaught. Being assurred that Steding had in fact lost by eight points, Gar expressed his congratulations to Ms. Marriott, Commiserations to Ms. Steding, and said, "Yes, but have you heard what she did to the opposition in Milwaukee!"

The invitational had been accepted by nine players: Marriott, Steding, Jenny Harding, Jan Pasternak, Sue Carow, Jean Sauser, Ruth Knudson, Bette Weed, and Camille McCarthy.

With an array of talent such as this, anything could have happened. Only by the accidental luck of the draw was it that the most suspensful game was also the final game. Throughout the Invitational fans were treated to continuously exciting exhibitions of top-flight action by these pro and semi-professional players.

The news media was on hand. Two newspapers and a television crew covered all or parts of the tournament. The spectator viewing at the courts was excellent, and the crowds enthusiastic.

One of the women remarked that, win-or-lose (and she much prefers winning), the receipt of an invitation to play in the Del Mar surroundings, was in itself an honor, and Dr. Bud's hospitality made the acceptance a pleasure. Too, there was prize money.

Janell Marriott's eight-straight game round-robin victory over competitors who are not accustomed to losing was sweetened by the award of \$250 prize money. The Utah lass earned it, and the invitational could well be an indication of where she will place in national standings for 1976. Incidentally, the prize money came to about \$1 for every point she scored in her eight games.

In the Marriott-Steding match, the crowd was on the edges of their seats throughout the affray. Until the game reached 14-all, there were never more than two points separating the two women.

From that point on the action became more intense as the scoring proceeded by never being more than one point apart until 23-all was reached. Ensuing rallies were long and punishing.

Tidewater Military Championships

Army over Navy; Parker pulls upset

The weekend of 16, 17, and 18 January attracted some of the top military racquetball players on the East Coast to the Naval Amphibious Base, Little Creek, Va., for the 1976 Tidewater Military Racquetball Championships. Over sixty players participated in men and women singles competition, with a consolation tournament conducted for all first and second round losers.

In the prestigious men's open singles tournament, Captain Buzz Parker, USA, Ft. Monroe, Va., upset the number one seed LCDR Glenn Allen, USN, Comnavsurflant, Norfolk, Va., in a tightly contested three game match. Final scores were 21-6, 11-21, and 21-19. Enroute to the finals, two of the top eight seeds from a draw of 52 were upset; with LCDR Pat Drennan, USN, Washington, D.C., defeating ABCS Tom Madison, USN, Norfolk, number four seed in the round of 16.

and LTCOL Chuck Lake, USA, Norfolk, upsetting LT Larry Ryan, USN, Norfolk, number six seed in the round of 32.

Men's semifinal action was completed Sunday morning, with both matches drawing large numbers of spectators. In the upper bracket, Allen defeated Fred Mehne, USA, Ft. Bragg, N.C., 21-19, 21-11, after losing the first game, 20-21. This match was one of the best of the tournament, lasted two hours, and resulted in the destruction of racquets by Allen, before finally win-

Military Newsletter Number 5

Dear Military Racquetball Players,

I would like to take this opportunity to recognize two hard-working service commissioners: Lt. Cdr. Glenn Allen, Navy Commissioner, and Major Mike Stankosky, Marine Commissioner. Both new commissioners have been active in the advancement of racquetball.

Glenn Allen was the tournament director for the biggest military tournament ever held. He and Tom Madrin ran the East Coast Interservice Championships at Little Creek, Virginia, and did a superb job with 110 players.

One of my goals as Military Commissioner was to establish a true inter-service championship tournament to find out what we have in the way of players, and who might be number one.

This dream has now come true. The first annual Interservice Racquetball Championships will be held this September (1976) at West Point, New York. We wil have open, B, seniors, masters, women, and open doubles.

Transportation, lodging, and food will be at the players' expense. West Point has under construction at this time ten regulation courts. Applications will be sent to all military bases in the U.S. Watch for them. The winner goes directly to the national finals.

Points of contact are still needed at many posts and bases. Please write your service commissioner if you would like to help promote military racquetball.

Many military tournaments are programmed for the year. Jack Rashleigh, European Commissioner, has the first European Championships coming up soon. The New England military tournament was recently completed as was the Tidewater military championships, both of which are reported in this issue of the IRA magazine.

NOTE to tournament directors: be sure to get your tournament results typed and mailed to the IRA as quickly following an event as possible. For brackets to appear in the Scoreboard, have a typist follow the style in the magazine. When photos accompany your stories, be sure to identify everyone in the picture.

In my conversations with racquetball players around the country I have found the growth of this fantastic sport is even greater in the military than it is in the civilian community. A few things bother me about the sport at the military level. Foremost is the issuing of wooden rackets, and along with that, the lack of tournament experience by military players.

We want to take some positive steps to expose as many players as possible to the intricacies of this game. The knowledge gained by watching a state level tourney will greatly increase anyone's game. Participating is even better. Here in Massachusetts the military has been well represented, and placed as follows in the 1976 state singles: open, 2, 4; seniors, 1; B-division, 3, 6, 7, 8.

In every state we should have at least one military player in the semifinals of every event. Get hot.

TIPS: If you are having trouble getting what you feel is proper support for racquetball from the special services officer, try this course of action: ask the special services officer to play with you. Give him the old sales pitch. He might not understand the game, or its popularity. Financial support only comes after he is on your side, and has a feel for the game.

Try to get a few of the key officers and NCO's on post interested in playing. Their support will open many doors that otherwise might be closed.

A good racquetball program on post requires Special Services support, interest of key people, and enthusiasm of all players (dedication helps), and finally a place to view the game. These key factors are all present at Fort Huachuca, Arizona; Fort Devens, Mass.; and Little Creek, Va., where some of the best players in the military have come from.

If you have any problems, please contact your service commissioner. Last: get a friend to join the IRA this month.

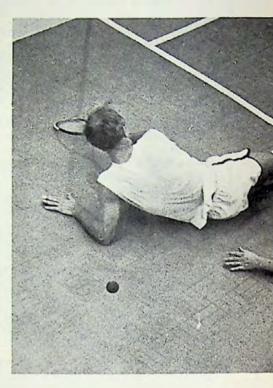

CLEARWATER, FLA.—If he had made the statement after winning the 1976 National Invitational Masters Singles Tournament, it would have sounded conceited.

But, in sizing up the field before the tournament held January 24-26 at the Clearwater YMCA courts, Gene Grapes of Irwin, Pa., came off as honest and prophetic.

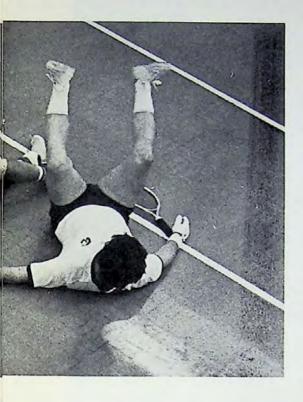
"This will be the best, the toughest Masters tournament ever," wrote Grapes in accepting a bid to play.

As he predicted, the talent in the tournament was so close that Grapes won the title on the last day of the tourney, edging an exhausted Bill Sellars of Dallas, Tex., 186-185.

"Upsets" became the order of play as each of the eight players who completed the 10-man, round-robin tournament managed at least one victory.

Fittingly, an "upset" decided the title as Sellars, the 1973 champion, lost, 27-13, to Earl Dixon of Indianapolis, Ind. Sellars went into the match knowing he needed 14 points to tie Grapes,

who earlier that day had defeated Bob Troyer of Lake Bluffs, Ill., 27-24, after coming back from a 10-point deficit.

The battle for third place was also close as Pat Whitehill of Cheney, Wash., edged Dixon, 27-24, in the last match of the tourney to wind up with 175 points. Dixon had 172 points.

Richard Walker of Dallas, Tex., was fifth with 154 points. He was followed by Troyer, 148, Tom Stidham of Clearwater, 140, and Joe Zelson of St. Louis, 101.

The tournament's two casualties were Joe Brechard of Waukesha, Wis., who suffered a shoulder injury after running into a wall while chasing a ball, and Ivan Bruner of Madison, Wis., who was forced out with a foot injury.

"Even though John Halverson (the defending national masters singles champion from San Diego) couldn't make it this year, I think we had the strongest masters tournament ever," said Stidham, who, as president of the Clearwater YMCA, was the official host for the tournament, and, as a mem-

ber of the selection committee, had a hand in choosing the players.

"I feel a lot better about placing seventh here than eighth last year. This tournament was a lot stronger. Every time two of these guys walked out on the court, one was capable of taking the other," he said.

As if to prove his point, Stidham knocked Sellars's title hopes for a loop by beating the Texas doctor, 27-22, on the tourney's opening day.

Other "upsets" included Stidham over Dixon, 27-15, Zelson over Walker, 27-6, Walker over Grapes, 27-19, and, of course, Dixon over Sellars, 27-13.

Despite the upsets, Grapes didn't back into his title. He won five of seven matches, defeating Stidham, 27-17; Zelson, 27-5; Troyer, 27-24; Dixon, 27-13, and Whitehill, 27-11.

His only losses came against Walker, 27-19, and Sellars, 27-17.

Grapes, a former handball player who waits until the last second before striking the ball, played his final match of the tournament early Sunday and then waited with a 186-point total as the action drew to a close.

Sellars, the only player with a chance to catch Grapes, saw the title escape in the 27-13 loss to Dixon, but he probably lost the championship in an earlier match that day against Walker. Although he won, 27-25, Sellars was on the court for more than an hour and a half against Walker and came into the match against the fast-moving Dixon tired.

As the score mounted against him, Sellars tried to summon reserve energy and climbed to a point of tying Grapes before the end came.

Grapes is a former Golden Masters-50 Doubles Champion, having won the title with Sam Caliazza of New Castle, Pa., in 1973.

The tournament was the first national racquetball tournament held in Florida, an indication of the tremendous growth of the sport in the state.

The University of Maryland was represented by Maryland Doubles Champs John Devlin and Charlie "Joe" Sullivan (1st seeded) and the much underrated Chuck Duda-John Cowan combo. The Players Club, congenial host to the tourney, was represented by two promising athletes Rick Kroos and Doug Creamer. Mike Stankowsky and Fred White of Whitemarsh had high hopes, as did veterans Don Potter and Don Huber from Towson. Rich Dreisen of Rockville and Tom Whipple of the Players Club (2nd seeded) rounded out a contingent ripe for upsets.

First round action pitted Devlin-Sullivan against Halperin-Corby in what was expected to be a "routine" match.

As it turned out, John and Charlie had their hands full with a hustling, shooting team, and got by 21-13, 21-15. Stankowsky-White and Walker-Goldberg fought long and hard, with Howard and Paul coming out on top in a tough three gamer, 21-7, 16-21, 21-16. Fred White suffered a badly bruised shoulder during the match, causing the Whitemarsh duo to forfeit in the consolation rounds. Rick Kroos and Doug Creamer were psyched for their match against Meringoff and Goldstein, but the veterans manipulated the volleys in their favor winning, 21-9, 21-5.

Second-round activity was less heated than expected, with Cutler-Baker downing Duda-Cowan, 21-9, 21-7, Whipple-Dreisen defeating Walker-Goldberg, 21-6, 21-4 and Potter-Huber defeating Goldstein-Meringoff, 21-13, 21-20.

In the upper bracket of the semifinals, spectators got tense as Dennis Baker and Tom Cutler took game one away from Sullivan and Devlin, 12-21. Games two and three had Baker-Cutler with early leads, but the Sullivan-Devlin team were cool-headed and won, 21-15, 21-11. 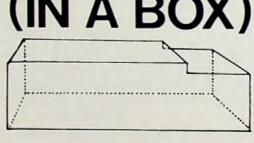

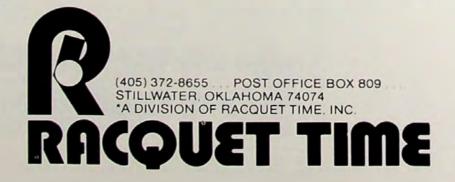

Remote control panels monitor court status throughout clubs

An electronic court monitor that shows when a court is open—or is scheduled to be open—has been introduced by Universal Fitness and Recreation Consultants (a division of Olympic Sports Products), a Miami, Florida, based firm that is associated with Sports Unlimited, Stillwater, Oklahoma, in supplying quality equipment to court clubs.

Players regard the Monitor as the greatest innovation since the game was invented. At a glance they can tell how much longer their scheduled court will be tied up, and with the aid of remote availability panels, the Monitor extends its information service to any part of the club—the lounge, locker rooms, refreshment bar, or pro-shop.

The electronic panel saves players the bother of continuously checking to see whether their court is open . . . wondering how much longer it will be, and endless trips from the lounge to the court. The convenience for any court club is obvious, and for tournament play its performance is a life saver to floor managers.

Both management and players have been plagued with keeping track of court time, and associated problems. The Monitor operates most efficiently, says Universal's consultants, with six or more courts. The electronic system registers availability, time the court is in use, and overtime. Electronic recording of these items simplifies bookkeeping, and is generally regarded by players as more accurate. Time, and overtime are recorded on digital readouts and indicated by a red light on the Monitor panel.

The operator, at a glance, can tell a player what courts are open, and when others are due to be open.

Players and court club managers are familiar with the player who consistently abuses his time schedule. Although the Monitor can't cure him, it can do much to curb his abuses. It is difficult to



argue with, or brow-beat a time clock.

Optional equipment increases the effective use of the Monitor. The system can include an inter-com, public address system, control for locking and unlocking court doors, and a remote light signal to alert players their scheduled time has been used (after which the Monitor records overtime).

The console can be designed to include separate controls for lighting and air-conditioning in each court—a huge dollar savings when courts are not in use, and a huge player bonus when additional cooling is demanded.

The remote availability panels are also optional, and efficiency would depend on the size of the club. Such extensions can be placed anywhere in the club for easy reference.

ning. In the bottom bracket of the semifinals, Parker easily defeated Drennan, 21-16, 21-8, in a warmup for the finals. Third place was captured by Drennan, in a tough three game, 8-21, 21-10, 21-15, victory over Mehne.

For the first time in military racquet-ball competition, a women's division was conducted and resulted in much interest, and some hard fought matches. The women's finals pitted 1975 Military East Coast Champ, Helen Rios, USMC, Parris Island, S.C., against former Eastern Regional Women's Champ, Patti Gurson of Norfolk, Va. When the match was completed, Miss Gurson had won with a surprisingly easy 21-14, 21-8 victory. In the semifinals, Miss Rios defeated Sue Cumminger, Norfolk, Va., while Gurson

defeated Judee Lyons, Norfolk, Va., in two well played matches. The third place award in the women's competition was captured by Cumminger, who defeated Lyons, 21-3, 21-17.

In women's consolation, Lou Hledik of Norfolk, Va., captured top honors, with a 21-14, 21-15 victory over Marge Leach also of Norfolk. The women's competition added much to the interest and participation in this first Tidewater tournament, and reflects the tremendous growth of both men and women's racquetball on military bases around the country.

The men's consolation tournament commenced with 32 entries, and was finally decided in a close three game match, 21-6, 16-21, 21-15; won by Major Gene Elias over Major Tom Young. Both Young and Elias are stationed at the Armed Forces Staff Col-

lege, Norfolk, and are members of the United States Air Force. Third place in men's consolation was won by Petty Officer Kurt Heber, USN, CINCLANTFLT, Norfolk, who defeated Ryan in three close games.

Naval Amphibious Base, Little Creek, Recreational Services graciously assisted in the planning of this tournament, and reserved all three courts for the weekend so the matches could be played without interference. Their cooperation and assistance, as usual, was outstanding in all respects. Glenn Allen, Tom Madison and Richard Brown organized and ran the tournament. It is anticipated that many of the same top military players will meet again in the Fifth Naval District Racquetball tournament to be held in February, at the Naval Amphibious Base, Little Creek.

Getting strung out . . . by Steve Dunn

Probably the most common questions asked by new members deal with racquets. Obviously, from the way the pro shop is stocked, there are lots to choose from.

All racquets have different qualities and all react differently when the ball rebounds off the front wall, strikes the strings (hopefully, square on the middle) and then zings back to the wall at Article and photo on this page courtesy the Supreme Court's "Court Reporter," edited by Rod Delson. a controlled velocity and height. (At least, that's the theory.) Most common are racquets of fiberglass, aluminum and laminated wood and graphite.

Materials

Aluminum: These are extremely durable while still being very light and easy to wield. Usually a year's guarantee on frame breakage because of durability. One disadvantage is that aluminum is rather inflexible and so sacrifices somewhat in ball control.

Fiberglass: Not as durable as aluminum but much more flexible giving better ball control. Flex allows the ball to be "held" on the strings longer, making it more probable the ball will go where your arms is directing it. A 90-day guarantee is the usual.

Graphite: Both durable and flexible. Graphite is a more expensive racquet material and so can be prohibitive.

Strings

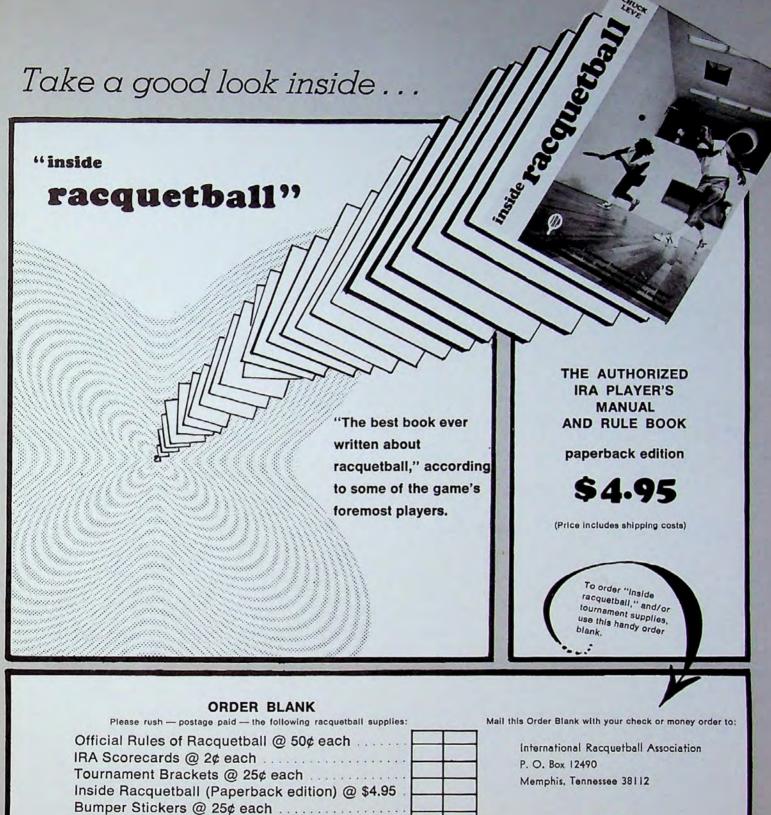
Tension: No racquet should be strung tightly, certainly never as tightly as a tennis racquet. The tighter the strings, the more chance that the ball is going to rebound too quickly off the strings without control. Strings should be no tighter than 28 pounds. Charlie Brumfield, national champ, strings his racquets at 18 pounds.

Strings: Gut strings aren't very common in racquetball. They tend to shred too quickly due to the excess friction caused by the rubber ball. A good nylon string such as Victor Sta-Tite is recommended.

Grip

Size is the important determinant. Don't equate with the grip of a tennis racquet. Tennis grips are big for one reason, to keep the user from "breaking' his wrist in guiding the ball over the net. In racquetball, using the wrist is vital to giving the ball speed. Find a grip that is comfortable and allows ample wrist movement.

The General Membership Meeting and Election of board members is scheduled for Sunday morning, May 30, 1976.

An unexpected treat: over 800 seating capacity

Competitors at the 8th annual IRA international championships this Memorial day weekend, will provide an initiation—a baptism as it were—of the newest set of courts available. At press time construction was still underway, with promise by the contractor that all work would be completed on or before April 10.

It is hard to find newer facilities than this.

Alex Guerry describes the courts as providing some of the best spectator arrangements he has seen. The exhibition court has a full glass backwall, side-walls of glass from the four-foot level to the ceiling, and in the front wall a television window. More than 400 people can be seated about the main court.

All courts provide permanent seating, and some of the best viewing is made possible by having the courts sunk four feet below floor level. Glass back-wall panels to within three-feet of the ceiling provides excellent viewing. These six courts, seat an estimated 75 people each.

From the spectator's point of view the all glass courts are most attractive; from the player's point of view, those with no glass are preferable. The Chattanooga courts in the DeSales Harrison Racquet Center on the University of Tennessee campus provide a compromise, giving viewing facilities without unduly interfering with play.

As the game continues to attract public attention, news media—television, radio, and newspaper personnel, as well as fans—must have a means for covering the major events. Guerry feels the Chattanooga courts have been ideally designed for just such news coverage . . . and fan viewing.

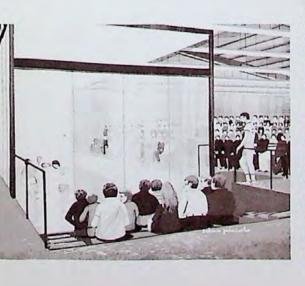
The building in which the University of Tennessee courts are located is an un-pretentious all metal building, with little in the way of "creature comforts." Guerry said the DeSales Harrison Center will be used 98 per cent of the time for university students and faculty, and to an extent by local high school players from the Chattanooga area.

Locker rooms are quite simple but adequate, having been designed for student use, rather than catering to a paid membership clientele, as would be found in many private clubs.

The DeSales Center, on campus, is seven blocks from downtown Chattanooga, ten blocks from the YMCA, and nine to ten blocks from the main motels.

The university gymnasium, with two racquetball courts and larger dressing room facilities is one block from the DeSales courts. The YMCA has four very fine courts and excellent dressing room facilities.

The IRA invites as many members as can possibly make the trip to attend the 8th annual membership meeting and international championships; Chattanooga welcomes you!

San Antonio Pro-Am Tour report

San Antonio makes it three in a row for Steding and Brumfield

The second leg of the 1975-76 IRA Pro-Am racquetball tour was held in sunny San Antonio, Texas, at the Racquetball and Handball Club of San Antonio. After three and a half days and some 300 matches the results were the same as they had been in the last three IRA Pro-Ams—Charlie Brumfield and Peggy Steding carted off the titles.

Winners in other events were Eric Campbell,
Dallas, in the men's open; Lyn McKie, Memphis, in the
women's open; Dr. Bud Muehleisen, San Diego, in
the seniors; Dewey Strickland, Houston, in the masters;
Mark Malowitz, Houston, in both the juniors and
"B" division; Mark Norenberg, Houston, in the men's
novice; and Neysa Buckley of College Station, Texas,
in the women's novice.

In the women's pro-division, Peggy Steding was devastating. Anyone who thinks she has slowed down just hasn't seen her play lately. In the finals she met Shannon Wright, who many consider heir to the throne.

It was no contest, as Steding came out firing. An 11-0 lead in the first game led to a 21-5 victory. In the second game the final score was 21-16, but Steding took it more easily than the score indicates. She was

hitting the ball so hard she gave Wright no chance to set-up, and constantly kept her off balance.

The semifinals contained one close match, and one that was not. Shanon Wright and Jan Campbell, San Diego, staged a tight battle with Wright winning 21-11, 18-21, 21-14. Campbell showed no ill-effects from her recent knee troubles, and the match was nip and tuck until midway through the third game when Wright's serve forced several weak returns and she gained a commanding lead.

Steding had little trouble with Jennifer Harding, Portland, Oregon, in the other semi—21-12, 21-8. Harding played well throughout the tournament including a quarterfinal win over Jan Pasternak. However, Steding simply dominated the match and forced her the play.

Harding came back to gather in the third place check with a two game victory over Jan Campbell. Winning the two fifth place checks were Pasternak and Lynn McKie (a quarterfinal loser to Campbell).

Men's Pro

The men's pro was not a typical Brumfield breeze. When asked what he was going to do after the tournament, he replied, "Go back to San Diego and practice. I'm worn out." It was not that Brumfield was not in condition, so much as it was the ever increasing strength of the competition.

In the six pro-tournaments—San Antonio and five previous ones—only one name has appeared more than once in the top two finishes—Brumfield. Seven other players have made the finals but only once each.

The surprise of the tournament was St. Louisan Jerry Hilecher, who blasted his way past Schmidtke, Serot and Hogan to reach the finals. Hilecher's game had not been what he wanted it to be lately, so a week before the tournament he dug deep in his discarded

racquet bag and pulled out his old favorite—a 1971 Ektelon with a blue bumper. The racquet looked as though it had been through several wars, and had an odd configuration to match. But, suddenly Jerry Hilecher was playing the best racquetball of his life.

Then, two days before the tournament, the racquet broke. Somewhat skeptically Hilecher began again with a brand new racquet. Evidently the old racquet had helped him get over his psychological hump, for Jerry continued to play brilliantly.

The finals—as the saying goes—were closer than the score indicates. In the first game Brumfield jumped off to a fast lead, and everytime it appeared Hilecher was about to turn things around, Brumfield would spurt out again.

In game two Hilecher built a 12-7 lead. Brum reversed the margin, 14-12. Several innings went past with little scoring. Then, Charlie found an ace. It was the spark he needed, and he soared ahead to win.

Both semifinals were packed with excitement. In the top bracket it was a familiar battle—Brumfield and Keeley meeting for the n-th time. Steve Keeley probably plays Brumfield tougher than anyone else. He came close in the first game, leading most of the way, only to go down 21-18. In the second game he took a decisive victory over Brum, 21-9. In the third game

Keeley plays Brumfield tougher than anyone else

Brumfield was back in control, and allowed Keeley but five points.

The bottom bracket matched two products of the St. Louis JCCA. Hilecher and Hogan. Jerry Hilecher had been the star for quite some time, but lately Marty Hogan had been getting the headlines. This match was definitely not a quiet uneventful, unemotional, Sunday afternon tea party. It was more like the Boston tea-party.

The three game match brought displays of exceptional shooting and shouting (not always in that order). When it was over Marty was still the "new boy on the block." The match belonged to Hilecher: 21-14, 20-21, 21-18.

The quarterfinals provided what might be called three upsets and one almost. Brumfield squeezed past Richie Wagner, San Diego, 21-19, 11-21, 21-14. Wagner showed his game is there with his win over Craig McCoy in the 16's, and pushed Brumfield hard. Wagner's speed and quickness on the court was unbelievable.

In a rematch of the Memphis quarterfinals, Steve Keeley reversed the outcome, defeating Davey Bledsoe, 5-21, 21-17, 21-17. Bledsoe was unbeatable in the first game, rolling everything out. Keeley kept plugging along and eventually worked himself back into contention. In the third game, it appeared Bledsoe got impatient, and it cost him too many points.

The other two quarterfinals were not nearly so close. Hilecher shot the eyes out of the ball to defeat Steve Serot, 21-16, 21-16, stunning many viewers who though it would be routine the other way. Hogan did likewise to Steve Strandemo, 21-8, 21-14, never allowing Strandemo much control in either game, and none over the match. Hogan shot, shot, shot, either winning or losing the rally because of it. Fortunately for him, he won more than he lost, in the process.

Notable victories in the earlier rounds include Hilecher's win over Bill Schmidtke, and Bledsoe's sudden awakening in the third game against Dr. Bud Muehleisen. Bledsoe was behind, 6-16. Abruptly he rattled off 15 straight points. Other early round victories include Randy Stafford knocking off Jim Austin, and Tom McKie upsetting Bill Dunn.

Women's Open

The women's open was easily captured by Lyn McKie, Memphis. Except for a brief mental lapse in her semifinal match she swept through her games with little trouble. A hard hitting lefty, she defeated Marcilene Greer, Wichita, in the finals. Third place was captured by Janice Segall over Libby Bernhard, both from Austin.

A 64-man draw in the novice!

Eric Campbell, Dallas, fought his way to victory in the men's open over Randy Stafford. It was a run and gun type of match with Eric still standing at the end. Third place belonged to Mike Carr, Houston, over Ed Barziza, Austin.

One of the strongest events at the tournament was the seniors. Old master Dr. Bud Muehleisen tamed them all, beating Jim Austin, Houston, in the finals by 21-17, 21-9. Earlier Austin had been pushed hard by Jerry "the Judge" Winsberg, New Orleans, in a semifinal match that went 13-21, 21-13, 21-19, while Dr. Bud was toying with Richard Walker, Dallas, 21-5, 21-10. Winsberg captured third place.

Dewey Strickland, Houston, kept Jack Hood, San Antonio, out of the center court position and easily won the master's title, 21-4, 21-10. When Strickland is in the center court, it is hard to know what is going on anywhere in the court. Simon Wiederman, Houston, defeated Bill Reese, Dallas, 21-14, 21-12.

An up and coming left hander from Houston entered both the B division and junior division, and swept the title in both. Mark Malowitz, with a powerful backhand (all lefties have strong backhands) defeated fellow Houstonion, Jeff Kwartler, to capture the juniors, and—long after everyone else had gone home—triumphed over Carlos Nieves, Dallas, to win the B division. Another young player from Houston was involved in both third place matches, winning the

juniors by default over Mark Sandler, Chicago, and losing the B's to Ron Meek, Austin.

The novice division strained the score-keepers. A 64-man draw demands a lot of writing. To climb to the top of a 64-man bracket takes a lot of power, and indicates a lot of talent. Among the promising young players in the huge novice class, Mark Norenberg, Houston, put down Lonnie Parsons, San Antonio, in the finals. Third was Angel Diaz, San Antonio, followed by Don Jensen, Dallas.

In the women's novice, Neysa Buckley, College Station, Texas, took top honors over Faith Ragow, Dallas, 21-7, 21-16. Kathy Kelly defeated Connie Karcher for third.

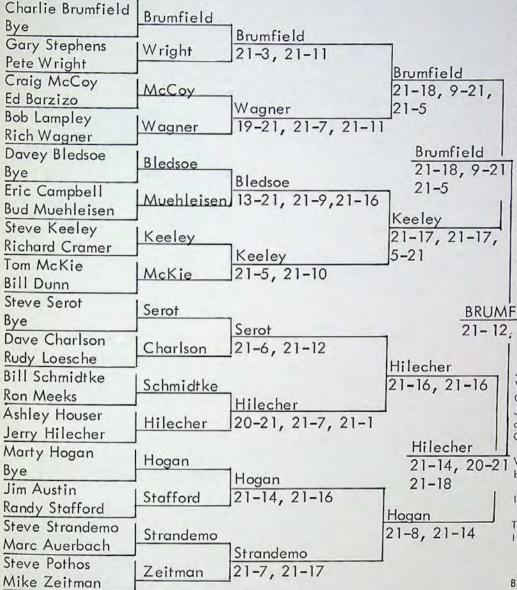

Eye injuries hit one in 20

The JCCA in St. Louis, Mo., has developed a new policy concerning the

wearing of eye guards while participating in court sports. Beginning April 1, all JCCA members, guests, visitors who use the courts for the purpose of playing handball, racquetball or squash will be required to wear either shatterproof glasses or some form of acceptable eye guards while playing.

This bold, forward policy to help enforce an important safety function is reminiscent of the original struggle to have in the rules the use of the wrist strap to be worn at all times by the racquetball players.

A record of injuries to the eyes and the area about the face near the eyes has indicated there is an urgent need for this policy. The statistical calculation during the year 1975 indicated that approximately five per cent of all the people who play handball, racquetball or squash sustained some form of eye injury. And five per cent of those injuries which did occur were serious enough to have some permanent effect, even though slight, such as scarring of the cornea or resulting in other visual problems.

MANY OF THESE cases required hospital rest and individuals suffered great pain and loss of work for from one to six weeks; in a few cases major eye surgery was necessary.

The ICCA in St. Louis has adopted a policy which accept glasses as protection as well as a variety of eye guards. The action in St. Louis may well portend the necessary action for court sport lovers all over the country in order to hold down the serious outgrowth of eye injuries. The ICCA has hosted several national tournaments and none has been completed without eye injury. It is not panic time; it is time to intelligently consider ways and means of protecting individuals who are involved in court sports. All of us love our game and we would like to share these joys with as many people as possible.

In order to keep court sports viable, the protection of eyes becomes a necessity. If one cuts or bruises a normal muscle anywhere else in the body, it will heal and ultimately function as well as it did originally. The eye is different. A cut or bruise or scar in the eye forever deters one's ability to see. This most precious gift must be protected.

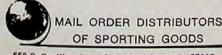

Tom Whipple Gaithersburg, Md. Davey Bledsoe is the eldest of the youngsters who have been making their presence felt at the top of the racquetball world. A 24-year-old resident of Memphis, Tennessee, Davey has shown promise ever since he switched from paddleball to racquetball, three years ago.

However, for two years he never seemed to win that one match that would push him over the hurdle and up toward the top.

A year ago in the Tanner Pro-Am at Memphis, he finally got that victory. Playing stunning racquetball, he defeated Charlie Brumfield, 21-14, 21-5. He was on his way.

In this interview the old-young pro, or the young older-pro, shares his feelings about the game, some of its top players, and what he sees for the sport's future.

Player Profile--Davey Bledsoe

McKie: Davey, I don't think many racquetball fans really know much about Davey Bledsoe, where he's from ... how he started playing?

Bledsoe: I grew up in Kingsport, Tennessee, which is in the northeast corner of the state . . . went to school at the University of Tennessee, Knoxville, and this is where I picked up the game. Actually I started with a paddleball group. Ray DePue and Andy Koser, who is one of the originators of paddleball, started me at the four-wall game. I played in two national tournaments and managed to get to rounds of eight both times.

After that I switched to racquetball. I think that is when everyone made the change, and paddleball fell to the wayside.

McKie: What kind of athletic background have you? I assume you played other sports?

Bledsoe: I was fairly active in high school, but in college the only sports I took part in were in the intramurals. All the intramurals, and was proficient in most. In high school I did well in track. I was a distance runner, and ran the mile when I was in the ninth or tenth grade in 4 minutes, 38 seconds.

McKie: How about other racquet sports—other than paddleball?

Bledso: No, although I took six weeks of tennis while in high school, but that is it.

McKie: You have really come along this last year, Davey. Before this year, you had played well, but it seems that suddenly something has changed. You are considered as one of the top players in the nation. Is there any particular reason that your game has improved so much in such a short time?

Bledsoe: It only appears sudden. Actually it has been a gradual progression. A combining of several things. Probably the most important one thing that has happened in the last year or so, was the entire summer spent practicing in what I call "static time" on the court. I would go into the court and practice one particular shot. Instead of practicing ten or fifteen different shots in thirty minutes, I would spend all of that time on one shot until I got proficient at it.

McKie: You spent all summer playing and practicing?

Bledsoe: Except for one day of lying in the sun, I spent almost the entire time in the courts, working, playing, practicing, and most of the time by myself. That's one reason I've looked like a ghost all fall, while everyone else was tanned.

At 17 he could run the mile in less than 5-minutes; seven years later and he's still running

Player profile

McKie: When a player reaches top-level competition he must have developed a sound, all-around game. But, there are certain parts of it that he feels are stronger than others. In analyzing your own game, what would you say are your strengths?

Bledsoe: My basic strength is my speed, of course. That is what everybody seems to think. However, this can be a disadvantage as well as an advantage. If you rely on speed you sometimes don't think and concentrate as much as you should because you know you can get there and so it can work against you as well as for you. I think Dr. Bill King was very instrumental in pointing this out to me. We used to play regularly when he was here in Memphis. I remem-

ber when I had beaten him. I had really concentrated, thought well, and consequently hadn't had to retrieve as many balls. But when I came off the court, I didn't feel I played all that good, and told him so. "On the contrary," King said, "You were playing the best I've seen you do in quite a while." In other words, I was judging my game more on agility than ability.

McKie: And like you mentioned, it takes a lot of concentration when you are actually in the game.

Bledsoe: Right. You have to concentrate. You have to think. You can't rely on your retrieving ability, your speed, or your strength to hit the ball hard.

McKie: You have been playing now for a couple of years in professional tournaments. What do you think the future of professional racquetball is?

Bledsoe: I think it is down the road as far as we want it to be. I think it can come into its own any time we get down to business as far as really concentrating on promoting it—not only as a business, but for the sport itself. The pros and the promoters need to give more of ourselves, instead of concentrating on the profit end of it, in order to expose the sport to the public. I think too many of us are getting involved in the profit end of the business. We want to make big money and make it fast. We're not looking at what is best for the sport itself.

MsKie: You pretty much answered my next question—what else does professional racquetball need?

Bledsoe: It needs better facilities. It needs some people working hard for it. I think it needs a cooperative effort. I feel many people are going the wrong route. Going back to what I said earlier, they are too much concerned with their profit and their money.

McKie: By everybody, you are talking about promoters, players, industries, and clubs?

Bledsoe: Yes. I don't think we have a single body. We have communications within the IRA, but I don't think efforts of all groups concerned are being channeled toward one common goal. We need to establish a common purpose in order to accomplish anything.

McKie: Everybody has trouble playing Charlie Brumfield, and no racquetball interview would be complete without discussing the top player in the game. What do you think makes Brumfield so tough?

Bledsoe: Charlie chews up young players—and I include myself here—because so many of us have one basic strength, and one basic game. Charlie, on the other hand, has several. I don't really know how many. He might not even know.

He is tough because of this. Of course, he is a great athlete. But along with physical ability, he is a thinker. When one game isn't working, Charlie can turn on another. If you think back on the players that he has met in the finals of recent tournaments, it is as though one top young player will emerge to challenge Brumfield . . . be defeated . . . and another will emerge in time for the next tournament . . . but never the same one.

McKie: In addition to Brumfield, who gives you the most trouble?

Bledsoe: I think it is the hard hitters, and the people who gear toward the same kind of game I play. Say Serot or Hogan. If I play either of these two, it is going to be physical—very physical.

McKie: Whomever is the hottest will win?

Bledsoe: Right. And that is why you may either see a tough, close, three game match, or you might see one of them blow the other off the court.

McKie: What other interests have you besides racquetball—hobbies, career ambitious . . .

Bledsoe: As you know, I am interested in medicine. After obtaining my bachelor's degree in biology (McKie's note: Bledsoe graduated with honors in this field), I intended to go on to med school, but for the present, this has been set aside.

Right now I am so involved in the sport of racquetball, not just professional play, but the entire spectrum, that I have no other time-consuming interests. To me the game is a challenge. I want to see it promoted. I want to see it grow and become as recognized, say, as tennis.

McKie: Some of what we call our "stars" have personalities that become very evident in display on the courts. Do you feel this type of color is good for racquetball? Bad for the game? Needed?

Bledsoe: I know what you mean. Given the choice between vulgar excitement and sterile monotony, there is but

one answer. But, I think we can have excitement and color without licensing bad taste.

Professional players are on exhibit. In this way we are showmen, and it seems that fans get a kick out of seeing and hearing the off-handed, candid, lurid, exclamations that are a natural part of all-out effort. I do not think they are offended. In the heat of a tough battle, the raw, emotional side of a man will come through. I feel this is important to the sport.

At the same time I am saying this, I recall the tournament that I just returned from. I was very discouraged in the fact that many of the professionals are using what I feel is too much profanity.

Most of the time their comments are as funny and entertaining to me as to anyone else, but I also heard some of the remarks from the fans who had sat there listening to the cussing, and know many of them didn't like it at all. We can't afford for people to look on us as a bunch of barbarians.

McKie: In other words, showmanship is good for the sport, but it has to be something that is in good taste as well?

Bledsoe: You don't want to subject your wife, kids, boss, friends or other guests to a couple jokers yelling profanities back and forth. It is embarrassing. It isn't necessary. It is hard to control your emotions, because you do get all wound up. All your attention is within that court, and you forget there is anyone else in the world, let alone a crowd of people with ears as well as eyes. But, as professionals, concerned with a paying audience, we must remember. We must make an effort to remember.

McKie: Do you feel the tournament personnel need to do a better job laying down the law on this?

Bledsoe: I believe this is true. The IRA instituted a technical foul, but I have yet to see it called. I think excessive profanity is one instance where it should be used. Automatically.

McKie: Davey, the trend to some extent for the guy who wants to be number one has been, "If he didn't grow up in San Diego, he should migrate to San Diego." Do you feel this is necessary?

Bledsoe: The first thing to consider is why do the people go there? I think it is because some of the manufacturers are there for one, and two there is good competition. We need good competition. If you are in an area where there is little competition it means you have to work harder on your own. You're going to reach a level, especially professional, where you don't need competition as much as you need individual attention to your own game. Like I said earlier, "static time" on the court. Until you get that good you do need competition. It just depends on the individual. If you can analyze your own mistakes and work with yourself well. A lot of people say they don't like to go into the court and practice by themselves because it is boring. They would rather compete. You have to sacrifice a willingness to compete and maybe a willingness to beat Joe Blow who you play every day (because you don't want him going out telling people, well he beat Bledsoe today). You can't worry about that. You have to say to yourself, "All right, I am working on a particular part of my game and who wins in practice is not important."

McKie: This is something we probably should emphasize at all levels of play and not just the top player. You can get in a court and you can play to win and you may win but may not improve your game at all. You have to practice the things that you don't do well and when you are trying to win you only use the things that you do do well.

Bledsoe: Yes, that is exactly right. I think to find any improvement you need to concentrate on a particular part of your game or a particular type of game. When I first started at the University of Tennessee with Randy Stafford, we used to go in the court and play ceiling ball games. This helped our ceiling ball rallies considerably and you have to make up little gimmicks to entertain yourself or you will be bored. It takes a lot of discipline though, to rule out the competitive effort every time and practice.

McKie: When it's a back hand shot you hit a back hand shot instead of running around to your forehand?

Bledsoe: Yes, and this is what I teach when I am giving lessons. You can't improve something unless you use it, and I find that most beginners will run around to hit around that forehand every time. What they have to do is mentally convince themselves that they love to hit backhands and once they convince themselves of that they will start running around forehands to hit backhands. When they start doing that they have equalled it out.

McKie: You'll be in Chattanooga Memorial Day weekend?

Bledsoe: I'll be there. Will you . . . ?



This season started slowly for Davey Bledsoe, following a shoulder separation in the summer (playing softball), but lately he's been razor-sharp. In his last five pro-tournaments he has earned his way to the semifinals four times, and to the finals once. In a year when competition has been so strong that top players from last year are not always making it past the round of 16, Bledsoe's record is outstanding.



the 'Gar' the best player on the east coast

A mistake was made in asking Garfinkel for his selection of the best player on the east coast . . . when he was asked to write a story on his selection, he said that would appear immodest. So, with liberal quotes . . .

Charlie Garfinkel, also known as "the Gar," has accepted the nomination of being Buffalo's finest all-time racquetball player, and perhaps even the best player in the history of the east coast. Sources for the nomination have not been named, and, therefore, have not been polled. Later, some may wish to pole them.

Racquetball magazine readers have been known to wonder about the Gar's penchant for writing. He comes about it naturally, which it is one of the few things Gar takes seriously.

Garfinkel is a Reading Resource Teacher at School 80 in Buffalo, has his master's degree in School Administration, and about 20 hours graduate work on his doctorate. He is married to the former Leslie Kwasman, has two children, Bradley, age six, and Adina, age four-and-a-half.

Those who associate Gar's name with racquetball will be pleased to know he does something besides play and report the play of others—some of whom do nothing but play, and read what Gar reports.

Gar is a graduate of Buffalo State, where he was in the men's glee club (he says) and the Acapella choir. He was known then as a sort of "poor man's Henny Youngman." Buffalo still claims him, and in 1971 he received the Amateur Athlete of the Year Award from the Buffalo Athletic Club. Bob Lanier and Calvin Murphy had won it the year before.

Last year he received the Distinguished Alumni Award from Buffalo State. Racket and racquet sports have been an obsession with Garfinkel. He plays tennis, squash and racquetball—excelling at all three. In racquetball he has ranked 5th, 10th, 7th and 8th, nationally from 1971 through 1974.

In a national poll, he placed 11th on the list of all-time players (which was headed by Brumfield and Schmidtke, both of whom he has beaten at one time), and ranked 7th in the category of "Smartest Players" on the court.

Gar says he is prouder, however, of his fourth place ranking in the "Sportsmanship" category.

When asked about games that stand out in his memory, Gar said perhaps one of the games—not necessarily his greatest—was the one with Victor Niederhoffer, the three-time world squash champion. "It was a gruelling challenge-match, and as Niederhoffer showed at St. Louis later in the year, he is a player to take seriously."

Gar won the game, but then, as he points out, he "can beat anyone if I am playing well, hitting my sidewall shots, hitting my controlled shots, and am in condition. If I had started playing this game before I was 30, I have no doubts that I would rank myself (who else) in the top five of all time."

Charlie Garfinkel's humility just grows and grows.

In local competition, the Gar has won the City singles title the past nine years. In doubles, he and his partner, Chuck Wurzer, have won the City Doubles the past six years, and the New York State doubles the past five out of

six years. Nationally, they finished third in 1971.

At one time or another, the Gar has won almost every singles title offered on the East coast.

In tennis the Gar is a two time National Parks Doubles champion (with the Reverend Bob Hetherington) and has won the City singles four times. He has been co-winner in the city doubles competition ten different years.

In 1970 Gar played an exhibition tennis match with Wimbledon champion Arthur Ashe. Gar says, "Arthur played like Arthur, and I played like his brother, jack . . ."

In 1969 Gar won the City Squash championship, and is the only person to date to hold the city title in all three racquet sports the same year.

"Racquetball is my game," Gar says.
"It is a great game. I love to compete
and to stay in shape. By playing racquetball I can do both. There aren't
many sports that do that."
