Contributions are voluntary, making a contribution is neither a condition of employment nor membership in the Association, and members have the right to refuse to contribute without suffering any reprisal. Only Association members, staff and their immediate families who are U.S. citizens or lawful permanent residents may contribute.

Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation, and name of employer for each individual whose contributions aggregate in excess of \$200 in a calendar year.

Only U.S. citizens or lawful permanent residents may contribute to the NEA Fund.
