1. SCOPE OF SERVICES. Service Provider will provide the following services to Client:

2. SERVICE PRICE. Services provided by Karma Kloset shall be at the following rate:

- b. Shopping Assistance Rate: \$25 per hour
- c. Removal of donations or consignments: negotiable

3. PAYMENT. Payment is due based on the following terms: A \$50 deposit is required upon booking (Square or Venmo Invoice). Remaining to be paid immediately after services rendered-cash, check, charge, Venmo or ACH transfer. (Unless pre-pay option was selected)

4. RESCHEDULING & CANCELLATION. A \$50 fee will be applied to all appointments that are missed, cancelled, or rescheduled with less than 48-hours' notice of the appointment time.

5. CONFIDENTIALITY. Karma Kloset and Client acknowledge that due to the nature of the services provided, Karma Kloset may come into contact with confidential and personal information of Client. Karma Kloset employees shall not disclose any personal or confidential information of Client's and shall maintain the highest standards of confidentiality.

6. IMAGES. Client grants Karma Kloset permission to take photographs of Client's property while engaging in the agreed upon services. Client grants Karma Kloset the right to use and publish said photographs for marketing purposes, provided such use does not violate section 5 of this Agreement.

7. ITEMS FOR DISPOSAL, DONATION/TRASH HAULING FEES: As an additional service Karma Kloset may, at the Client's request, transport items for disposal to the appropriate locations. MUTUAL RELEASE OF LIABILITY
