FIRST AMENDMENT TO DECLARATION OF UNIT OWNERSHIP AND FIRST AMENDMENT TO PLAT FOR RIDGEVIEW CONDOMINIUM MULTNOMAH COUNTY, OREGON

THIS FIRST AMENDMENT TO DECLARATION OF UNIT OWNERSHIP FOR RIDGEVIEW CONDOMINIUM AND FIRST AMENDMENT TO PLAT MULTNOMAH COUNTY, OREGON is made this 6 day of AMURY 2008, by the "Ridgeview" Condominium Owners' Association ("Association").

RECITALS

- A. Association is a Condominium Association established pursuant to the Declaration of Unit Ownership For Ridgeview Condominium Multnomah County, Oregon dated September 15, 1978, and recorded September 15, 1978, in the records of Multnomah County, Oregon, at Book 1294 Page 2309 ("Declaration");
- B. Association desires to amend the Declaration for the limited purposes of (i) amending the plat to change the location of parking spaces assigned to Units 13, 21 and 22 designated on the Plat of Ridgeview Condominium recorded September 15, 1978, in the plat records of Multnomah County, Oregon, at Plat Book 1209 Page 82-91 ("Plat"); (ii) changing the designation of the original spaces assigned to Units 13, 21 and 22 from Limited Common Elements to General Elements; and (iii) removing the weight restriction on pets.
- C. Association intends to file for recording in the official records of Multnomah County, Oregon the Plat amendment entitled "Ridgeview Condominium Plat Amendment"

- D. Not less than 75% of all Unit owners voted in favor of amending the Declaration as described herein.
- E. Unless otherwise defined herein, the definitions used in this First Amendment shall have the same meaning as set forth in the Declaration.

NOW THEREFORE, the Association hereby amends the Declaration as follows:

DECLARATION

The Declaration of Unit Ownership For Ridgeview Condominium Multnomah County, Oregon is amended as follows:

1. **Plat Amendment**. The Plat is hereby amended to change the location of the parking spaces assigned to Units 13, 21 and 22 from their existing location on the Plat to such locations as depicted on the attached and incorporated Plat Amendment ("New Parking Location Spaces"). The designation of the New Parking Location Spaces are changed from General Common Elements, as depicted on the Plat, to Limited Common Elements as shown on the Plat Amendment. In addition, the designation for the parking spaces originally assigned to Units 13, 21 and 22 on the Plat ("Original Parking Spaces"), which were originally designated as General Common Elements on the Plat, is changed from General Common Elements to Limited Common Elements, as shown on the Plat Amendment. The table below illustrates the designation changes for both the New Parking Location Spaces and the Original Parking Spaces.

2. **Pet Weight Restriction.** The first sentence of Paragraph B(5) of Article VII is deleted in its entirety and replaced with the following language:

Unit owners shall be permitted to keep or permit the keeping of a pet which weighs more than 10 pounds.

3. Except as specifically amended hereby, the Declaration continues unchanged and in full force and effect.
