	2	<p>Driver Education Course Completion Certificate – REQUIRED FOR AGES 18-24, optional for ages 25 & above</p> <p>* "ADE-1317" form from 6-hour course used to get permit. <i>The title of the form should be: "Texas Adult Driver Education Certificate" – "DRIVER EDUCATION COURSE EXCLUSIVELY FOR ADULTS"</i></p>
	3	<p>ORIGINAL - "Impact Texas Adult Drivers" (ITAD) video certificate</p> <p>* Must be dated within 90 days of the testing date (expiration date should be displayed on certificate)</p> <p>* Website link to access the video. https://impacttexasdrivers.dps.texas.gov/ITAD/</p>
	4	<p>IF USING OWN VEHICLE FOR DRIVING TEST – Texas Liability Insurance Card for car driven in the Road Test (SEE ADDITIONAL REQUIREMENTS IN THE SECTION BELOW)</p> <p>* Insurance card must show current effective dates, cannot be expired</p> <p>* NO ELECTRONIC COPY ACCEPTED (MUST BE PRINTED COPY)</p> <p>* The VIN # on the insurance card must match the VIN # on the registration sticker AND the car itself</p> <p>* Car must be listed on the liability insurance card and the student cannot be listed as an excluded driver</p>
Check box when verified		<p>IF USING OWN VEHICLE FOR DRIVING TEST - CAR INSPECTION - Texas State Law requires these items to be inspected on the car before the test can be administered.</p>
	1	<p>Current Non-Expired Registration Sticker on windshield</p> <p>* A recently purchased car with no registration sticker on windshield MUST have 2 metal license plates- affixed on the outside on the bumper – front & back AND a Texas Buyers Tag Receipt – Buyers Copy</p>
	2	<p>Proper License Plates</p> <p>* 2 Metal Plates - affixed on outside <u>on the bumper</u> - FRONT and BACK</p>
	3	<p>These items must be in working order</p> <p>* Working Horn</p> <p>* Working Brake Lights and Turn Signals</p> <p>* Seat Belts must be present and worn during test</p> <p>* At least one mirror must be intact (rearview or outside)</p>
	4	<p>Working Headlights, Tail Lights and Windshield Wipers</p> <p>* If current conditions require them at the time of the test</p>
	5	Front Driver & Passenger Doors must be present and open from the inside & outside
THESE FORMS ARE NOT REQUIRED FOR THE TEST AT GLDA - BUT THEY WILL BE REQUIRED AT THE DPS TO GET YOUR LICENSE		
1		DL-14A - Application for Driver's License – this can be picked up at the DPS office when you arrive
