	3	<p>ORIGINAL - "Impact Texas Young Driver" (ITYD) video certificate</p> <ul style="list-style-type: none"> • Must be dated within 90 days of the testing date (expiration date on certificate) • Click here to link to access the video. IMPACT TEXAS YOUNG DRIVERS VIDEO
	4	<p>Texas Liability Insurance Card for car driven in the Road Test</p> <ul style="list-style-type: none"> • Insurance card must show current effective dates, cannot be expired • NO ELECTRONIC COPY ACCEPTED (MUST BE PRINTED COPY) • The VIN # on the insurance card must match the VIN # on the registration sticker AND the car itself • Car must be listed on the liability insurance card and the student cannot be listed as an excluded driver

	1	<p>Current Non-Expired Registration Sticker on windshield</p> <ul style="list-style-type: none"> • Car w/ Non-expired Texas Buyer's (PAPER) License Plate on back & no registration sticker is ACCEPTABLE
	2	<p>These items must be in working order</p> <ul style="list-style-type: none"> • Working Horn • Working Brake Lights and Turn Signals • Seat Belts must be present and worn during test • At least one mirror must be intact (rearview or outside)
	3	<p>Working Headlights, Tail Lights and Windshield Wipers</p> <ul style="list-style-type: none"> • If current conditions require them at the time of the test
	4	<p>Front Driver & Passenger Doors must be present and open from the inside & outside</p>
	5	<p>Proper License Plates</p> <ul style="list-style-type: none"> • 2 Metal Plates - affixed to outside on the bumper - FRONT and BACK; OR • Car w/ Non-expired Texas Buyer's (PAPER) License Plate on back & no registration sticker is ACCEPTABLE
<p>THIS FORM ARE NOT REQUIRED FOR THE TEST AT GLDA - BUT THEY WILL BE REQUIRED AT THE DPS TO GET YOUR LICENSE</p>		
1	<p>DL-14A - Application for Driver's License – this can be picked up at the DPS office when you arrive</p>
